What is (a) the full amount not spent on housing per municipality and (b) the number of housing units not delivered (i) per municipality and (ii) per year since 2009?

How many (a) informal settlements were upgraded per municipality in the province and (b) per year since 2009?

With reference to the 16% growth recorded in the tourism sector of the Western Cape,

- (4) of the R112 million investment by the Department, the Jobs Fund and SETA, how much of the funding went to learner-development costs and how much went to all other support and related costs to deliver the Programme;
- (5) what were the failures of this Programme?
