2. The Speaker took the Chair and read the prayer.

6. [15:30] Mr H P Geyer moved without notice: That the House acknowledges the mothers of our country and pays tribute to them as we did on Mother's Day last Sunday, on 12 May.

Let us not forget that mothers plant the seeds of love, which bloom forever!

7. Mr E J von Brandis moved without notice: That the House congratulates –
 - (1) Wesgro on winning a gold medal for its display stand, made of recycled material, at the recent Tourism Indaba in Durban; and
 - (2) Ms Nisreen Bulbulia on being the Western Cape finalist in the Emerging Tourism Entrepreneur of the Year Awards (ETEYA).

8. Ms A Rossouw moved without notice: That the House recognises “Fair Trade Tourism”, a tourism organisation that advocates responsible tourism, who, with the cooperation of South African hotels, will sign a code of conduct with a view to helping to protect children against sex tourism.

9. Ms J Witbooi moved without notice: That the House extends its condolences to the family and friends of 20-year old Annamarie Beukes of Swellendam, who was raped and subsequently died in hospital as a result of complications relating to pneumonia.

10. Mr M G E Wiley moved without notice: That the House –

- (1) congratulates two Cape Town surfers, Tanika Hoffman and Michael February, who were both members of Team South Africa that won the most prestigious team title in world surfing in Panama recently;
- (2) notes with pride that Team South Africa was placed first at the Reef ISA (International Surfing Association) World Surfing Games and that it is the first time in 50 years that a South African blue ribbon team has won a championship outside the country;
- (3) also congratulates Shaun Joubert from Mossel Bay, the captain of Team South Africa, on his excellent victory at the same event in this Central American country where he clinched the ISA Men’s World Champion title; and
- (4) notes that these victories make it possible for the South African team to compete in China later in 2013.

11. Mr E J von Brandis moved without notice: That the House –

- (1) conveys its sympathy to the family and friends of the cyclist, Dr Koos Roux, who was killed in a hit-and-run accident on Sunday morning, 12 May 2013, across the road from the Soneike Shopping Centre on the Bottelary Road near Kuilsrivier; and
- (2) notes that Dr Roux has been a curator at the Compton Herbarium of Kirstenbosch since 2003.

12. Mr M Skwatsha moved without notice: That the House notes that the national Minister of Public Enterprises, Mr Malusi Gigaba, is handing over an IT laboratory of 50 computers to Lwazi Primary School in Gugulethu today, on 16 May 2013.
