**NOTICES OF MOTION**

1. Ms N D Nkondlo moved: That the House debates farm evictions under the DA-run government in the Western Cape.
2. Ms B A Schäfer moved: That the House debates the National Minimum Wage Bill and its impact on the Western Cape.
3. Ms T M Dijana moved: That the House debates the negative effect of gentrification under the DA in the Western Cape.
4. Ms N D Nkondlo moved: That the House notes that on Tuesday 29 May 2018 the national Parliament, by an overwhelming majority, passed the National Minimum Wage Bill despite opposition by the DA, and that millions of workers will now be earning at least R3 500 a month; notes further that this Bill is meant to reduce inequality, stimulate economic growth and alleviate poverty in the country; and notes that once the Bill becomes law all low-income workers can start earning more dignified salaries.

5. Ms C F Beerwinkel moved: That the House notes and condemns the nonsensical and clownish accusations by J P Smith and the hon Wiley to make people's grievances about poor service delivery by the DA part of a plot to make the Western Cape ungovernable; notes further that the accusations are not only unfounded but also border on stupidity as everyone knows that the communities are up in arms against the DA, which continues to give the poor substandard services; appeals for calm in the Western Cape amidst all these tensions; appeals to all to desist from committing illegal acts; and calls on the provincial government to prioritise service delivery to poor communities in the province.
6. Ms N D Nkondlo moved: That the House notes with concern the reports from Women on Farms that the Drakenstein Municipality is preparing for large-scale farm evictions as farmers have approached the courts for eviction orders that will affect about 20 000 farmworkers; notes that, as has been reported, that new legislation by the national government that is to benefit farmworkers and protect their rights has prompted farmers to start turning their farms into holiday destinations and evicting the workers, meaning that they would have to move to informal settlements; calls for the intervention of the national government; and calls for an investigation into farm evictions in the Western Cape.
7. Mr N E Hinana moved: That the House congratulates the DA on winning Saldanha Bay and Oudtshoorn in the by-elections; and further confirms that the DA is building the quality of the citizenry by providing quality services.
8. Mr Q R Dyantyi moved: That the House notes that the ANC is growing while the DA is still in a tailspin, heading downward, as was seen in yesterday's by-elections; and further notes that the ANC has gained 15% support in Saldanha Bay and 17% in Oudtshoorn, while the DA lost 17% support in Saldanha Bay and 9% in Oudtshoorn.
9. Mr M Mnqasela moved: That the House notes and congratulates every DA activist, professional staff member and all public representatives for earning well-deserved victories in both the Oudtshoorn and Saldanha Bay by-elections; and further extends the House's gratitude to both communities for their continued trust in the DA. 10. Mr M Mnqasela moved: That the House notes that the Overstrand Municipality will implement level 2 water restrictions that ban the use of hosepipes to wash cars and boats from 1 June 2018; and further notes that level 1 water restriction tariffs will apply accordingly.
11. Mr M G E Wiley moved: That the House requests the national Minister of Public Works to inform it why only R400 million is to be spent on small-boat harbours when the original amount spent two years ago was R1 billion.
