ACT

To appropriate additional adjusted amounts of money from the Provincial Revenue Fund in respect of funds that have become available for the requirements of the Province of the Western Cape in respect of the 2015/16 financial year; and to provide for matters incidental thereto.

WHEREAS the National Treasury has allocated additional funds to the Province in respect of the national conditional grant: Education Infrastructure Grant;

AND WHEREAS section 31 of the Public Finance Management Act, 1999 (Act 1 of 1999), provides that the Provincial Minister responsible for finance may table an adjustments budget in the Provincial Parliament in respect of funds that have become available;

AND WHEREAS section 26 of the Public Finance Management Act, 1999, provides that the Provincial Parliament must appropriate money for each financial year for the requirements of the Province,

BE IT THEREFORE ENACTED by the Provincial Parliament of the Western Cape, as follows:—

Interpretation

1. In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Western Cape Appropriation Act, 2015 (Act 2 of 2015), has the meaning assigned to it in that Act. 5

Appropriation of adjusted amounts of money for requirements of Province

2. (1) Adjusted appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2015/16 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in the Schedule. 10

(2) The spending of the appropriations contemplated in subsection (1) is subject to the Public Finance Management Act.

Amounts listed as specifically and exclusively appropriated

3. The amounts in respect of the national conditional grants listed in the Schedule as specifically and exclusively appropriated may be used only for the purpose stipulated in the Division of Revenue Act and in accordance with the framework published in terms of that Act. 15

Short title

4. This Act is called the Western Cape Additional Adjustments Appropriation Act (2015/16 Financial Year), 2016. 20

Bewilliging van aangesuiwerde bedrae geld vir behoeftes van Provinsie

2. (1) Aangesuiwerde bewilligings deur die Provinsiale Parlement van geld uit die Provinsiale Inkomstefonds vir die behoeftes van die Provinsie in die 2015/16-boekjaar, vir begrotingsposte en hoofindelings binne 'n begrotingspos, en vir die spesifieke doeleindes gelys, word in die Bylae uiteengesit. 10

(2) Die besteding van die bewilligings beoog in subartikel (1) is onderhewig aan die Wet op Openbare Finansiële Bestuur.
