(a) How many cases of child rape have been struck off the roll in courts in the (i) 2014/15, (ii) 2015/16 and (iii) 2016/17 financial years and (b) what steps have his Department taken to ensure that these cases are appropriately investigated so that victims are protected and perpetrators convicted?

Whether he and his Department are investigating or will be investigating the alleged transgression of the Rules of Order by the Mossel Bay Municipality on 31 May 2017 when the Council approved the budget while disregarding their own rules; if not, why not, if so, when will the investigation be completed?

Whether his Department conducted any in-depth analysis of townships and informal settlement areas to determine whether the people who stay there are enjoying their full rights as set out in section 24(a) and (b) of the Constitution of the Republic of South Africa, 1996; if not, why not; if so, what are the relevant details?

- (1) Whether there are provincial norms for households according to the public health care (PHC) facility; if not, why not; if so, what are the relevant details;
- (2) whether there are any plans to upgrade the PHC facility in Pacaltsdorp; if not, why not; if so, what are the relevant details?
