1. Opening and welcome

The Chairperson welcomed all in attendance.

The Chairperson advised the Committee that the Ministry of Agriculture, Land Reform and Rural Development (the Ministry) would not be in attendance. She provided the Committee with a detailed summary of the Committee's interaction with the Ministry as follows:

A meeting request was sent to the Ministry of Agriculture, Land Reform and Rural Development on 4 May 2021 to discuss the District Six matter. The Ministry responded by indicating that they would not be able to meet with the Committee due to prior engagements. Following the non-attendance of the Ministry, the Committee resolved to re-invite the Ministry or a representative selected by the Minister to brief the Committee on a date which would be more suitable to them.

An invitation was sent to the Ministry requesting that the Minister or a representative attend the Committee meeting of 18 June 2021. The Ministry indicated that they would not be able to brief the Committee and that they would advise the Committee on their availability should an opportunity arise. Further correspondence was sent to the Ministry to enquire about their availability and to meet with the Committee, but no further response to the Committee's request was received.

The Department briefed the Committee on its Fourth Quarterly Report for the period January 2021 – March 2021. The Department provided the Committee with a synopsis of the target indicators achieved and not achieved per programme and on the challenges experienced due to COVID-19.

- 12.3 The Committee RESOLVED to re-invite the Department of Agriculture, Land Reform and Rural Development to attend a Committee meeting and to brief the Committee on the same agenda items as was previously sent to the Ministry.
- 12.3 The Committee RESOLVED to conduct an oversight visit week to the Garden Route, with the Standing Committee on Local Government to observe the status of the Municipal Housing Demand Database and the integration of mixed housing typologies into housing projects.
