- 3.1.3 The Department provides the Committee with a written explanation of what is deemed to be legal for councillors in terms of those functions they are responsible for within a municipality and what functions would be deemed beyond their legal power or authority.
- 3.2 The Committee expressed its concern at the number of critical positions that are vacant at Kannaland Municipality specifically the Technical Director and RESOLVED to engage the Department of Local Government on the vacancies and suspension of senior officials at municipalities.
