1. Opening and welcome

2. Consideration and adoption of the Draft Final Mandate Stage Report on the National Environmental Management Laws Amendment Bill [B 14F–2017] (s76)

The Department of Environmental Affairs and Development Planning and the WCPP Legal Adviser highlighted matters in the F-version of the Bill that were of concern.

The Committee deliberated after which the Chairperson submitted the Draft Final Mandate Report which was considered and adopted.

3. Reviewing of the Western Cape Biodiversity Bill [B 2A–2021] and [B 2B–2021]

The Chairperson informed the Committee that the A-and B-Bill were circulated and requested the Committee to note that the amendments as agreed to were incorporated into the Bill and that translation has been completed.

The Chairperson expressed his appreciation to the members and officials for their contribution to the success of the meeting.
