The Committee deliberated after which it agreed to support the Vote. The African National Congress did not support the Vote.

3. Consideration and adoption of Draft Committee Report on Vote 11: Agriculture in the Schedule to the Western Cape Adjustments Appropriation Bill [B 6–2021]

Upon conclusion of its deliberations the Chairperson submitted a Draft Report. The African National Congress requested that their minority view be included in the Report after which the Report was considered and adopted.

4. Resolutions/Actions

The Committee RESOLVED that it would express its support for the agricultural sector being declared an essential service during the COVID-19 pandemic and that it would call on the National Government to continue this classification, despite the current new wave of COVID-19 infections.

The Chairperson expressed his appreciation to the members, the Minister of Agriculture, the Head of Department, the Departmental officials as well as the officials from the Western Cape Provincial Parliament for their contribution to the success of the meeting and for the support afforded the Committee during the year.
