Aspects relating to the possible closing down of the factory such as the financial and production losses as well as the employment and social impacts were highlighted. The financial support required, interventions by the Western Cape Government and the support provided by the Department were also discussed.

Numerous issues were raised, including what will happen in the event that financial support is not secured as well as the impact on the long term prospects of the factory as farmers in the surrounding Robertson and Ashton areas switch to citrus production.

The Committee expressed its appreciation to the Department for the briefings and, in particular, the work that has been done to ensure the future of the Ashton Canning Company.
