1. Opening and welcome

The Chairperson opened the meeting and welcomed the Members of the Committee, Minister Mitchell, Departmental officials and representatives of Intercape, SANTACO, GABS, SAPS, PRASA and the National Department of Transport.

2. Briefings on the recent attacks on the public bus service

The Committee proceeded with briefings by representatives of Intercape, the provincial Department for Transport and Public Works, GABS, the national Department of Transport, SANTACO, PRASA and SAPS.

The Committee deliberated.

3. Resolutions/Actions

3.1 The Committee **RECOMMEND** that:

- 3.1.1 SANTACO hand over any information or evidence to the South Africa Police Service that could assist them in their investigations into the attacks on the public bus service;
- 3.1.2 SANTACO considers writing to theirs members/associations urging them to stop intimidating public bus operators;
- 3.1.3 The South African Police Services offer bigger rewards and allocate more resources to address the attacks on public bus services; and
- 3.1.4 It was of the opinion that there should be regular engagements between the Transport Industry and SAPS on matters such as intimidation, and extortion.

3.2 The Committee **RESOLVED** that:

- 3.2.1 The Committee meet with the Eastern Cape's Standing Committee on Transport to discuss the attacks and intimidation of the public bus service;
- 3.2.2 It would write to the National Assembly Portfolio Committee on Transport to request it to request a debate on the extortion, violence and intimidation in the transport industry;
- 3.2.3 It would request Minister Mitchell to:
 - 3.2.3.1 Place the extortion, violence and intimidation in the transport industry on the agenda of the next MINMEC for Mobility meeting and to provide feedback to the Committee and all stakeholders on the outcome of that meeting; and
 - 3.2.3.2 Consider shutting down the applicable taxi routes within the Western Cape where regular problems were experienced;
- 3.2.4 It would request Minister Allen to place the extortion, violence and intimidation in the transport industry as soon as possible on the agenda of the next MINMEC for Safety and Security meeting and to provide feedback to the Committee and all stakeholders on the outcome of that meeting; and
- 3.2.5 It would request Premier Winde to place the extortion, violence and intimidation in the transport industry as soon as possible on the agenda of the Presidents Council and to provide feedback to the Committee and all stakeholders on the outcome of that meeting.

4. Consideration of Draft Committee Minutes
