The Committee proceeded to a page by page discussion on Vote 1, in the Adjusted Estimates of Provincial Expenditure Book.

The Committee deliberated and engaged the Department on Vote 1.

The Chairperson thanked the Department for its preparation and responses to the questions raised by the Committee members.

3. Consideration and adoption of the draft Committee Report on Vote 1: Premier in the Schedule to the Western Cape Second Adjustments Appropriation Bill [B 3-2022]

In terms of Standing Rule 90, the African National Congress expressed its minority view to not support the Vote for the following reasons:

- 3.1 The Department has allocated too much funds on venues for Provincial Top Management and Cabinet outreaches;
- 3.2 Not enough detail on various expenditure; and
- 3.3 The Department prioritised Microsoft Azure cloud computing above the infrastructure needs of Khayelitsha Hospital.
