#### 1. Welcome and attendance

The Chairperson opened the meeting and allowed brief introductions by the Minister and the Head of Department.

## 2. Consideration of Vote 12: Provincial Economic Development and Tourism in the Schedule to the Western Cape Adjustments Appropriation Bill [B 3–2022]

The Minister and Head of Department gave introductory remarks on budgetary adjustments to Vote 12: Economic Development and Tourism. The Committee proceeded to a discussion on Vote 12, in the Adjusted Estimates of Provincial Expenditure book.

The Committee deliberated and engaged the Department on Vote 12. The Chairperson thanked the Department's officials and the Minister for the preparation and responses to the questions raised by the Committee Members and for their hard work and dedication during the year.

The Chairperson noted that there were no questions or comments raised by members of the public.

The Committee proceeded to express their views on the Vote.

# 3. Consideration and adoption of the draft Committee Report on Vote 12: Economic Development and Tourism in the Schedule to the Western Cape Second Adjustments Appropriation Bill [B 3–2022]

The Chairperson submitted the draft Committee Report, which was considered and adopted. In accordance with Standing Rule 90, the African National Congress expressed its Minority View to not support the Vote because of the budget cuts to Cost of Employment and Goods and Services, which the party believes will have adverse effects on service delivery. Al Jamaah also expressed its Minority View to not support the Vote as the party felt that the budget fuelled the inequality in the Western Cape.
