**1. Welcome**

The Chairperson welcomed everyone present and allowed for brief introductions.

**2. Deliberations on Vote 7: Social Development in the Schedule to the Western Cape Adjustments Appropriation Bill, [B3-2022]**

Before proceeding to the consideration of Vote 7: Social Development in the Schedule to the Western Cape Adjustments Appropriation Bill, [B3-2022], the Minister and Mr. C Jordan, the Acting Head of the Department in the absence of Dr Macdonald, the Head of the Department, were allowed to make opening remarks.

Mr. Jordan, Acting HOD for the Department of Social Development reported that the Adjustments appropriation for the Department was R2 365 076 000 an increase of R79 741 000 from the main appropriation of R2 285 335 000 in the 2022/23 financial year.

The Department reported a provincial rollover of R10 045 000, Programme 2: Social Welfare Services received an adjustment allocation of R7 839 000, roll-over amount of R6 290 000 from the 2021/22 financial year for modification, customisation, and operations of vehicles for the transport of intellectually disabled children. In addition, it was reported that R1 549 000 roll-over from the 2021/22 financial year was allocated to the Sanitary Dignity Project to provide girl learners with access to sanitary dignity products and appropriate programmes at identified schools across the province was earmarked.

Furthermore, the Department reported that Programme 4: Restorative Services was allocated an adjustment allocation of R2 206 000 from 2021/22 for funding Substance Abuse non-profit institutions (NPI's) (custodian department responsible for the implementation of the Prevention of and Treatment for Substance Abuse Act, Act 70 of 2008, Section17(1)).

The Committee proceeded to deliberate on Vote 7: Social Development in the Scheduled to the Western Cape Adjustments Appropriation Bill, [B3-2023].

The Committee deliberated.

### **3. Public input**

The Committee proceeded to the public hearing on Vote 7: Social Development in the Schedule to the Western Cape Adjustments Appropriation Bill, [B3-2023]. No members of the public were in attendance and no input was received.

### **4. Consideration and adoption of the Committee Report**

The Chairperson tabled the Draft Committee Report on Vote 7: Social Development in the Schedule to the Western Cape Adjustments Appropriation Bill, [B3-2023], which was considered and adopted.

The Committee resolved to support the Vote referred to it.

In terms of Standing Rule 90, the African National Congress and Economic Freedom Fighters expressed their minority view to not support the Vote.

### **5. Conclusion**

The Chairperson thanked the Members of the Committee, the Minister, the Head of Department and all the officials of the Department for their preparation and responses to the questions posed by the Committee.
