6.1.3 The list of the post including the Special Advisors that are in the office of the Premier; a breakdown of the salaries to be included;

6.1.4 Copies of the court ruling documents that were presented to the Provincial Cabinet and Heads of Department bi-annually;

6.1.5 A copy of the updated table indicating the representivity and vacancies of senior management; and

6.1.6 A list of the 16 areas that were reported as the high-crime areas by the Provincial Data Office.

6.2 The Committee RESOLVED to invite the Department of the Premier to brief and update the Committee on the status of Cyber Security and Broadband.
