#### 1. Welcome and attendance

The Chairperson opened the meeting and welcomed all the members and stakeholders present. Apologies were received from Premier A Winde and Minister D Maynier who could not attend the meeting due to attending the Cabinet meeting.

2. Briefing by the Department of the Premier, as well as Provincial Treasury, on the status of the implementation of the Integrated Financial Management System (IFMS) piloting in the Western Cape.

Mr Mazomba and Mr Arendse briefed the Committee on the subject matter. The Committee members engaged the officials on their presentation.

#### 3. Briefing by Provincial Treasury on the following:

- 3.1.Red Ants Security Relocation and Eviction Services (Pty) Ltd matter, including the general sourcing and implementation of transversal departmental contracts which are utilised by the departments and entities of the Western Cape Government.
- 3.2.Instruction notes that were issued by National Treasury to government departments and entities of the Western Cape Government for the 2019/20 and 2020/21 financial years.

- 7.1. A Report from the departments of Human Settlements, Transport and Public Works; including the AGSA on the supply chain management process that was followed in allowing the usage of the services of the Red Ants Relocation and Eviction Services (Pty) Ltd between the two departments.
- 7.2. That the Provincial Treasury issues prescripts to the departments and entities of the Western Cape Government to guide on shared contractual agreements between departments.
