2. Briefing by the Department of Economic Development and Tourism and Wesgro

The Department and Wesgro briefed the Committee on Delta Airlines, who are unable to fly to Cape Town, film permits in the Western Cape, attracting the film industry to the Province, and remote working visas, electronic visas and the issuing of visas.

The Committee asked questions based on the presentations and information received.

3. Tour of the Cape Town Film Studios

Members Baartman, van der Westhuizen, Bosman and Nkondlo attended the tour of the Cape Town Film Studios. The Members were required to sign Non-Disclosure Agreements (NDA) and produce clear COVID PCR test results in order to gain access to the facility. Ms W Stander, Ms M Rorvic and Ms A Venter joined the delegation.

The delegation was met by Mr M Slamang, the Acting CEO of the Cape Town Film Studios, who guided the Committee around the facility and sets belonging to Project Panda.

Due to the signing of NDAs, the Committee is unable to provide details on Project Panda and other private studio-related matters.
