### 1. Welcome

The Chairperson welcomed the Members and noted that there were no apologies. The Committee proceeded to the consideration and adoption of draft reports and committee minutes.

The Chairperson requested that the agenda be amended in order to deliberate on the resolutions for, and the consideration and adoption of the draft Report on the Oversight Visit to the Pick 'n Pay Market Stores in Langa.

# 2. Deliberations on the Resolutions to be included in the Draft Committee Report on the Oversight Visit to the Pick 'n Pay Market Stores in Langa, and the Consideration and Adoption of the Draft Report

The Committee amended the draft report in respect of 3.12 to indicate that the property was leased from the Nabe Family and not Pick 'n Pay.

The Committee amended 4.5 to indicate that the Ms T Dike had changed to a Nedbank account as a requirement from Pick 'n Pay for the market store model, hence the challenge with high banking fees.

Thereafter, Members deliberated on resolutions to be included in the draft report, which were agreed to by the Committee.

On completion of the deliberations on the resolutions, the Committee considered and adopted the report with the amendments and addition of the resolutions.

3. Consideration and adoption of the Draft Committee Report on the Deliberations of the 2020/21 Annual Report of the Department of Economic Development and Tourism and its Entities; Wesgro, Saldanha Bay IDZ Licencing Company and Atlantis ASEZ

The Committee considered the Draft Report on the 2020/21 Annual Reports of the Department and its Entities.

The Committee agreed to amend observation 3.1.1 to indicate that the Department facilitated the opening of re-opening of the George Airport.

The Committee also amended observation 3.2.1 to read that the revitalisation of the South African maritime industry was an opportunity, not a challenge, as previously drafted.

Thereafter, the Committee considered and adopted the draft report with amendments.

# 4. Deliberations on the resolutions to be included in the Draft Report on the Committee's Public Participation Process on the UIF's Temporary Employer/Employee Relief Scheme

The Committee deliberated on the draft report and agreed to add a table listing the stakeholders that were emailed about the Committee's TERS public participation process. It was agreed that the table would be included as an annexure.

The Committee deliberated and agreed on the resolutions to be included in the draft report.

Thereafter, the Committee considered and adopted the report with amendments and the addition of the resolutions.
