NOTICES OF MOTION (9 March 2023)

1. Mr M K Sayed: That the House debates the fact that more than 400 learners are yet to be placed in Western Cape; while other learners are preparing to write end-of-term tests, some parents are still struggling to find school placement for their children.
2. Mr C M Dugmore: That the House debates GBV and femicide in the Western Cape, as well as sexual harassment cases in the provincial government.
3. Ms R Windvogel: That the House debates the backlog of elective surgeries at the Western Cape hospitals.
4. Ms R Windvogel: That the House debates the challenges related to health, as well as the decommissioning of COVID-19 hospitals.
5. Mr M Kama: That the House debates the case of sport in the Western Cape.
6. Ms A P Bans: That the House debates crimes targeted at emergency staff in the Western Cape.

NOTICES OF MOTION (2 March 2023)

1. Ms A P Bans: That the House notes with deep concern the rising crime levels in the Western Cape that were reported in the 2022/23 third quarter crime statistics, between October and December 2022, which showed that 1 198 people were murdered and 2 157 sexual offences, including the rape of 1 518 innocent women and children, took place; acknowledges that this picture confirms that the Western Cape is a crime scene and that the Safety Plan in its current form is a big expensive failure; and calls on the Premier to refocus the implementation of the Safety Plan to address the causative factors of violent crimes, to redeploy LEAP officers in rural areas, and to focus on addressing GBV and femicide.
2. Mr M K Sayed: That the House notes that the ANC is not pleased with the absence of regular sittings of the House; notes that it is not acceptable that out of seven Thursdays in the first quarter of the year, there will only be two regular sittings of the House; notes that this gives an indication that the DA is not interested in discussing and solving the issues of our people and not interested in constitutional obligations and avoiding accountability; notes that the DA treats the House like its playground, where they will do as they please and everyone else should follow their lead; notes that this is unacceptable and downright disrespects other parties in the House; and calls for the Speaker to make a ruling on this matter.
3. Ms N D Nkondlo: That the House lauds Gauteng Premier Panyaza Lesufi for the progressive commitments made in his outstanding State of the Province Address where he has committed to use 60 per cent of the R34 billion goods and services budget to support initiatives to boost the township economy; notes that this is inclusive of directing provincial government procurement to township enterprises as this will go a long way in creating employment in each household; commends Gauteng for its dedication to the township economy; and calls on the Western Cape Government to follow suit and to redirect funds towards the township economy and to develop its own Township Economy Act.
4. Ms N G Bakubaku-Vos: That the House notes with deep sadness the Western Cape High Court judgment to grant the City of Cape Town permission to evict homeless people off the streets; notes that the notices of eviction are to be served to the people at several occupation hotspots along Buitengracht Street, FW de Klerk Boulevard, Foregate Square, taxi rank and foreshore, Helen Suzman Boulevard, Strand Street, foreshore/N1, Virginia Avenue and Mill Street bridge in the city; notes further and accepts that the court action by the DA goes a long way to expose the depth of hatred for the poor and downtrodden by the DA; condemns the disingenuous and misleading claims by the Cape Town Mayor Geordin Hill-Lewis that the City had done its “absolute level best” over the past year to offer care to each of the homeless people; appreciates that homelessness is a complex issue that needs various specialties to address the needs of homeless people; and calls on all three spheres of government to intervene urgently to assist the poor.
5. Mr M K Sayed: That the House notes the damning allegations levelled against the principal of the Ned Doman High School in Athlone of allegedly intimidating learners and teachers; notes further that several complaints have been made against the principal in the past, including allegedly detaining learners at the school without informing parents, illegally withholding reports of learners who owe fees, and even allegedly undermining the cultural beliefs of learners at the school; notes that, despite all these complaints and several other concerns we have personally raised about him, he remains untouchable; and cautiously welcomes the long overdue visit by the Standing Committee on Education to the school next week and Tuesday who, we trust, will listen to all the affected parties.

6. Mr M K Sayed: That the House notes with disgust that 32 days have passed since the start of the 2023 academic year and yet close to 1 000 learners are not yet placed at schools, which shows that we have a serious multi-year learner placement crisis in Western Cape; notes further that unplaced learners have thus far missed out on 32 of the 51 days of the first quarter of this academic year; appreciates that this is a self-orchestrated crisis by the weak Premier and his government that continues to protect and encourage former Model C schools to discriminate against learners on the basis of race and class and thus keep their schools underutilised with average class sizes of fewer than 25 learners, while schools in poor and working-class communities are forced to have up to 70 learners in a class; and repeats the ANC's call for all public ordinary schools to be fully utilised by having up to 35 learners in class.
7. Ms D M Baartman: That the House notes the Western Cape High Court judgment handed down yesterday in favour of the Western Cape Education Department against CODETA's illegal attempts to seize control of the learner transport market; notes that this judgment will end the criminal and profit-motivated blockade of school children by elements of the taxi industry, which has resulted in thousands of absences; and celebrates the resumption of the academic project by many hundreds of learners today and commends Minister David Maynier's swift action to resolve this crisis.
8. Mr T M Klaas: That the House notes that early last week the DA-led City of Cape Town announced that it was granted an eviction order to remove homeless people living in open spaces around Cape Town; further note that the City did this without prior engagement with these vulnerable members of our society and without a clear plan for shelters in which they are going to house them; notes that the majority of homeless people complained afterwards that shelters normally charge rental fees (although this is normally not disclosed to them before by the City), they are squeezed into congested rooms, families are separated, and there is no privacy whatsoever; further calls on the DA-led Western Cape Government to offer homeless people dignified places to live in, including access to proper housing as the Constitution of South Africa requires; and urges this government to take the initiative to assist homeless people to apply for proper housing.
9. Mr T M Klaas: That the House notes that the so-called Safety Plan is just a waste of taxpayers' money, as there is no statistical evidence that it is effective and successful when taking into account that it operates parallel with the South African Police Service; further notes this so-called Safety Plan is narrow in scope, as it only focuses on murders (and even here it is failing), while excluding other forms of crime, such as gangs charging businesses protection fees; notes that mass murders in the province continue unabated, just last week four people were shot and killed in the Wallacedene informal settlement close to Kraaifontein; notes that the Mfuleni township has taken the top spot in the whole country when it comes to the high number of murders there, according to the latest 2022 Third Quarter Crime Statistics; and asks this provincial government to work with the national government to eradicate crime in the province.

VOORSTELLE MET KENNISGEWING (9 Maart 2023)

1. Mnr M K Sayed: Dat die Huis die feit dat meer as 400 leerders in die Wes-Kaap nog geplaas moet word, debatteer; terwyl ander leerders voorberei om toetse aan die einde van die kwartaal te skryf, sukkel sommige ouers steeds om skoolplasing vir hul kinders te vind.
2. Mnr C M Dugmore: Dat die Huis geslagsgebaseerde geweld en vrouemoord in die Wes-Kaap, asook gevalle van seksuele teistering in die provinsiale regering, debatteer.
3. Me R Windvogel: Dat die Huis die agterstand in elektiewe chirurgiese prosedures by Wes-Kaapse hospitale debatteer.
4. Me R Windvogel: Dat die Huis die uitdagings met betrekking tot gesondheid, asook die buitediensstelling van COVID-19-hospitale, debatteer.
5. Mnr M Kama: Dat die Huis die onderwerp van sport in die Wes-Kaap debatteer.
6. Me A P Bans: Dat die Huis misdaad wat noodpersoneel in die Wes-Kaap teiken, debatteer.

VOORSTELLE MET KENNISGEWING (2 Maart 2023)

1. Me A P Bans: Dat die Huis met diepe kommer kennis neem van die stygende misdaadvlakke in die Wes-Kaap wat aangemeld is in die misdaadstatistiek vir die derde kwartaal van 2022/23, tussen Oktober en Desember 2022, wat aantoon dat 1 198 mense vermoor is en 2 157 seksuele oortredings, insluitend die verkragting van 1 518 onskuldige vroue en kinders, plaasgevind het; daaraan erkenning gee dat hierdie inligting bevestig dat die Wes-Kaap 'n misdaadtoneel is en dat die Veiligheidsplan in sy huidige vorm 'n groot en duur mislukking is; en 'n beroep op die Premier doen om die implementering van die Veiligheidsplan te herfokus om die oorsakende faktore van geweldsmisdade aan te spreek, om LEAP-beamptes in landelike gebiede te herontplooi, en om daarop te fokus om aan geslagsgebaseerde geweld en vrouemoord aandag te skenk.
2. Mnr M K Sayed: Dat die Huis kennis neem dat die ANC nie tevrede is met die afwesigheid van gereelde sittings van die Huis nie; kennis neem dat dit nie aanvaarbaar is dat daar uit sewe Donderdae in die eerste kwartaal van die jaar slegs twee gereelde sittings van die Huis sal wees nie; kennis neem dat dit 'n aanduiding gee dat die DA nie daarin belangstel om die kwessies van ons mense te bespreek en op te los nie, en nie in grondwetlike verpligtinge belangstel nie en aanspreeklikheid vermy; kennis neem dat die DA die Huis soos sy speelterrein hanteer, waar hulle maak soos hulle wil en almal anders hul leiding moet volg; kennis neem dat dit onaanvaarbaar is en die ander partye in die Huis heeltemal minag; en 'n beroep op die Speaker doen om 'n beslissing oor hierdie aangeleentheid te maak.
3. Me N D Nkondlo: Dat die Huis die Gautengse Premier, Panyaza Lesufi, aanprys vir die progressiewe verbintenisse wat in sy uitstekende provinsiale rede gemaak is, waar hy hom daartoe verbind het om 60 persent van die goedere-en-dienstebegroting van R34 miljard te gebruik om inisiatiewe te ondersteun om die informelenederssettingseconomie 'n hupstoot te gee; kennis neem dat dit insluit om die verkryging van die provinsiale regering na ondernemings in informele nedersettings te verwys, omdat dit baie sal doen om indiensneming in elke huishouding te skep; Gauteng aanprys vir sy toewyding tot die informelenederssettingseconomie; en 'n beroep op die Wes-Kaapse Regering doen om sy voorbeeld te volg en om fondse na die informelenederssettingseconomie te herlei en om sy eie Wet op die Informelenederssettingseconomie te ontwikkel.
4. Me N G Bakubaku-Vos: Dat die Huis neem met diepe hartseer kennis van die uitspraak van die Wes-Kaapse Hooggeregshof om die Stad Kaapstad toestemming te gee om hawelose mense van die strate te verwyder; kennis neem dat die uitsettingskennisgewings aan die mense by verskeie besettingsbrandpunte in Buitengrachtstraat, FW de Klerk-boulevard, Foregate-plein, taxistaanplek en die strandgebied, Helen Suzman-boulevard, Strandstraat, strandgebied/N1, Virginiaalaa en die Millstraat-brug in die stad beteken sal word; verder kennis neem en aanvaar dat die hofaksie deur die DA baie doen om die diepte van die DA se haat vir armes en verdruktes bloot te lê; die onbehoorlike en misleidende bewerings deur die Kaapstadse burgemeester, Geordin Hill-Lewis, dat die Stad die afgelope jaar sy "allerbeste" gedoen het om sorg aan elke hawelose mens aan te bied, veroordeel; aanvaar dat haweloosheid 'n ingewikkelde kwessie is wat verskeie spesialisgebiede betrek om aandag te skenk aan die behoeftes van hawelose mense; en 'n beroep op al drie regeringsfere doen om dringend in te gryp om die armes by te staan.
5. Mnr M K Sayed: Dat die Huis kennis neem van die verdoemende bewerings wat teen die hoof van die Hoërskool Ned Doman in Athlone gemaak is, naamlik dat hy leerders en onderwysers na bewering intimideer; verder kennis neem dat verskeie klagtes in die verlede teen die skoolhoof gemaak is, insluitende dat hy na bewering leerders by die skool hou sonder om hul ouers in te lig, dat hy leerders wat geld skuld,

se rapporte onwettig terughou, en dat hy na bewering selfs die kulturele oortuigings van leerders by die skool ondermyn; kennis neem dat, ten spyte van al hierdie klagtes en verskeie ander bekommernisse wat ons persoonlik oor hom geopper het, hy onaantasbaar bly; en met omsigtigheid die Staande Komitee vir Onderwys se besoek volgende week en Dinsdag aan die skool, wat lankal moes gebeur het, verwelkom wat, ons hoop, na al die betrokke partye sal luister.

6. Mnr M K Sayed: Dat die Huis met afkeer kennis neem dat 32 dae verloop sedert die aanvang van die 2023- akademiese jaar het en dat nagenoeg 1 000 leerders nog nie by skole geplaas nie, wat aantoon dat ons 'n ernstige meerjarige leerderplasingskrisis in die Wes-Kaap het; verder kennis neem dat ongeplaasde leerders tot dusver 32 van die 51 dae van die eerste kwartaal van hierdie akademiese jaar misgeloop het; aanvaar dat dit 'n selfgeorkestreerde krisis is wat deur die swak Premier en sy regering veroorsaak word, omdat hulle voortgaan om voormalige Model C-skole te beskerm en aan te moedig om teen leerders op grond van ras en klas te diskrimineer, en sodoende hul skole onderbenut te hou met gemiddelde klasgroottes van minder as 25 leerders, terwyl skole in arm en werkersklasgemeenskappe gedwing word om tot 70 leerders in 'n klas te hê; en hdie ANC se beroep herhaal dat alle openbare gewone skole ten volle benut moet word deur tot 35 leerders in die klas te hê.
7. Me D M Baartman: Dat die Huis kennis neem van die uitspraak van die Wes-Kaapse Hooggeregshof wat gister ten gunste van die Wes-Kaapse Onderwysdepartement gelewer is teen CODETA se onwettige pogings om beheer oor die mark vir leerdervoer oor te neem; kennis neem dat hierdie uitspraak die strafregtelike en winsgemotiveerde blokkade van skoolkinders deur elemente van die taxibedryf sal beëindig, wat tot duisende afwesighede gelei het; en die hervatting vandag van die akademiese projek deur baie honderde leerders vier en Minister David Maynier se vinnige optrede om hierdie krisis op te los aanprys.
8. Mnr T M Klaas: Dat die Huis kennis neem dat die DA-geleide Stad Kaapstad vroeg verlede week aangekondig het dat 'n uitsettingsbevel toegestaan is om hawelose mense wat in oop ruimtes in Kaapstad woon, te verwyder; verder kennis neem dat die Stad dit gedoen het sonder vooraf skakeling met hierdie kwesbare lede van ons samelewing en sonder 'n duidelike plan vir skuilings waar hulle hulle gaan huisves; kennis neem dat die meerderheid hawelose mense daarna gekla het dat skuilings gewoonlik huurgeld vra (alhoewel dit normaalweg nie vooraf deur die Stad aan hulle bekend gemaak word nie), dat hulle in oorvol kamers ingedruk word, dat gesinne geskei word en dat daar hoegenaamd geen privaatheid is nie; verder 'n beroep op die DA-geleide Wes-Kaapse Regering doen om hawelose mense menswaardige woonplekke aan te bied, insluitende toegang tot behoorlike behuising soos die Grondwet van Suid-Afrika vereis; en hierdie regering aanmoedig om die inisiatief te neem om hawelose mense te help om aansoek te doen om behoorlike behuising.
9. Mnr T M Klaas: Dat die Huis kennis neem dat die sogenaamde Veiligheidsplan net 'n vermorsing van belastingbetalers se geld is, aangesien daar geen statistiese bewyse is dat dit doeltreffend en suksesvol is nie, as in ag geneem word dat dit in parallel met die Suid-Afrikaanse Polisie diens funksioneer; verder kennis neem dat hierdie sogenaamde Veiligheidsplan se klem beperk is, aangesien dit net op moorde fokus (en selfs hier misluk dit), terwyl dit ander vorme van misdaad, soos bendes wat beskermingsfooie van sakeondernemings eis, uitsluit; kennis neem dat massamoorde in die provinsie onverpoosd voortduur, net verlede week is vier mense in die Wallacedene- informele nedersetting naby Kraaifontein doodgeskiet; kennis neem dat die Mfuleni- informele nedersetting volgens die jongste misdaadstatistiek vir die derde kwartaal van 2022 die topposisie in die hele land beklee ten opsigte van die hoë getal moorde wat daar plaasvind; en vra dat hierdie provinsiale regering om saam met die nasionale regering werk om misdaad in die provinsie uit te roei.

UMnu M K Sayed: Sokuba iNdlu iqaphela ngomsindo ukuba iintsuku ezingama-32 zidlule oko kuthe kwaqala unyaka wokufunda ka-2023 kwaye nangoku phantse i-1 000 labafundi alikabikho zikolweni, nto leyo ibonakalisa ingxaki enkulu yobeko lwabafundi ezikolweni yaminyaka le eNtshona Koloni; iyaqaphela kwakhona ukuba abafundi abangabekwanga zikolweni ukuza kuthi ga ngoku balahlekelwe ngama-32 eentsuku ezingama-51 ekota yokuqala zalo nyaka wokufunda; iyayamkela ukuba le yingxaki eyenziwe ngumntu ngabom yiNkulumbuso ebuthathaka norhulumente wayo oqhuba ekhusela kwaye ekhuthaza izikolo ezazisakuba zezikaModel C ukuba zibandlulule ngakubafundi ngokwebala nodidi kwaye ngokwenza njalo begcina izikolo zabo zingasetyenziswa zine-avareji engaphantsi kwabafundi abangama-25, ngeli lixa izikolo zabahluphekayo noluntu lwabasebenzi zinyanzeleka ukuba azibe nabafundi abafikelela kuma-70 kwigumbi lokufundela; kwaye iphinda ikhwelo le-ANC lokuba izikolo zoluntu eziqhelekileyo ukuba zisetyenziswe ngokupheleleyo ngokuba zibe namalunga ama-35 abafundi kwigumbi labafundi.

UNksz D M Baartman: Sokuba iNdlu iyasiqaphela isigwebo seNkundla ePhakamileyo yaseNtshona Koloni esiwiswe izolo sigwebela iSebe lezeMfundo laseNtshona Koloni ngakwimigudu engekho mthethweni yeCODETA ukuthabathela ulawulo lwentengo yothutho lwabafundi; iyaqaphela ukuba esi sigwebo siza kuphelisa uvingco lolwaphulo-mthetho nolucutywa kukunyolukela inzuzo lwabantwana besikolo zizigulamkhuba zoshishino lweeteksi, olukhokelele kumawaka ephoswa kukuya esikolweni; kwaye ivuyela ukuqalisa kwakhona iphulo lokufunda ngamakhulu abafundi namhlanje kwaye incoma inyathelo elikhawulezileyo likaMphathiswa David Maynier ukusombulula le ngxaki.
8. UMnu T M Klaas: Sokuba iNdlu iyaqaphela ukuba ebuthathaka beveki ephelileyo iSixeko seKapa esikhokelwa yi-DA sibhengeze ukuba sifumene umyalelo wokususela abantu abangenamakhaya abahlala kwiindawo ezivulelekileyo eKapa; iphinda iqaphela ukuba iSixeko sikwenze oko ngaphandle kokubonisana kuqala nala malungu abuthathaka oluntu lwethu kwanangaphandle kwesicwangciso esicacileyo samagwiba apho besiza kubahlalisa oku; iyaqaphela ukuba uninzi lwabantu abangenamakhaya bakhalazile mvanje besithi la magwiba aqheleke ukuba abize imirhumo yerente (nangona oku kungaqhelekanga ukuba kuxelwe kubo ngaphambili siSixeko), baxinaniselwa kumagumbi aphuphumalayo, iintsapho ziyohlulwa, kwaye akukho mfihlo kwaphela; iphinda imemelela kuRhulumente weNtshona Koloni okhokelwa yi- DA ukuba abonelele abantu abangenamakhaya ngeendawo ezisesidima abanokuhlala kuzo, kuquka ufikelelo kwezezindlu ezifanelekileyo njengoko uMgaqo-siseko zoMzantsi Afrika unyanzelisa; kwaye ikhweba lo rhulumente ukuba athabathe inyathelo lokunceda abantu abangenamakhaya ukuba bafake izicelo zezindlu ezifanelekileyo.

UMnu T M Klaas: Sokuba iNdlu iyaqaphela ukuba okubizwa njengeSicwangciso soKhuseleko yindlalo nje ngemali yabarhafi, kuba akukho bungqina beenkcukachamanani obusebenzayo nobunempumelelo xa kuthatyathelwa ingqalelo ukuba sisebenza ecaleni leNkonzo yaMapolisa oMzantsi Afrika; iphinda iqaphele ukuba oku kubizwa njengeSicwangciso soKhuseleko kuxinene, kuba kugxile kuphela kubulawo lwabantu (kwaye nkqu nalapha siyasilela), ngeli lixa sikhuphela ngaphandle ezinye iintlobo zolwaphulo-mthetho, olufana namaqela oonqevu ehlawlisa aamashishini imirhumo yokukhuselwa; iyaqaphela ukuba ubulawo lwesininzi kweli phodo luqhuba ngaphaya kokuqonda, nje kule veki iphelileyo abantu abane badutyulwe baza babulawa kwindawo yamatyotyombe yaseWallacedene ngaseKraaifontein; iyaqaphela ukuba ilokishi yaseMfuleni ithabathe indawo yokuqala kwilizwe liphela xa kuthethwa nenani eliphezulu labantu ababulawayo phaya, ngokutsho

kweeNkcukachamanani zoLwaphulo-mthetho zeKota yesiThathu zika-2022; kwaye imemelela kulo rhulumente wephondo ukuba asebenze kunye norhulumente kazwelonke ukuncothula neengcambu ulwaphulomthetho ephondweni.
