Report of the Standing Committee on Finance, Economic Opportunities and Tourism (the Committee) on the recommendations for the appointment of candidates to the Western Cape Gambling and Racing Board, dated 24 March 2023, as follows:

- The matter of vacancies on the Western Cape Gambling and Racing Board (the Board) was
 referred to the Committee on 14 February 2023, by the Office of the Speaker. The
 Provincial Treasury informed the Committee that there were two vacancies that needed
 to be filled.
- 2. Section 3(1) of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996, as amended) (the Act) stipulates: "The Board shall consist of seven members, appointed on a part-time basis, by the Executive Council in accordance with the prescribed procedure, which shall provide for public participation in the nomination of candidates for appointment; provided that the standing committee of the Provincial Legislature responsible for this Act shall evaluate all candidates as to their suitability for appointment."
- 3. On 13 March 2023, the Provincial Treasury briefed the Committee on the process leading to the shortlisting of candidates. The Committee was provided with a list of eight candidates to evaluate.
- 4. Following the briefings by the Provincial Treasury and Nexus Forensic Services, the service provider that conducted the probity assessments, the Committee resolved to evaluate the eight candidates. The Committee also resolved to evaluate the candidates through an interview process.
- 5. In accordance with Section 4(3) of the Western Cape Gambling and Racing Regulations, 1996 (PN 239 of 1996), the Committee "... shall, within seven days from receiving the documentation... submit a final short list of not less that fifteen names or, in respect of any vacancy occurring on the Board, of not less than three names, together with the comprehensive list of all applicants to the responsible Minister for submission for consideration to the Executive Council".
- 6. The Committee, having interviewed the candidates on 24 March 2023, recommends the following candidates, ranked as follows:

6.1 For the first vacancy:

- Mr Terence Arendse
- Ms Ayanda Mvandaba

6.2 For the second vacancy:

- Mr Claude Bassuday
- Ms Ayanda Mvandaba
