4.1.3 All relevant stakeholders be invited;

4.1.4 Advertisements be placed in the Die Burger, Cape Argus, Die Son, City Vision, George Herald, Die Hoorn, and Weslander;


4.1.5 Social media platforms be used to inform the public about the bills and the public hearings; and
