2.1 The Committee RESOLVED that:

2.1.1 The Committee would meet quarterly with the Department of Local Government and

2.1.2 Provincial Treasury brief the Committee on the Municipal Standard Chart of Accounts and

the ICT support to these three municipalities to assist with the audit process;

2.1.3 That the Committee conduct similar meetings at Matzikama and Cederberg Municipalities

should the Parliamentary programme allows for it; and

2.1.4 SALGA facilitate a session with Provincial Treasury on the effectiveness of Municipal Public

Accounts Committees and what is required of these committees.

2.2 The Committee REQUESTED that:

2.2.1 The Department of Local Government and Provincial Treasury provide the Committee with

the dates and agendas of envisaged meetings (where support will be provided to the municipalities) with Kannaland, Beaufort West and Laingsburg Municipalities;

2.2.2 Provincial Treasury provide the Committee with a copy of the Financial Recovery Plan for

Beaufort West Municipality;

2.2.3 Provincial Treasury provide the Committee with information and the requirements on how

capital expenditure can be spent in an unfunded budget;

2.2.4 Kannaland, Beaufort West and Laingsburg Municipalities provide the Committee with

copies of the Local Economic Development Strategies;

2.2.5 Kannaland, Beaufort West and Laingsburg Municipalities provide the Committee with the

names of their respective Audit Committees;

2.2.6 Beaufort West Municipality provide the Committee with a list of their creditors.
