## 1. Welcome and attendance

Consequently, the Chairperson suggested a temporary suspension of the meeting at 09:08, scheduled to resume at 09:23, to allow for administrative efforts in securing a formal response from the NCOP. Upon reconvening, and in the absence of the referral, the Committee decided to adjourn until 11:00, anticipating the arrival of the referral by then.

At 11:00 the officials from the National Treasury briefed the Committee on the above-mentioned subject matters.

The Committee deliberated on the presentation by Provincial Treasury.

## **3. Public Hearing on the Division of Revenue Amendment Bill [B 33-2023] (NCOP)**


The Chairperson explained the advertisement process where the Committee invited all interested persons to make submissions on the Bill.
