#### 1. Welcome and attendance

The Chairperson opened the meeting and welcomed the Members of Provincial Parliament present and any members of the public that were present. The Chairperson explained the rules of engagement in virtual meetings and noted that there were no apologies.

2. Deliberations on the Final Mandate for the Public Procurement Bill [B 18D – 2023]

The Chairperson informed Members that she had received communication from the Chairperson of the Select Committee on Finance, Mr Y Carrim, indicating that they were requesting comments on the proposed amendments for the Public Procurement Bill [B 18D – 2023](NCOP). The Chairperson requested procedural advice on whether the Committee

may continue with the deliberations on the final mandate.

The Chairperson was advised that clarity had been sought from the NCOP, who indicated that the request was for stakeholders who had made submissions on the Bill, and that the final mandate was still expected to be submitted before the NCOP Select Committee's

meeting to consider the provinces' final mandates on 7 May 2024.

The Committee proceeded with the deliberations on the final mandate for the Public

Procurement Bill.

Member Brinkhuis indicated that Al Jama-ah supported the Bill, while Members Murray and Sileku indicated that they would confer on the NCOP delegate not to support the Bill, as it

seemed that there would still be changes to the Bill.

3. Consideration and Adoption of the Final Mandate on the Public Procurement Bill

[B 18D - 2023]

The Chairperson tabled the Final Mandate on the Public Procurement Bill [B 18D – 20223] and requested that Members indicate if they were in support of the adoption of the final mandate or not. The final mandate was then adopted, conferring on the NCOP delegate the authority not to support the Bill. Al Jama-ah expressed its Minority View in terms of Standing

Rule 90 to support the Bill.

4. Closure of meeting

The Chairperson thanked the Members and procedural staff for their contribution to the meetings and for their hard work during the term. The Members thanked the Chairperson for the significant role she played in chairing the Committee and wished her well for her

future endeavours.

The meeting adjourned at 09h27.
