2. Briefing by the Independent Electoral Commission (IEC)

Mr Hendrickse, presented to the Committee. The briefing focused on reflections of the recently held 2024 National and Provincial Elections (NPE). The IEC's closing report, largely due to pending court matters, has not yet been finalised. The presentation therefore covered aspects such as the voters roll, voter management devices, special votes, Section 24A notifications, an overview of voting day turnouts, staffing and education and outreach prior to the NPE.

3. Consideration and adoption of draft minutes


The Committee considered and adopted the draft Minutes of 23 August 2024.

4. Resolutions/Actions

The Committee resolved to:

- 4.1 Have regular interactions with the Independent Electoral Commission for it to update the Committee in terms of their mandate and their efforts to avoid logistical bottlenecks that could delay voting.
- 4.2 Request that the Independent Electoral Commission provides it with its outreach activities and programmes that illustrate their efforts to educate and register people of the Western Cape in how to exercise their rights.
