1. Welcome

The Chairperson welcomed the Members, organisations and members of the public and media and noted an apology from Member D Baartman (DA).

The Chairperson explained the rules of engagement to Members and officials in respect of virtual meetings and then proceeded to the presentations.

The Chairperson informed the Committee that they will continue its public engagement programme and be briefed by various individuals and organisations. These individuals and organisations indicated that they would want to make verbal presentations on their written submissions.

The Committee deliberated and engaged with the individuals and organisations on the oral submissions.

The Chairperson thanked each participant for putting a lot of thought and effort into their submissions and giving the Committee a better idea of the impact of the pandemic on the communities.

3. Consideration and deliberations on grid of public participation and dealing with public submissions received.

The Chairperson informed the Committee that the Committee agreed on a set of questions to be posed for the public participation process. The questions were translated in the three official languages of the Western Cape, adverts were placed in various traditional media and a social media campaign was launched as well. The Committee received just under 17 000 submissions. The Committee will therefore need to agree on a way forward in dealing with the vast amounts of submissions received.

The Chairperson proposed that the Ad Hoc Committee be grouped in 5 Working Groups, consisting of 3 members in each working group. The respective Working Groups will deal with a set of submissions and report back to the full Ad hoc committee. The respective Working Groups would then meet on Thursday, 8 and Friday, 9 October 2020. A procedural officer will be assigned to each Working Group and each Working Group will submit a short report on its findings to the Ad Hoc Committee and table this with the full Ad Hoc Committee on Wednesday, 14 October 2020. The Committee agreed to the proposal.
