- 4. In order to comply with section 7(2)(b) of the Western Cape Provincial Languages Act, 1998 (Act 13 of 1998), the Committee resolved to submit its shortlist of candidates to the Provincial Minister of Cultural Affairs and Sport to consider for appointment.
