## COMMITTEE REPORT

Report of the Rules Committee on the proposed Allocation of Whips per party, Composition of the Programming Authority, Allocation of Committees, Representation on Committees and the nomination of a Member as Trustee, representing the WCPP on the Political Office-Bearers Pension Fund Board of Trustees, dated 25 June 2024

The Rules Committee, having considered the proposals in the above regard, begs to report that it has unanimously approved the proposals for ratification by the House as follows:

## 1. Allocation of Whips

The Chief Whip of the majority party, Hon G Bosman, proposed that the ratio of Whips to Members be 1:6; and that the majority party be allocated a Chief Whip and a Deputy Chief Whip, and the Official Opposition be allocated a Chief Whip.

It was agreed that the DA be entitled to four (4) whips and the ANC one (1) Whip.

## 2. Representation on Programming Authority

The Committee agreed to the proposal by the Chief Whip of the majority party, Hon G Bosman, that the Programming Authority consists of 9 Members.
The DA shall therefore be entitled to five (5) Members and the ANC to one (1) Member, PA one (1) Member, EFF one (1) Member and one (1) Member to the smaller parties who would have to decide amongst themselves on the representative, on an annual rotation basis to serve on this committee.

## 3. Allocation of Committees

The Committee agreed to the proposal by the Chief Whip of the majority party, Hon G Bosman, that the Committees be clustered in the following manner:
(i) Cluster A - Social: Which will comprise of: "Standing Committee on Premier and Constitutional Matters; Standing Committee on Health and Wellness; Standing Committee on Education; Standing Committee on Social Development and Standing Committee on Police Oversight, Community Safety and Cultural Affairs and Sport."
(ii) Cluster B - Economic: Which will comprise of: "Standing Committee on Infrastructure; Standing Committee on Local Government; Environmental Affairs and Development Planning; Standing Committee on Mobility, Standing Committee on Finance, Standing Committee on Agriculture, Economic Development and Tourism."
(iii) Cluster C - Corporate: Which will comprise of: "Parliamentary Oversight Committee; Public Accounts Committee; Budget Committee; Conduct Committee; Rules Committee and Programming Authority."

## 4. Representation in Committees

The Committee agreed that Standing Committees be composed of Seven (7) Members as follows:
a) DA : 4 Members;
b) ANC : 1 Member;
c) PA : 1 Member; and
d) 1 representative from the smaller parties to take up membership in a committee, on an annual rotational basis.
5. The Rules Committee, having considered the nomination of a Member as Trustee, representing the WCPP on the Political Office-Bearers Pension Fund Board of Trustees referred to it, begs to report as follows:
That Mr A W Bredell be appointed as the Pension Fund Trustee of the WCPP and Mr D J Wessels as an Alternate.
