#### 1. Introduction

#### 1.1 The mandate of the Committee is to:

- 1.1.1 Maintain oversight over the executive, the Department and its entity, including the implementation of legislation, and to hold them accountable to the Western Cape Provincial Parliament; and
- 1.1.2 Consider and report on legislation, other matters and annual reports referred to it by the Speaker.

- 1.2.1 Facilitated public participation and involvement in the legislative and other processes of the Committee:
- 1.2.2 Conducted its business in a fair, open and transparent manner;
- 1.2.3 Promoted cooperative governance; and
- 1.2.4 Reported regularly to the House.

## 5. Oversight activities

- 5.1 The first quarter started with a briefing by the Department on its Fourth Quarterly Performance Report (January 2022–March 2022) and Expenditure Report for the same period which was followed by a briefing by the Department on the Western Cape 2022 Easter weekend road safety statistics and the Road Safety Plan for 2022. The Western Cape Provincial Transport Infrastructure Bill was referred to the Committee and the Committee facilitated two public hearings on the Bill. The Committee also conducted an oversight visit to the George Integrated Transport Network (Go George) and the Government Motor Transport Regional Hub in George and the Gene Louw Traffic College in Brackenfell. The Committee was again reconstituted and Mr R Mackenzie was elected as the new Chairperson of the Committee.
  - 5.2 The Committee met with various stakeholders on the recent attacks on the public bus service after which the Committee had several meetings to consider the Western Cape Provincial Transport Infrastructure Bill [B 5–2021]. The committee met with Sasol and received a briefing on the fuel additives that consumers add to their fuel to achieve better fuel efficiency. The second quarter ended with a Cluster B visit week to the Overberg

region during which the Cluster visited the Villiersdorp replacement clinic which is currently under construction and the South Africa National Space Agency.

- 5.3 The Committee met with the Department and deliberated on the annual reports of the Department of Transport and Public Works and Government Motor Transport for the 2021/22 financial year. Due to some outstanding technical matters, the Committee could not finalise the Western Cape Provincial Transport Infrastructure Bill [B 5–2021]. The Committee concluded the year with the deliberation on Vote 10: Transport and Public Works in the Schedule to the Western Cape Adjustments Appropriation Bill [B 3–2022] and the consideration and adoption of the Committee Report on Vote 10: Transport and Public Works in the Schedule to the Western Cape Adjustments Appropriation Bill [B 3–2022].
- 5.4 The Committee also dealt with the Western Cape Provincial Transport Infrastructure Bill [B 5–2021] and concluded its deliberations on the Bill. In February 2023 the Committee was reconstituted and Member D America was elected as the new Chairperson. The Committee had to adopt a new A Bill on the Western Cape Provincial Transport Infrastructure Bill [B 5–2021] due to amendments that were detected in the Afrikaans version of the Bill. On 16 March 2023 the Department briefed the Committee on Vote 8: Mobility in the Schedule to the Western Cape Appropriation Bill [B 2–2023]. The Economic Regulation of Transport Bill [B 1B–2020] (NCOP) was referred to the Committee and on 23 March 2023 the Department of Transport briefed the Committee on the Bill.
