An apology was rendered on behalf of Member A Van der Westhuizen.

1. Welcome and Introduction

The chairperson opened the meeting and welcomed all present. After setting the context for the meeting he allowed for brief introductions by those present. He also allowed the Provincial Minister of Cultural Affairs and Sport, Ms A Marais, and the Head of Department, Mr B Walters, to present introductory comments.

2. Department of Cultural Affairs and Sport presentation

The Department of Cultural Affairs and Sport (the Department) presented an overview of its 2019/20 Annual Performance Plan. The presentation addressed matters related to the Department's Vision, Mission, Core Function, Organisational Structure, Strategic Goals and the Mid Term Expenditure Framework for 2019/20 – 2021/22.

The Department also presented on its programmes, legislation in the pipeline, and provided updates on its current projects. Key points of discussion focused on the Department's geographic footprint, its alternative employment mechanisms, its Public Entities, and its main clients. Additionally the

Department presented on developments in the Electronic Content Management process, the After School Game Changer, women in sport, promotion of indigenous music initiatives and matters related to cultural councils.

Following its deliberations, the Committee excused the Department in order to finalise Committee resolutions.

3. Request for oral Submission

The Committee received a request for an oral submission by the Queen Itha Legal Colloquium. The request was furnished by Mr Marius Abrahams, on behalf of Mr Ras Bergwater. However the exact nature of the complaint was not fully detailed. The Committee agreed to first request a detailed written submission for its consideration before resolving on whether or not the request merits an oral submission.

4. Recommendations and requests

- 4.1 The Committee requested a written submission from the Queen Itha Legal Colloquium and to thereafter consider the merits of the submission.
- 4.2 The Committee requests the reasons for the increase in expenditure on consultants reflected in the Annual Performance Plan for 2019/20.
- 4.3 The Committee recommended that the Department of Cultural Affairs and Sport should accelerate the process of giving recognition to the cultural councils that meet the legal requirements.

5. Heritage Western Cape Shortlisting

The procedural officer informed the Committee that the Department of Cultural Affairs and Sport would shortly submit its list of applicants for membership to the new term of the Heritage Western Cape (HWC) council. Following receipt of the documentation, and a briefing by the Department on the HWC, the Committee is expected to deliberate on the allocations and submit a shortlist to the Provincial Minster of Cultural Affairs and Sport.

6. Committee Programme

The Committee discussed its Draft Committee Programme and provided agenda items to be considered.

The meeting was adjourned at 12:19.
