The Budget Committee, having considered the subject of the Division of Revenue Amendment Bill [B 15–2019] (S76) (NCOP) referred to the Committee in accordance with Standing Rule 217, recommends that the House confers on the Western Cape's delegation in the National Council of Provinces the authority not to support the Amendment Bill.
