#### 1. Mr D G Jacobs to ask Mr T A Simmers, Minister of Infrastructure:

(a) What are the details of all the projects that have been allocated to Communicare for social housing in the 2024/25 financial year, (b) how many of these projects have been finalised and (c) what are the reason or reasons why some projects have not been finalised?

#### 2. Mr B N Herron to ask Mr T A Simmers, Minister of Infrastructure:

With regard to the Forest Village Housing for Military Veterans Pilot Project and a certain person, whose details have been furnished to his Department for the purpose of the reply:

- (1) Why has the transfer of this military veteran house in the Forest Village Housing Project not been concluded;
- (2) whether the conveyancers who have been appointed to do the transfer received any payment of their fee for the transfer; if so, (a) why, (b) what will his Department do to resolve this unduly delayed transfer, (c) when does his Department expect transfer to be completed and (d) what steps will his Department take if transfer does not take place in the expected time period;
- (3) whether his Department has a policy, a standard operating procedure or an executive instruction with regard to when transfers and the handing over of titles of housing to beneficiaries should occur; if so, what are the relevant details;
- (4) (a)(i) what role do transfer and title play for beneficiaries in the delivery of public housing and (ii) what impact has this long-delayed transfer had on that role, (b)(i) how many houses in the Forest Village Housing Project were earmarked for military veteran housing and (ii) how many of these houses have still not been transferred to the beneficiaries and (c)(i) how many housing units have been completed

in the Forest Village Housing Project, (ii) how many of these houses have not yet been transferred to their owners or beneficiaries and (iii) what has been the cause of the delays?

- (2) whether his Department developed any provincial environmental health policies, guidelines, norms and standards that are applicable to water quality for recreational use in the province; if not, why not; if so, (a) what are the relevant details and (b) what steps have Environmental Health Services taken to ensure that the City of Cape Town implements or complies with those policies, guidelines, norms and standards;
- (3) (a) what standards are applicable for the testing of water quality for recreational use and (b) who (i) monitors, (ii) evaluates or (iii) audits these tests for compliance;
- (4) whether he will intervene if the water quality continues to be of concern or the presence of harmful bacteria or substances continues to be alleged or reported; if not, why not;
- (5) with regard to the media report of 3 March 2025 in IOL with the title "Near-death incident at Cape Town beach raises alarm over water quality", what is his Department's response to the alleged environmental health risks associated with the recreational use of sea water:
- (6) whether his Department has conducted any independent testing of the sea-water quality, given the conflicting reports; if not,
- (7) whether his Department has any plans to conduct one in the future; if not, why not; if so, what are the relevant details?

With reference to the Safety Plan launched in 2019 and the Memorandum of Understanding signed in August 2024:

- (1) Whether the Memorandum of Understanding (MOU) signed in August 2024 between the Western Cape Government, the City of Cape Town and the national government forms part of the Safety Plan; if so, (a) what is the total expenditure attributed to the MOU, (b) how does the MOU integrate with the agreement between the Western Cape Government and the City of Cape Town for the implementation of the Western Cape Safety Plan and (c) what is the difference between the MOU and the Safety Plan or the Safety Plan and the LEAP agreement;
- (2) with reference to a study on data-driven policing mentioned by him in his 2025 State of the Province Address that was overseen by the Institute for Security Studies, the Global Initiative and the Bavarian State, (a) what were the outcomes of this study,

- (b) what role did the Westen Cape Government play in the study and (c) what was the cost of the study;
- (3) whether the outcomes of the study have been implemented; if not, why not; if so, what are the relevant details;
- (4) (a) how many other studies have been conducted and (b)(i) what were the outcomes of these studies and (ii) will these outcomes be made available;
- (5) the Safer Western Cape Conference was hosted in 2018, what outcomes from that conference, if any, were used to inform the 2019 Safety Plan;
- (6) whether there are plans to host another conference; if not, why not; if so, what are the relevant details?

- (3) whether the Western Cape Government recognises and respects the national government's commitment to the One-China Policy; if so, what measure are in place to ensure that provincial officials align themselves with this policy;
- (4) whether the Western Cape Government currently has any formal trade relations with Taiwan; if not, why not; if so, (a) what are the details of the (i) engagements, (ii) agreements and (iii) trade volumes and (b) what economic impact assessments have been conducted;

(5) what is the (a) total value and (b) breakdown of the trade between the province and China for (i) imports and (ii) exports since 2020?

- (2) what are the provincial government's plans to expand (a) broadband infrastructure to connect rural areas and boost economic activity and (b) the Black Industrialist Programme to integrate marginalised groups into the industrial economy;
- (3) what are the provincial government's plans to strengthen income support, particularly to ensure that all employees in the Western Cape earn the stipulated national minimum wage?

(a) How many infrastructure projects in the Department are currently in progress by (i) type, (ii) expected completion date and (iii) location, (b)(i) how many infrastructure projects were abandoned before completion in the (aa) 2022/23, (bb) 2023/24 and (cc) 2024/25 financial years and (ii) what was the value of those projects and (c)(i) what delays are affecting the completion of infrastructure projects and (ii) what are the actions that the Department is taking to prevent delays in the delivery of infrastructure projects?
