THURSDAY, 1 JUNE 2023

1. The House met at 14:15.
2. The Speaker took the Chair and read the prayer.
3. [14:16] The Speaker requested Hon Members to remain standing and to observe a moment of silence in memory of the schoolchildren who tragically lost their lives in a motor vehicle crash on Tuesday, 30 May 2023. Our thoughts and prayers are with their families and loved ones.
4. [14:17] The Hon Member Dugmore, on a point of order, raised his concerns about the inconsistency when a moment of silence is allowed in the House.
5. [14:18] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.
6. [14:20] The Chief Whip moved without notice: That, notwithstanding the provisions of Rule 20(1), precedence be given to the Motion as printed in the name of hon C Murray and the Subject for Discussion.

Agreed to.

7. [14:21] Motion

Ms C Murray moved: That the House, as the representatives of 7,2 million people in the Western Cape, one of South Africa's 9 provinces, notes the economic development and job creation that the African Growth and Opportunities Act (AGOA) provides the Western Cape through preferential access to the USA market for many of our exporters; notes that, despite the Western Cape having the lowest unemployment rate in the country with a 25,9% expanded unemployment rate for the first quarter of 2023, unemployment remains a challenge in the province; recognises the role AGOA plays in creating jobs where they are needed the most; recognises that South Africa has benefitted tremendously from this Act through increased exports to the world's biggest consumer market, the USA; notes that the ANC's foreign policy, through their support of Russia's invasion of Ukraine, is putting South Africa's inclusion in any renewal of AGOA at risk; and notes that trade is a concurrent area of national and provincial legislative competence in accordance with the Constitution, Schedule 4, Part A.

Therefore, that this House resolves to reaffirm the USA and the Western Cape's friendship and important economic and trade ties; supports the renewal of AGOA in 2025; calls on the President to take urgent diplomatic action by engaging with the United States on ensuring SA's inclusion in AGOA once again; calls on the Minister of the Department of Trade, Industry and Competition to support trade relations on behalf of the Western Cape in making every effort to negotiate in good faith for the renewal of AGOA; and emphasises strong bilateral ties with the US and commits to strengthening these ties.

Debate concluded.

Question put: That the motion moved by the Hon Member C Murray be adopted.

Question agreed to.

Motion agreed to. (ANC Dissenting).

14. Mr G Bosman moved without notice: That the House congratulates the athletes who were selected for the Proteas team that will be representing South Africa at the Netball World Cup in July this year.

Agreed to.

15. Mr F C Christians moved without notice: That the House applauds teenage sisters Cleo and Amy Adriaan of Bishop Lavis; notes that the sisters, 17 and 14 years respectively, will present their talent at an international robotics competition in America in July of this year; notes that they are part of Team Syre, the robotics team at Goodwood College; notes that Byron Lukas of the *Daily Voice* wrote in the 24 May edition that the sisters had success in the national competition that was held in Johannesburg in February month; notes that the two sisters build and programme robots from scratch; notes that, for the national competition, they designed, built and programmed their robot called "Shrek"; notes that Shrek is programmed to fetch and bring items; notes that their proud parents, Josh and Yolanda, say their daughters spend day and night with their books and at the robotics laboratory; notes that the sisters are excited to make the trip to the USA: Cleo says, "This will be one of my highlights for my matric year, but I would love to go sightseeing and see how things work in the first tech challenge because it is different to what it is here in SA.";

notes that the sisters need funding of R100 000 to make the trip and the family is busy with fundraising to meet this target; and wishes Cleo and Amy well in the coming competition.

16. Mr M Kama moved without notice: That the House notes with pride and congratulates sisters Cleo Adriaan (17) and Amy Adriaan (14) from Bishop Lavis who have been invited to showcase their talents at an international robotics competition in the USA; notes that they have a talent of building and programming prototype robots from scratch; notes that their latest design that got this spot in the competition is a robot named Shrek that can fetch and bring things; and wishes the teens all success with the competition because they will be representing the country. Halala mantombazana halala.

17. Ms P Z Lekker moved without notice: That the House notes with deep shock and sadness the passing away of Comrade Mithrasagaran “Murthie” Naidoo; notes that Murthie was a political activist, political prisoner, banned person, Communist Party member and member of the Parents of Detainees Committee (an organisation set up to assist political detainees during apartheid); notes that he was first detained in 1965 on his way to visit his brother Indres Naidoo who was imprisoned on Robben Island for sabotage; notes that he was arrested at the airport in Cape Town and was held overnight in a dark, filthy cell in Roeland Street Prison; notes that the loss of such an eminent liberation fighter should move us to cherish, defend and sustain the freedoms and opportunities we enjoy today in a free South Africa; and sends heartfelt condolences to the family and friends of this struggle stalwart. Hamba kahle Mkhonto.

18. Ms A P Bans moved without notice: That the House notes and congratulates the SA Operational Task Team of Crime Intelligence, Home Affairs, International Relations, Interpol, the NPA and the Hawks (DPCI) for the arrest of Rwandan’s fugitive, Fulgence Kayishema, who was on the run since 1994; notes that Kayishema is alleged to have orchestrated the killing of 2 000 women, men and children at a church in Rwanda during the 1994 genocide; notes that he has been living in Paarl under a false identity of Donatien Nibashumba; and congratulates the team for the stellar work of arresting such criminals.

19. Mr D America moved without notice: That the House expresses profound sorrow and grief at the tragic loss of five innocent children who tragically lost their lives in a devastating car crash in Mitchells Plain while on their way to school, as well as the young 12-year-old girl who was fatally hit by a car in Heideveld; notes that the knowledge that these precious lives could have been saved, makes these tragedies even more heart-wrenching; deeply mourns the untimely deaths of these young souls and stand in solidarity with the grieving families who have been robbed of their beloved children; offers our heartfelt support during this unimaginably difficult time; calls for collective efforts to strengthen the fight against the use of illegal school transportation vehicles; notes that it is imperative that we take decisive measures to prevent further tragedies and to ensure the safety of all children commuting to school; urges that those found responsible for operating illegal school transport vehicles be prosecuted to the fullest extent of the law; and notes that holding these individuals accountable will serve as a deterrent and will send a strong message that such reckless actions will not be tolerated.

20. Ms W F Kaizer-Philander moved without notice: That the House notes that today, 1 June, marks the annual celebration of World Milk Day; notes that World Milk Day was established by the Food and Agriculture Organisation of the United Nations in 2021 in recognition of the importance of milk as a global food; notes that the day is also a celebration of the dairy sector; pays special tribute to our dairy sector here in the Western Cape and recognises that our province is home to more than 30% of the milk producers in South Africa; and notes that the sector is a billion-rand industry and a vital contributor to our agriculture economy.

21. Ms N G Bakubaku-Vos moved without notice: That the House notes the funding challenges faced by child-protection-service organisations in the Western Cape; notes that, as the country commemorates Child Protection Week, Western Cape' NGOs find themselves in a hopeless place, as the subsidies received by them from the provincial Department of Social Development amount to a mere 42%, while they have to carry the burden of child-protection services heavily on their backs; notes that, as seen in the media reports, Children's Institute senior researcher Lucy Jamieson said, "In the Western Cape, NGOs render 55% of all child-protection services but they are required, by law and service level agreements, to deliver the same standards of care as the government for a fraction of the cost."; notes that, not only are these NGOs unable to deliver basic child services, they have to let go of staff because of budget constraints; and urges and demands that Sharna Fernandez, Minister of Social Development, and her department take a stand and do what is right to protect the children of the Western Cape.

Agreed to.

22. Ms R Windvogel moved without notice: That the House notes with shock the rising violent crimes and murders in Swellendam, which is becoming a serious concern in the community as the people are not feeling safe; further notes that Leaton September, an innocent young man, fell victim to these crimes as he was brutally murdered in Suurbraak, and sadly became one of the many statistics among the young people killing each other in Swellendam; laments the ongoing murders of young people by other young people that is becoming a norm in Swellendam while the Western Cape Premier does not seem to care about the plight of victims of crime in rural areas as his so-called Safety

Plan does not provide for the deployment of LEAP officers outside of the metropolitan area; and calls for the expansion of Winde's plan to cater also for areas outside of the metropolitan area so that victims of crime in areas such as Swellendam can also feel safe.

Agreed to.

23. Ms R Windvogel moved without notice: That the House notes and welcomes the visit by ANC MPPs to the Vanguard Day Hospital in Bonteheuwel on Monday where they saw for themselves a number of serious challenges hampering service delivery in the facility; further notes that many challenges at the facility were caused by the delays in the filling of critical posts, such as the facility manager, which was only filled in January this year; notes that, while many other vacancies have been filled, calls on the provincial government to prioritise the filling of the help desk as well as the clerk vacancies; further notes that as the ANC we are extremely concerned about the administration system at the hospital, which by management's own admission is a bit of a mess as patients' folders were lying in the passage behind the pharmacy, and even in the pharmacy area folders were disorganised, and as a result of this the hospital has a big challenge with duplicate folders with some missing important patient history; acknowledges that the challenges of the hospital, including long waiting hours at the facility, is the result of this poor filing system, which is as a result of delays by the provincial government to complete the very important infrastructure development at the facility, which would include building a bigger and effective reception area; accepts that the poor services and the challenges at the hospital should be blamed partly on the DA government and not on the management, which is doing a good job under the circumstances; and calls on the provincial government to accelerate the infrastructure development at the hospital and calls on the Standing Committee to go on an official visit to the hospital soon.

3. [14:16] Die Speaker versoek agbare Lede om te bly staan en 'n oomblik van stilte te handhaaf ter nagedagtenis aan die skoolkinders wat op Dinsdag, 30 Mei 2023, hul lewens tragies in 'n motorvoertuigbotsing verloor het. Hul families en geliefdes is in ons gedagtes en gebede.
4. [14:17] Die agb Lid Dugmore, op 'n punt van orde, spreek sy kommer uit oor die inkonsekwentheid wanneer 'n oomblik van stilte in die Huis toegelaat word.
5. [14:18] Die Speaker doen 'n algemene aankondiging met betrekking tot die sitting van die Wes-Kaapse Provinsiale Parlement in ooreenstemming met Reël 1A van die Staande Reëls van toepassing op Lede wat op afstand teenwoordig is met behulp van elektroniese middele.
6. [14:20] Die Hoofswep stel sonder kennisgewing voor: Dat, ondanks die bepalings van Reël 20(1), die Voorstel soos gedruk in die naam van agb lid C Murray en die Onderwerp vir bespreking voorrang het.

7. [14:21] Voorstel

Me C Murray: Dat die Huis, as die verteenwoordiger van 7,2 miljoen mense in die Wes-Kaap, een van Suid-Afrika se nege provinsies, kennis neem van die ekonomiese ontwikkeling en werkskepping wat die Wet op Groei en Geleenthede in Afrika (AGOA) aan die Wes-Kaap bied deur voorkeursoortoegang vir baie van ons uitvoerders tot die VSA-mark; kennis neem dat, ten spyte van die Wes-Kaap wat die laagste werkloosheidsyfer in die land het met 'n 25,9%- uitgebreide werkloosheidskoers vir die eerste kwartaal van 2023, werkloosheid 'n uitdaging in die provinsie bly; erkenning gee aan die rol wat AGOA speel om werk te skep waar dit die nodigste is; erkenning gee dat Suid-Afrika geweldig by hierdie wet baat gevind het deur verhoogde uitvoere na die wêreld se grootste verbruikersmark, die VSA; kennis neem dat die ANC se buitelandse beleid, deur hul ondersteuning van Rusland se inval in Oekraïne, Suid-Afrika se insluiting by enige hernuwing van AGOA in gevaar stel; en kennis neem dat handel 'n konkurrente gebied van

nasionale en provinsiale wetgewende bevoegdheid is in ooreenstemming met die Grondwet, Bylae 4, Deel A.

Daarom, dat hierdie Huis besluit om die VSA en die Wes-Kaap se vriendskap en belangrike ekonomiese en handelsbande te herbevestig; die hernuwing van AGOA in 2025 ondersteun; 'n beroep op die President doen om dringende diplomatieke stappe te doen deur met die Verenigde State in gesprek te tree om SA se insluiting by AGOA weer te verseker; 'n beroep op die Minister van die Departement van Handel, Nywerheid en Mededinging doen om handelsbetrekkinge namens die Wes-Kaap te ondersteun deur elke poging aan te wend om in goeder trou vir die hernuwing van AGOA te onderhandel; en sterk bilaterale bande met die VSA beklemtoon en hom verbind tot die versterking van hierdie bande.

Mnr D America stel sonder kennisgewing voor: Dat die Huis diepe meegvoel en hartseer uitspreek oor die tragiese verlies van vyf onskuldige kinders wat hul lewens tragies in 'n vernietigende motorbotsing in Mitchells Plain verloor het terwyl hulle op pad skool toe was, asook die jong 12-jarige meisie wat noodlottig deur 'n motor in Heideveld getref is; kennis neem dat die wete dat hierdie kosbare lewens gered kon word, hierdie tragedies nog meer hartverskeurend maak; diep treur oor die ontydige dood van hierdie jong siele en in solidariteit saamstaan met die bedroefde gesinne wat van hul geliefde kinders beroof is; ons opregte ondersteuning aanbied gedurende hierdie uiters moeilike tyd; 'n beroep doen vir kollektiewe pogings om die stryd teen die gebruik van onwettige skoolvervoertuie te versterk; kennis neem dat dit noodsaaklik is dat ons beslissende maatreëls tref om verdere tragedies te voorkom en om die veiligheid van alle kinders wat skool toe pendel, te verseker; daarop aandrang dat diegene wat vir die bestuur van onwettige skoolvervoertuie verantwoordelik is, tot die letter van die wet vervolg moet word; en kennis neem dat, deur hierdie individue verantwoordingspligtig te hou, dit 'n afskrikmiddel sal wees en 'n duidelike boodskap sal uitstuur dat sulke roekelose optrede nie geduld sal word nie.

Me W F Kaizer-Philander stel sonder kennisgewing voor: Dat die Huis kennis neem dat vandag, 1 Junie, die jaarlikse viering van Wêreldmelkdag is; kennis neem dat Wêreldmelkdag in 2021 deur die Voedsel-en-landbou-organisasie van die Verenigde Nasies ingestel is uit erkenning van die belangrikheid van melk as 'n wêreldwye voedselbron; kennis neem dat die dag ook 'n viering van die suiwelsektor is; spesiale hulde bring aan ons suiwelsektor hier in die Wes-Kaap en daaraan erkenning gee dat ons provinsie die tuiste van meer as 30% van die melkprodusente in Suid-Afrika is; en kennis neem dat die sektor 'n miljardrandbedryf is en 'n noodsaaklike bydraer tot ons landbou-ekonomie is.

Me N G Bakubaku-Vos stel sonder kennisgewing voor: Dat die Huis kennis neem van die befondsingsuitdagings wat kinderbeskermingsdiensorganisasies in die Wes-Kaap in die gesig staar; kennis neem dat, terwyl die land Kinderbeskermingsweek herdenk, Wes-Kaapse NRO's hulself in 'n hopelose situasie bevind, aangesien die subsidies wat hulle van die provinsiale Departement van Maatskaplike Ontwikkeling ontvang, 'n skamele 42% beloop, terwyl hulle die swaar las van kinderbeskermingsdienste moet dra; kennis neem dat, soos blyk uit mediaberigte, 'n senior navorsers van die Kinderinstituut, Lucy Jamieson, gesê het: "In die Wes-Kaap lewer NRO's 55% van alle kinderbeskermingsdienste, maar hulle word volgens wet en diensvlakooreenkomste verplig om dieselfde standaard ten opsigte van sorg te lewer as die regering vir 'n fraksie van die koste."; kennis neem dat hierdie NRO's nie net nie in staat is om basiese kinderdienste te lewer nie, maar dat hulle personeel weens begrotingsbeperkings moet afdank; en Sharna Fernandez, Minister van Maatskaplike Ontwikkeling, aanmoedig en eis dat en haar departement standpunt moet inneem en moet doen wat reg is om die kinders van die Wes-Kaap te beskerm.

Me R Windvogel stel sonder kennisgewing voor: Dat die Huis met skok kennis neem van die toenemende gevalle van geweldsmisdad en moorde in Swellendam, wat 'n ernstige kommernis vir die gemeenskap word aangesien mense nie meer veilig voel nie; kennis neem dat Leaton September, 'n onskuldige jongman, die slagoffer van hierdie misdade

geword het nadat hy wreed in Suurbraak vermoor is, en ongelukkig deel van die groeiende statistiek geword het van jongmense wat mekaar in Swellendam vermoor; die voortgesette moorde van jongmense deur ander jongmense betreur wat die norm in Swellendam geword het terwyl die Wes-Kaapse Premier blykbaar nie omgee vir die lot van slagoffers van misdaad in landelike gebiede nie, aangesien sy sogenaamde Veiligheidsplan nie voorsiening maak vir die ontplooiing van LEAP-beamptes buite die metropolitaanse gebied nie; en 'n beroep op die uitbreiding van Winde se plan doen om ook voorsiening te maak vir gebiede buite die metropolitaanse gebied sodat slagoffers van misdaad in gebiede soos Swellendam ook veilig kan voel.
