12. Ms P Z Lekker moved without notice: That the House notes with profound sadness the passing away of the ANC MP and former Minister, Tina Joemat-Pettersson, who died at her home in Cape Town on Monday 5 June 2023; notes that Joemat-Pettersson was a member of the ANC's National Executive Committee and the Chairperson of the Police Portfolio Committee, and previously served as Minister of Agriculture, Forestry and Fisheries and Minister of Energy, as well as Education MEC in the Northern Cape; further notes that she was also a stalwart of the ANC women's league and liberation struggle; and extends condolences and sends a message of strength to her family and friends.

13. Mr L L Mvimbi moved without notice: That the House notes with deep shock and sadness the brutal murder of an ANC member of Drakenstein's ward 12, and Chairperson of the taxi association Codeta, Siyabulela Mandyoli; notes that Mandyoli was shot dead in front of his house in the Mbekweni area on Tuesday afternoon, 6 June 2023; notes that he served as both the Deputy Chairperson and Chairperson of the Bulelani Mangena branch; notes that he was also a Sanco and Congress of Democratic Taxi Associations (Codeta) Chairperson; notes that Mandyoli was a significant figure in the discussions that resulted in the reopening of the B97 route and that he was instrumental in securing the peaceful cohabitation between the two opposing taxi associations (Cata and Codeta) operating in Mbekweni; and sends heartfelt condolences to his family, friends and colleagues.

Mr M K Sayed moved without notice: That the House notes with deep shock and sadness the passing of a 20-year-old female student who was stabbed to death by a male student on Tuesday 6 June 2023 at the Nelson Mandela University, George Campus; and sends deepest and most heartfelt condolences to the family and friends of the deceased student.

Mr M Kama moved without notice: That the House notes the passing away of Mark Mausenbaum, affectionately known as "Coach Mouse"; notes that he was one of the founding members of the Milnerton Surf Lifesaving Club; notes that, when he joined the club in 2010, he touched many hearts in the broader lifesaving community; notes that his enthusiasm for the lifesaving movement has helped to nurture the lifesaving club that exists today; notes that Mausenbaum touched every corner of life at the club over the past 13 years in his many roles as nipper coach, chairman, club captain, barman, gear steward, cameraman, but mostly as a friend; and sends deepest condolences to his family and friends.

Ms W F Kaizer-Philander moved without notice: That the House notes with profound sadness the passing away of Marlene van Staden on Thursday 8 June 2023; notes that, at the time of her death, Marlene was serving as the Mayor of the Modimolle-Mookgophong Local Municipality and was the Democratic Alliance's first mayor in the province of Limpopo; notes that Marlene was a force for good in her municipality and served the communities of her town with grace and dignity; notes that she was a formidable female leader, not only in her party, but also in government; notes that Marlene fought various obstacles to bring good governance to Modimolle-Mookgophong; notes that her dedicated, optimistic and committed leadership should serve as an example to all those who serve in government across South Africa; sends our thoughts and prayers to the family, loved ones and colleagues of Marlene; expresses deep grateful for her dedicated civil service and her exemplary leadership; and may you rest in eternal peace, Marlene.

Mr C Fry moved without notice: That the House notes with sadness the passing away of the legendary former Bafana Bafana coach Clive Barker on Saturday 10 June 2023 at the age of 78; notes that he will be laid to rest on 15 June 2023 and sends its heartfelt thoughts and prayers to his family, loved ones and the South African football fraternity; honours Clive's dedicated service to his country; notes that he was a courageous figure who defied the apartheid regime in order to develop the game of football in black townships and it is precisely this unmatched commitment to the sport and passion to overcome deeply rooted divisions that left an indelible mark on the hearts of many South Africans; notes that, during a time of much tribulation and division, Clive led the South African men's football team to victory at the African Cup of Nations in 1996 on home soil and was a key figure in bringing pride and cohesion to our country during that delicate period; honours Clive as a truly great South African who inspired a nation and has left an indomitable legacy; notes that his famous "flying bird" celebration will forever be imprinted on the hearts and memories of South African football lovers across the nation; and bids Clive farewell and thanks him for his service.
