11. Ms D M Baartman moved without notice: That the House congratulates the learners from the Schoonspruit Secondary School, a focus school for the arts in Malmesbury, who kicked off the first phase of the Swartland Municipality's mural project to raise awareness of gender-based violence, femicide and violence against children; notes that this initiative will not only create awareness, but will also serve to educate and inform the community about the scourge of violence against women and children; further notes that additional schools and artists from the area will participate in the project, supported by the Swartland Municipality and the Western Cape Department of Education; and notes that the young learners and artists from the community have been empowered to utilise their skills for the education of others and the upliftment of vulnerable groups.

12. Mr G Bosman moved without notice: That the House sends its most sincere condolences to the friends and family of coach Mike Lukhubene who was tragically killed on Sunday 11 June 2023; notes that it is very unsettling that this incident occurred at a place of entertainment outside the Site C sports grounds in Khayelitsha; and notes that, while we encourage children and adults to be involved in sports and outdoor recreational activities, incidents like these prevent people from enjoying such events in their own communities.

13. Mr I Sileku moved without notice: That the House commends the unwavering dedication and tireless efforts of numerous disaster management teams across the province that are working ceaselessly around the clock to avert any loss of life amidst the ongoing flooding; and, furthermore, extends its commendation to these teams for their relentless work in promptly clearing roads, once deemed safe, to ensure a smooth passage.

14. Ms D M Baartman moved without notice: That the House congratulates the Rustenburg Girls' High School (RGHS) for its inclusion on T4 Education's shortlist of the 10 best schools in the world in the category of "Supporting Healthy Lives"; notes that this represents recognition of the inclusive and holistic approach to education employed by RGHS, which seeks to balance academics, sport and cultural activities; notes that this achievement represents the culmination of RGHS's continuous embracement of excellence; and wishes the staff and learners of the school well as they compete for the honour of best school in the world.

Ms A P Bans moved without notice: That the House notes the brutal murder of the former manager of Chippa United, Mike Lukhubene; notes that Mike Lukhubene was gunned down along with another individual after a football match between Hot Spurs and Tottenham Hotspur FC in Khayelitsha, Cape Town, on Sunday 11 June; notes that Lukhubene coached Chippa United and Royal AM previously and was coaching an amateur team at the time of his death; notes that South African football has lost another much-loved coach; and sends its heartfelt condolences to his family, friends and colleagues.

Mr M K Sayed moved without notice: That the House congratulates Akili (Kiki) Molele, who is in Grade 7 and who passed her audition to be part of a chorus of 24 children for the Cape Town Opera's upcoming production of Tosca; notes that over 100 children from across the city between the ages of 9 and 15 queued for the audition; and notes that Kiki is a member of the Senior Choir, KATS, and is busy preparing to sing solos at the Tygerberg Eisteddfod.

Mr M Kama moved without notice: That the House notes and congratulates Tete Dijana (35) and Gerda Steyn (33) who claimed victory in the record-breaking Comrades Marathon that took place on 11 June; notes that Gerda Steyn set the Comrades Marathon down-run record with a time of 5:44:54 to become the fourth woman to run under six hours for that race; and Tete Dijana claimed the men's title by running in a record time of 05:14:30.

Mr M Kama moved without notice: That the House notes with sadness the passing away of former Bafana Bafana head coach, Clive Barker, at the age of 78; notes that Barker was renowned for leading South Africa to victory in the Africa Cup of Nations in 1996; notes that, throughout his remarkable 42-year coaching career, Barker mentored various teams, including AmaZulu, Manning Rangers, Durban City, Durban Bush Bucks, Santos Cape Town, Wits and Maritzburg United where he concluded his coaching journey in 2016; notes that he guided Durban City to consecutive league titles in 1982 and 1983, as well as leading Durban Bush Bucks to victory in 1985; and extends its heartfelt condolences to his family and friends.

19. Ms R Windvogel moved without notice: That the House notes with deep sadness the passing away of Jamahi David Scheepers from 42 Marray Street, Swellendam, who died on 9 June due to excessive smoke inhalation; and conveys sincere condolences to the Scheepers family.

20. Ms R Windvogel moved without notice: That the House notes and conveys sincere condolences to the Santsaba family after the passing away of their infant son in Petunia Street, Swellendam, due to cot death.

Ms P Z Lekker moved without notice: That the House notes the brutal murder of Ntsikelelo Konisani from 3752 Block 7, Lower Crossroads, in Philippi East; notes that he was killed on Wednesday 14 June in a hail of bullets on suspicion of extortion; notes that Konisani was a young and upcoming businessperson and community developer; and conveys heartfelt condolences to his parents, wife, children and the community of Lower Crossroads.

Ms P Z Lekker moved without notice: That the House notes the concerning trends reflected in the latest crime statistics for Brackenfell; notes that, while it is encouraging to note the low incidence of violent crime, we express deep concern over the rise in common robbery, business burglary, car theft and theft from cars; notes that these offenses pose a significant threat to the safety, security and economic well-being of our community; and calls on the provincial government to work with law enforcement agencies, local authorities and community organisations to collaborate and implement targeted strategies to combat these specific crimes to ensure the protection of our residents, businesses and vehicles.

Ms P Z Lekker moved without notice: That the House notes the concerning rise in the number of small business owners fearing a potential turf war between extortion gangs in Cape Town; notes that this alarming situation poses a significant threat to the safety, security and livelihoods of these hardworking individuals and their communities; calls on law enforcement agencies and local authorities to prioritise the protection of small business owners and their businesses by implementing proactive measures to prevent criminal activities, by dismantling extortion networks and by ensuring the safety of all residents; and notes that, by taking decisive action, we can create an environment where all business owners can operate without fear and can contribute to the prosperity and diversity of Cape Town.
