2. The Speaker took the Chair and read the prayer.
3. [14:17] The Speaker made a general announcement regarding the sitting of the Western Cape Provincial Parliament in accordance with Rule 1A of the Standing Rules pertaining to Members in remote attendance by electronic means.

12. Mr A P van der Westhuizen moved without notice: That the House notes of the challenges and risks to which farm workers are exposed when they are transported in inappropriate vehicles; further notes that the risks of inappropriate transport were once again illustrated by the incident a week ago where a 24-year-old farm worker from Citrusdal tragically died when he fell from a wagon being pulled by a tractor; and calls on employers and especially the drivers of vehicles that transport people to be aware of the risks and to take the necessary steps to improve workers' safety.

13. Mr G Bosman moved without notice: That the House sends its sincere condolences to the friends and family of Loedfie Hendricks; notes that Mr Hendricks was a Collegians Rugby Football Club stalwart and decades-long government communications officer; notes that he unfortunately passed away on 12 August at the age of 64 after a long period of ill health; and further notes that he will not only be missed by the entire Lentegleur community, but by many throughout the City of Cape Town.

Agreed to.

14. Mr G Bosman moved without notice: That the House congratulates both the Western Cape Government and the City of Cape Town after the inaugural Cape Town E-prix race was named race of the year; notes that the public vote was very convincing, and the Western Cape alongside the City of Cape Town have proven themselves to be a world-class location for many more international events to come; further notes this successful event played a massive role in nation building and economic growth; and looks forward to the potential future events.

15. Ms L M Maseko moved without notice: That the House congratulates and thanks the Grassroots ECD Training Centre for their work in changing women's and children's lives in the Western Cape; notes that the Grassroots Educare Trust is a partner non-profit organisation of the Department of Infrastructure's Expanded Public Works Programme; notes that, as the oldest early childhood development facility in South Africa, the Grassroots Educare Trust manages and supports 200 unemployed youth and 160 parents through the EPWP; further notes that the Grassroots facility supports approximately 2 200 partial care facilities, with the majority of these being in rural areas; and notes that it is heartwarming to see the impact of these EPWP partnerships and the impact they have on our citizens.

16. Mr M Kama moved without notice: That the House notes and congratulates Nande Mabala, from Zwelethemba, Worcester, who was crowned second princess in the Miss South Africa competition on Sunday; notes that Mabala spent part of her childhood growing up in Zwelethemba, about 6 km outside Worcester; notes that Mabala received her crown after entering the competition for the second time as she did not make the selection in 2020; and notes that this is quite an accomplishment and that she has brought honour and pride not only to herself but to the entire community of the town.

17. Mr M K Sayed moved without notice: That the House notes and congratulates the Knysna Municipality and its leadership under Mayor Aubrey Tsengwa after the town was voted the best "dorpie" in the province; notes that the town was nominated when the competition began in mid-July and received the most public votes in its category; notes that, aside from being named the Best Dorpie in Kfm's Best of the Cape Awards, Knysna was listed as the 19th Most Loved Destination Around the World on the 2021 Tourism Sentiment Index, as it is known for its stunning natural beauty, indigenous forests and scenic coastline; and notes that it is a popular tourist destination, especially for its lagoon, beaches and outdoor activities.

Ms A P Bans moved without notice: That the House notes with deep sadness the passing away of Yoleka Xokashe (23) from Lower Crossroads, Cape Town; notes that it is alleged that Yoleka was brutally killed by her boyfriend; notes that she was found with multiple wounds at his home; and sends heartfelt condolences to her family and friends.

19. Ms A P Bans moved without notice: That the House notes with sadness the passing away of Leezandre Taaibosch (31) from Wesbank, Kuils River; notes that she was brutally killed on 1 August 2023 by her ex-boyfriend because she decided to end the toxic relationship; and sends heartfelt condolences to her family and friends.

20. Ms A P Bans moved without notice: That the House notes the passing away of Aboobakr du Preez (24); notes that Aboobakr left home on Sunday night shortly after 19:00 to attend Isha prayers when he came under attack; notes that he was walking along Ryston Road to Masjidur Rahmaan where he went every day for prayers; and extends its condolences and sends a message of strength to his family and friends.

21. Mr M K Sayed moved without notice: That the House notes the passing away of Johaar Mosaval, a trailblazing talent born in District Six, whose legacy transcends the boundaries of the arts; notes that, as we remember his life, we commend his groundbreaking accomplishment as the first black South African Senior Principal Dancer at the esteemed Royal Ballet in London; notes that this pinnacle of achievement not only showcased his exceptional skill, but shattered barriers in one of the world's most prestigious ballet companies; notes that Mosaval's ascent to the highest rank in his profession stands as an enduring testament to the power of talent, determination and the capacity for change; and, in his memory, let us recommit ourselves to fostering inclusivity and embracing the richness that diversity brings to the arts and our global community.

22. Mr F C Christians moved without notice: That the House conveys its condolences with the family and friends of the late Talia Morris (17) of Hanover Park; sympathises with her loved ones at her senseless killing; notes that the *Son* newspaper (Clyde Adams-Vister, 10 August 2023) reported that she was caught in the crossfire between rival gangs on Friday 4 August 2023; notes that she tragically passed away on Saturday 5 August 2023; notes that Talia was a learner at the Mount View High School; notes that she was another victim of the needless violence that has become commonplace on the Cape Flats; notes that the community is shocked and saddened by her death; and notes that this is a community that lives in daily fear of their lives. Our prayers are with the family as we share in their grief during the time of their bereavement.

23. Ms A Cassiem moved without notice: That the House takes note that on Tuesday 22 August 2022 Khayelitsha residents marched to the branch of the Department of Home Affairs in Khayelitsha in order to voice their frustrations and concerns stemming from poor service delivery; notes that the concerns raised by the community involve the manner in which they are mistreated by staff at that branch who also appear incompetent; further notes the majority of the incidents at the branch involves a lack of respect for the members of society, the erroneous capturing of their details on their IDs resulting in invalid IDs being issued and they remain useless as the recipients cannot use them to

open bank accounts, apply for work opportunities or even study opportunities; and calls on the national Minister of Home Affairs to intervene in the matter and to make sure that the community receives better services.

24. Ms A Cassiem moved without notice: That the House notes that the South African Women's Cricket Team took a great step yesterday with the launch of the Professional Domestic Women's League, which was launch at Freedom Park in Tshwane; notes that the league will feature two main tournaments, including the Cricket South Africa One-day Cup and the Cricket South Africa Women's T20 Challenge; further notes that this is a great feat taking place during Women's Month and we can only hope that this is the beginning of good things to come, especially with the inclusion and participation of women in sport; and calls for the establishment of a professional women's football league in the country following the great feat achieved by the South African women football team, Banyana Banyana, at the Women's World Cup recently held in Australia and New Zealand.

25. Ms L M Maseko moved without notice: That the House notes the handing over of keys to beneficiaries at the Our Pride Housing Project in Eerste Rivier; notes that the Our Pride Housing Project is part of the First Home Finance Programme that has delivered 218 housing units; notes that two housing units will be for Breaking New Ground, the remainder being FLISP; notes that the R102 million project was geared towards making affordable housing more accessible to all citizens; and further notes that the Western Cape remains the leading province in the delivery of affordable housing programmes.

Mr F C Christians moved without notice: That the House notes with concern that bullying is starting at an early age at our schools; notes an article by Ntuthuzelo Nene on 11 May 2023 in EWN about an 8-year-old Grade 3 learner who was cut by a Grade 3 learner, both being learners of the Stephan Road Primary School in Lotus River and in the same class; notes that this was a potentially fatal attack on the learner, who by the grace of God survived the attack; notes that this attack shows that bullying is rearing its ugly head among our learners at a young age; and advises that the WCED continues to be diligent and to offer proactive programmes that will stop this kind of delinquent behaviour.

27. Mr M K Sayed moved without notice: That the House welcomes the decisive action taken by the national Department of Basic Education in enforcing anti-bullying laws in our nation's schools; notes that this vital step demonstrates our commitment to creating safe and nurturing environments where our learners can learn and thrive; notes that, by implementing these measures, we not only protect our children from the harmful effects of bullying, but also foster a culture of respect, empathy and inclusivity; joins in unity to support this initiative, ensuring that every child's right to a safe and conducive educational experience is upheld; and reaffirms together our dedication to the well-being and future of our nation's youth.

28. Mr P Marran moved without notice: That the House calls for a thorough inquiry into the allocation of R161 million by the provincial Department of Infrastructure for human settlements in the Western Cape; notes that this substantial expenditure, ostensibly aimed at countering the extortion tactics of the construction mafia and combating the illegal occupation of vacant land and homes under construction, warrants careful scrutiny; notes that, in the interests of transparency and effective resource utilisation, we must assess the strategies employed, evaluate their impact and ensure that public funds are optimally utilised to safeguard our communities and to promote lawful development; and upholds our duty to the public by seeking accountability and constructive solutions to these pressing concerns.
