MATTER OF PUBLIC IMPORTANCE (in accordance with Standing Rule 143)

Mr B Herron: The impact of the national fiscal emergency on post provisioning in the Western Cape Education Department.

FURTHER BUSINESS

NOTICES OF MOTION (12 September 2024)

1. Mr B Ngqentsu: That the House debates the efficiency and effectiveness of the Western Cape's Safety Plan in addressing crime in the province.
2. Ms R Windvogel: That the House debates the state of public healthcare in the province.
3. Ms N D Nkondlo: That the House debates the provincial government's programmes to address poverty and unemployment that are affecting the black majority in the province.

4. Ms R Windvogel: That the House debates the challenges related to health infrastructure and the significant delays in key infrastructure development projects, as well as the provincial government's plans to address these issues.
5. Mr G Brinkhuis: That the House debates the negative impact that the retrenchment of teachers will have on children's right to education, and the proposed cuts to teaching posts that poses a real threat to education.

NOTICES OF MOTION (5 September 2024)

1. Ms A Cassiem: That the House notes that on Friday 30 August 2024 about 80 security guards picketed outside the Groote Schuur Hospital over late salary payments by Gold Security Services, which is contracted to the Western Cape Department of Health and Wellness for the purposes of providing security services; notes that the security company only started providing services on 1 July 2024 and had promised workers that they will be paid on the 15th of each and every month, which has never happened; notes that it then became a norm that the company would pay the employees on any random day after the 15th without any explanation; and reiterates its call for the insourcing of all security guards, cleaners and other employees stationed and providing services in government department buildings and institutions across all levels of government.
2. Ms T Lithakong: That the House to notes that on Wednesday 4 September 2024 the police in the Eastern Cape shot and killed two men who were part of the extortion syndicate in Mthatha; notes that the shooting incident is reported to have been started by the extortionist gang, while the police retaliated thereafter; further notes that among those killed is Chief Sakhumuzi Dalinzolo who is said to have been the kingpin behind the recent extortions initiated against schools in Mthatha; notes that a similar incident also took place last week in this province where four men, alleged to have been part of the extortionist gang, were shot and killed by police in Milnerton, while four others remained wounded, after they also opened fire on the police, and they were shot back; concludes by stating that, while shootouts create a dangerous environment for communities, the police efforts must be embraced and welcomed; and hopes that extortionists will realise that crime does not pay and hopes that they will abandon their criminal campaign.
3. Ms P Z Lekker: That the House notes with grave concern the current challenges and tensions surrounding the relocation of informal farmers occupying state-owned land in Eerste River, as the planned relocation to areas that are already occupied has exacerbated community tensions and threatens the livelihoods of these farmers; further notes and acknowledges the profound impact this situation has had on the livelihoods of the informal farmers as the proposed relocation sites are not only inadequate in size to accommodate their livestock, but also cause further displacement of existing residents, adding to the community's overall strain; calls for the protection of the farmers' livelihoods by ensuring that any relocation plans makes provision for adequate space, proper facilities and the preservation of their agricultural activities, as it is crucial that the relocation does not adversely affect their ability to continue farming and supporting their families; further calls on the provincial government to end the tensions in the community by releasing a suitable and adequately sized parcel of land for the relocation of the these families that is also free from current occupation; and calls on the provincial government to facilitate a dialogue between all the affected parties to address their concerns and to prevent conflict.

4. Ms R Windvogel: That the House notes with deep concern the contentinous decision by this DA-led provincial government to cut 2 407 teaching posts effective January 2025, despite heightened broad-based opposition to this nonsensical decision; further notes and rejects this reckless decision as it has been made without adequate consideration of the severe consequences it will have on the quality of education in the province, particularly for learners in previously disadvantaged schools; further notes that reducing the number of teaching posts by over 2 400 will have a devastating impact on poor learners from previously disadvantaged schools that cannot afford to employ additional teachers through school governing bodies (SGBs), which will lead to even greater educational disparities, larger class sizes, decreased individual attention and overall diminished educational outcomes; calls on the WCED to reconsider its decision to cut teaching posts, and instead of reducing the number of teachers – the bedrock of our education system – the WCED should explore alternative cost-saving measures, such as cutting expenditures on less critical programmes, such as the Back-on-Track Programme and the School Evaluation Authority; urges the WCED to adopt a more equitable approach that protects the quality of education for all learners and addresses the specific needs of schools that serve economically disadvantaged communities, as it is essential that the WCED engages in meaningful consultation with teachers, parents and community stakeholders to ensure that any budgetary adjustments do not harm disproportionately those who are already at a disadvantage; and calls on all the progressive forces and education stakeholders, including activists and civic organisations, to unite in rejecting this move by the DA-led government.
5. Ms B Stoffel: That the House notes and welcomes the significant progress that has been made with the reopening of the central line, specifically the resumption of train services from the Nolungile train station in Site C to Cape Town; acknowledges that this development has significantly improved transportation options for residents by providing affordable and reliable travel at rates starting from R9, with further discounts available during off-peak times; commends the national Department of Transport and Prasa for their sterling work in reaching this stage of the central line's reopening; further notes and expresses concern that the devolution of rail or its privatisation, as proposed by some in the House, could undermine the quality of service and could lead to increased fares, and rejects these reckless calls; and reaffirms support for maintaining rail services under national oversight, thus ensuring that they continue to function optimally and remain accessible to all.
6. Ms R Windvogel: That the House notes with deep concern the recent decision by the Western Cape Education Department (WCED) to terminate learner transport services for learners residing in Vredebes and on surrounding farms who are enrolled at the Ceres Primary School and the Morrisdale Primary School; further notes the decision also affects high school learners enrolled at the Bella Vista High School who reside in Kliprug, Phases and on surrounding farms; further notes and rejects the WCED's decision to discontinue these vital transport services, as this action will have a devastating impact on the affected learners, particularly those from low-income households who rely heavily on these services to attend school; acknowledges that the unexpected termination of transport services is likely to lead to increased absenteeism and a higher dropout rate among these vulnerable learners; further notes that the termination of learner transport services will disproportionately affect poor learners, will exacerbate educational inequalities and will hinder their ability to access quality education; and calls on the WCED to reconsider this decision urgently and to reinstate the learner transport services.

7. Mr F Kamfer: That the House notes with deep concern the recent tragic bus crash on the Van Rhyn Pass between Nieuwoudville and Van Rhynsdorp in the Western Cape, which resulted in the loss of nine lives and other people being injured; further note that the crash occurred when the bus, which was carrying 42 passengers from the Northern Cape to the Western Cape, collided with the side of the mountain, causing the driver to lose control and the bus and it rolling down the slope; expresses our sincere sympathy for the families and loved ones of the deceased workers and wishes the survivors a speedy and full recovery; calls on all drivers to exercise greater care and vigilance when travelling on challenging and dangerous routes, as guaranteeing road safety is a joint responsibility, and drivers must comply with safety regulations and remain vigilant to prevent such devastating crashes; and urges the provincial government to take immediate action to improve road safety measures on the Van Rhyn Pass and other similar routes.
8. Mr F C Christians: That the House notes with concern that extortionists are targeting schools; notes that Basic Education Minister Siviwe Gwarube has raised deep concerns about the increasing rate of extortion in the Eastern Cape; notes that criminal networks are expanding operations in schools; notes that, if this crisis is allowed to flourish in our centres of learning, it will have dire consequences for education; notes that it must be stamped out before it takes root in the Western Cape and other provinces; notes that extortionists will not limit their operations to the Eastern Cape, but will spread their wickedness to the Western Cape; cautions against the spread of education extortionists whose actions will have serious repercussions for all, teachers and learners alike, as they will force their evil intentions upon our schools; and notes that lives have been lost due to the mindless violence perpetrated by extortionists in the construction industry and we must prepare to offer combined resistance to the pending disaster looming on the horizon.
9. Mr D Wessels: That the House notes that the City of Cape Town has started the construction of stormwater infrastructure along Japhta K Masemola Road between Baden Powell Drive and Nyanda Avenue; notes that the outlet of the existing stormwater drainage system is currently blocked as a result of the establishment of the Island Informal Settlement, which is causing road flooding at the low point of Japhta K Masemola Road when it rains; and notes that the installation of the new stormwater infrastructure will alleviate the risk of flooding along Japhta K Masemola Road, thereby extending the longevity of the City's road network and improving the safety of all road users.

Mnr B Herron: Die impak van die nasionale fiskale noodsituasie op die voorsiening van poste in die Wes-Kaapse Onderwysdepartement.

VERDERE WERKSAAMHEDE

KENNISGEWING VAN VOORSTELLE (5 September 2024)

1. Mnr B Ngqentsu: Dat die Huis die doeltreffendheid en doelmatigheid van die Wes-Kaapse Veiligheidsplan om aandag aan misdaad in die provinsie te skenk debatteer.
2. Me R Windvogel: Dat die Huis die stand van openbare gesondheidsorg in die provinsie debatteer.
3. Me N D Nkondlo: Dat die Huis die provinsiale regering se programme om aandag te skenk aan armoede en werkloosheid wat die swart meerderheid in die provinsie raak, debatteer.

4. Me R Windvogel: Dat die Huis die uitdagings met betrekking tot gesondheidsinfrastruktuur en die betekenisvolle verdragings met sleutelinfrastruktuurontwikkelingsprojekte, asook die provinsiale regering se planne om aan hierdie kwessies aandag te skenk, debatteer.
5. Mnr G Brinkhuis: Dat die Huis die negatiewe impak wat die aflegging van onderwysers om kinders se reg op onderwys het, en die voorgestelde besnoeiing van onderwysposte wat 'n werklike bedreiging vir die onderwys inhou, debatteer.

KENNISGEWING VAN VOORSTELLE (29 Augustus 2024)

1. Me A Cassiem: Dat die Huis kennis neem dat ongeveer 80 veiligheidswagte op Vrydag 30 Augustus 2024 buite die Groote Schuur-hospitaal gestaak oor laat salarisbetalings deur Gold Security Services, wat deur die Wes-Kaapse Departement van Gesondheid en Welstand vir die verskaffing van sekuriteitsdienste gekontrakteer is; kennis neem dat die sekuriteitsmaatskappy eers op 1 Julie 2024 dienste begin lewer het en werkers belowe het dat hulle op die 15e van elke maand betaal sal word, wat nog nooit gebeur het nie; kennis neem dat dit toe die norm geword het dat die maatskappy die werknemers op enige lukrake dag ná die 15e sonder enige verduideliking sou betaal; en sy beroep herhaal vir die inkontraktering van alle sekuriteitswagte, skoonmakers en ander werknemers wat by geboue en instellings van staatsdepartement op alle regeringsvlakke gestasioneer is en daar dienste lewer.
2. Me T Lithakong: Dat die Huis kennis neem dat die polisie in die Oos-Kaap op Woensdag 4 September 2024 twee mans doodgeskiet het wat deel van die afpersingsindikaat in Mthatha was; kennis neem dat die skietvoorval na wat berig word, deur die afpersingsbende begin is, terwyl die polisie daarna teruggevuur het; verder kennis neem dat een van die mense wat doodgeskiet is, hoofman Sakhumuzi Dalinzolo was, wat na bewering die hoofrol gespeel het in die onlangse afpersingspogings teen skole in Mthatha waarmee begin is; kennis neem dat 'n soortgelyke voorval ook verlede week in hierdie provinsie plaasgevind het toe vier mans, wat na bewering deel van die afpersingsbende was, deur die polisie in Milnerton doodgeskiet is, terwyl vier ander gewond is nadat hulle ook op die polisie losgebrand het en die polisie teruggeskiet het; afsluit deur te verklaar dat, alhoewel skietgevegte 'n gevaarlike omgewing vir gemeenskappe skep, die polisie se optrede aanvaar en verwelkom moet word; en hoop dat afpersers sal besef dat misdaad nie lonend is nie en die hoop uitspreek dat hulle hul veldtog van misdaad sal laat vaar.
3. Me P Z Lekker: Dat die Huis met ernstige kommer kennis neem van die huidige uitdagings met en spanning oor die hervestiging van informele boere wat grond in staatsbesit in Eersterivier beset, aangesien die beplande verskuiwing na gebiede wat reeds beset word, gemeenskapspanning vererger het en die lewensbestaan van hierdie boere bedreig; verder kennis neem van en erkenning gee aan die diepgaande impak wat hierdie situasie op die lewensbestaan van die informele boere gehad het, aangesien die voorgestelde hervestigingsterreine nie net onvoldoende in grootte is om hul vee te akkommodeer nie, maar ook verdere die verplasing van die bestaande inwoners veroorsaak, wat bydra tot spanning in die gemeenskap as geheel; 'n beroep doen op die beskerming van die boere se lewensbestaan deur toe te sien dat enige hervestigingsplanne voorsiening maak vir voldoende ruimte, behoorlike fasiliteite en die bewaring van hul landbou-aktiwiteite, aangesien dit van uiterste belang is dat die hervestiging nie hul vermoë om voort te gaan met hul boerdery en om hul gesinne te ondersteun nadelig beïnvloed nie; verder 'n beroep op die provinsiale regering doen om die spanning in die gemeenskap te beëindig deur 'n

gedeelte grond wat geskik is en van voldoende grootte is en nie huidig beset word nie, vir die hervestiging van hierdie gesinne beskikbaar te stel; en 'n beroep op die provinsiale regering doen om 'n gesprek tussen al die geraakte partye te fasiliteer om aandag aan hul bekommernisse te skenk en om konflik te voorkom.

4. Me R Windvogel: Dat die Huis met diepe kommer kennis neem van die omstrede besluit deur hierdie DA-geleide provinsiale regering om 2 407 onderwysposte met ingang Januarie 2025 te besnoei, ten spyte van groter breë teenkanting teen hierdie onsinnige besluit; verder kennis neem van hierdie roekelose besluit en dit verwerp aangesien die besluit geneem is sonder voldoende oorweging van die ernstige invloed wat dit op die gehalte van onderwys in die provinsie sal hê, veral ten opsigte leerders in voorheen benadeelde skole; verder kennis neem dat die vermindering van die getal onderwysposte met meer as 2 400 'n verwoestende impak op arm leerders by voorheen benadeelde skole sal hê omdat daardie skole nie kan bekostig om bykomende onderwysers deur hul skoolbeheerliggame in diens te neem nie, wat tot selfs groter onderwysverskille, groter klasgroottes, verminderde individuele aandag en algehele verminderde opvoedkundige uitkomst sal lei; 'n beroep op die WKOD doen om sy besluit te heroorweeg om onderwysposte te besnoei en, in plaas daarvan om die getal onderwysers – die basis van ons onderwysstelsel – te verminder, moet die WKOD alternatiewe kostebesparingsmaatreëls ondersoek, soos om uitgawes aan minder kritieke programme te besnoei, soos die “Back-on-Track”-program en die Skoolevalueringsowerheid; die WKOD aanmoedig om 'n meer billike benadering aan te neem wat die gehalte van onderwys vir alle leerders beskerm en aandag skenk aan die spesifieke behoeftes van skole wat ekonomies benadeelde gemeenskappe bedien, aangesien dit noodsaaklik is dat die WKOD op 'n betekenisvolle manier met onderwysers, ouers en gemeenskapsbelanghebbendes skakel om toe te sien dat enige begrotingsaanpassings nie diegene wat reeds benadeel is, buitensporig benadeel nie; en 'n beroep op alle progressiewe magte en onderwysbelanghebbendes doen, insluitende aktiviste en burgerlike organisasies, om eensgesind hierdie stap deur die DA-geleide regering te verwerp.
5. Me B Stoffel: Dat die Huis kennis neem van en die betekenisvolle vordering wat met die heropening van die sentrale lyn gemaak is, spesifiek die hervatting van treindienste vanaf die Nolungile-treinstasie in Terrein C na Kaapstad, verwelkom; erkenning gee dat hierdie ontwikkeling vervoeropsies vir inwoners aansienlik verbeter het deur bekostigbare en betroubare vervoer te verskaf teen tariewe wat by R9 begin, met verdere afslag wat gedurende niespitstye beskikbaar is; die nasionale Departement van Vervoer en Prasa aanprys vir hul uitstekende werk om hierdie stadium van die sentrale lyn se heropening te bereik; verder kennis neem van en kommer uitspreek oor die afwenteling van die spoordiens of die privatisering daarvan, soos voorgestel deur sommige Lede in die Huis, die kwaliteit van diens kan ondermyn en kan lei tot verhoogde tariewe, en hierdie roekelose beroepe verwerp; en ondersteuning herbevestig vir die behoud van die spoordiens onder nasionale toesig, om sodoende te verseker dat dit voortgaan om optimaal te funksioneer en toeganklik vir almal bly.
6. Me R Windvogel: Dat die Huis neem met diepe kommer kennis neem van die onlangse besluit van die Wes-Kaapse Onderwysdepartement (WKOD) om leerdervoerdienste vir leerders wat in Vredebes en op omliggende plase woon en by die Laerskool Ceres en die Laerskool Morrisdale ingeskryf is, te beëindig; verder kennis neem dat die besluit ook hoërskoolleerders wat by die Hoërskool Bella Vista ingeskryf is wat in Kliprug, Phases en op omliggende plase woon, raak; verder kennis neem van en die WKOD se besluit verwerp

om hierdie noodsaaklike vervoerdienste te staak, aangesien hierdie optrede 'n vernietigende impak op die geraakte leerders sal hê, veral die leerders uit lae-inkomstehuishoudings wat grootliks op hierdie dienste staatmaak om by die skool te kom; erkenning gee dat die onverwagte beëindiging van vervoerdienste waarskynlik tot verhoogde afwesigheid en 'n hoër skoolverlatingsyfer onder hierdie weerlose leerders sal lei; verder kennis neem dat die beëindiging van leerdervervoerdienste arm leerders buitensporig sal raak, onderwysongelykhede sal vererger en hul vermoë sal belemmer om toegang tot gehalteonderwys te kry; en 'n beroep op die WKOD om doen hierdie besluit dringend te heroorweeg en om die leerlingvervoerdienste weer in te stel.

7. Mnr F Kamfer: Dat die Huis met diepe kommer kennis neem van die onlangse tragiese busbotsing op die Van Rhynspas tussen Nieuwoudtville en Van Rhynsdorp in die Wes-Kaap, wat tot die verlies van nege lewens gelei het en ander mense beseer het; verder kennis neem dat die botsing plaasgevind het toe die bus, wat 42 passasiers van die Noord-Kaap na die Wes-Kaap vervoer het, met die kant van die berghelling gebots het, wat veroorsaak het dat die bestuurder beheer oor die bus verloor het en teen die helling afgerol het; opregte simpatie word betuig met die families en geliefdes van die oorlede werkers en 'n vinnige en volle herstel word die oorlewendes toegewens; doen 'n beroep op alle bestuurders om groter sorg en waaksaamheid uit te oefen wanneer hulle op uitdagende en gevaarlike roetes reis, aangesien die waarborg van padveiligheid 'n gesamentlike verantwoordelikheid is, en bestuurders moet die veiligheidsregulasies nakom en waaksaam bly om sulke verwoestende botsings te voorkom; en eis dat die provinsiale regering onmiddellik optree om padveiligheidsmaatreëls op die Van Rhynspas en ander soortgelyke roetes te verbeter.
8. Mnr F C Christians: Dat die Huis met kommer kennis neem dat afpersers skole teiken; kennis neem dat Siviwe Gwarube, Minister van Basiese Onderwys, ernstige kommer uitgespreek het oor die toenemende afpersingskoers in die Oos-Kaap; kennis neem dat misdaadnetwerke hul bedrywighede na skole uitbrei; kennis neem dat, indien toegelaat word dat hierdie krisis in ons leersentrums floreer, dit ernstige gevolge vir die onderwys sal inhou; kennis neem dat dit uitgeroei moet word voordat dit in die Wes-Kaap en ander provinsies wortel skiet; kennis neem dat afpersers nie hul bedrywighede tot die Oos-Kaap sal beperk nie, maar hul boosdadigheid na die Wes-Kaap sal versprei; waarsku teen die verspreiding van onderwysafpersers wie se optrede ernstige gevolge vir almal sal inhou, onderwysers en leerders ingesluit, aangesien hulle hul bese bedoelings op ons skole sal afdwing; en kennis neem dat lewens verlore gegaan het weens die sinnelose geweld wat deur afpersers in die konstruksiebedryf gepleeg is, en dat ons voorbereid moet wees om gesamentlik weerstand te bied teen die dreigende ramp wat op die horison wag.
9. Mnr D J Wessels: Dat die Huis kennis neem dat die Stad Kaapstad begin het met die bou van stormwaterinfrastruktuur langs Japhta K Masemolaweg tussen Baden Powellrylaan en Nyandalaan; kennis neem dat die uitlaat van die bestaande stormwaterdreineringsstelsel tans geblokkeer word as gevolg van die totstandkoming van die Island- informele nedersetting, wat die oorstroming van die pad by die laagte punt van Japhta K Masemolaweg veroorsaak wanneer dit reën; en kennis neem dat die installering van die nuwe stormwaterinfrastruktuur die risiko van die oorstroming van Japhta K Masemolaweg sal verklein, en sodoende die langdurigheid van die Stad se padnetwerk sal verleng en die veiligheid van alle padgebruikers sal verbeter.
