**NOTICE OF MOTIONS**

1. Ms S W Davids: That the House debates to increase assistance to emerging and entry-level smaller businesses in townships sufficiently.
2. Ms T M Dijana: That the House debates the high increase in attacks on police officers and other emergency services in the province.
3. Ms L M Maseko: That the House debates the statement made by the Minister of Human Settlements, Bonginkosi Madikizela, regarding the unsustainability of free housing.
4. Mr R T Olivier: That the House debates the Western Cape Education Department's unwillingness to deal adequately with corporal punishment in schools across the province.
5. Ms D Gopie: That the House debates the shroud of secrecy around the new Manenberg hospital site.
6. Mr D Joseph: That the House debates the impact of sound financial governance in the Western Cape on economic growth and service delivery.

7. Mr R T Olivier: That the House debates the security of learners at schools in the province.
8. Mr R T Olivier: That the House investigates on-going allegations of sexual assault on learners in school time on state premises and attacks in school toilets, like the case of a girl from the Hottentots Holland High School who was attacked while waiting for her lift home.
9. Ms P Makeleni: That the House calls for a full investigation into how convicted paedophile Brain Shofer taught children at Lourier Primary School in the province at the time of his recent arrest for raping a young boy and to prevent other convicted paedophiles to work with children across schools in the province.
10. Mr Q R Dyantyi: That the House urgently investigates the large-scale unspent capital budget of the City of Cape Town that amounts to R130 million as well as a further R470 million on the operational budget and a massive rollover of R10 million grant funding unspent on, among others, housing; with a further R406 million rolled over for the human settlements operating budget and R18,4 million for upgrades of rental units during the past financial year.
11. Mr Q R Dyantyi: That the House notes with concern the golden handshake given to two City of Cape Town senior managers, Gerhard Ras and Dr Ivan Bromfield, and also notes that Ras is one of those professional collectors of such payments which he got in Matzikama and George too.
12. Ms M N Gillion: That the House notes the DA and EFF are now getting really very close in this Legislature as a delegation consisting of these two aligned parties now attend the 47th CPA Regional Conference in Mauritius.
13. Ms L M Maseko: That the House thanks everyone involved with the 2016 election in the Langeberg constituency for their hard and selfless work.
14. Mr M Mnqasela: That the House congratulates the Independent Electoral Commission of South Africa on conducting successful, peaceful, credible, free and fair 2016 local-government elections.
15. Mr R T Olivier: That the House notes that, despite the expectation of 25 000 new learners entering the Western Cape education system, the Western Cape Education Department will not increase the number of teaching posts in the 2017 academic year, causing a looming crisis that will affect mostly the learners in poor and township schools; and that the House calls for an urgent intervention from national Department of Education.
