MOTIONS

1. Ms P Z Lekker: That the House notes with profound sadness the untimely passing away of Honourable Maurencia Gillion, the ANC Western Cape delegate to the National Council of Provinces (NCOP); notes that comrade Maurencia was a dedicated servant of the people and served the ANC in different capacities, including as Mayor of Theewaterskloof, ANC Western Cape Treasurer and ANC Provincial Deputy Secretary, as well as a member of the current interim provincial leadership at the time of her passing; notes that she will be remembered fondly for her love for the people, her commitment to fight for transformation and her despise for injustices; notes that she passed away while on duty serving the people of South Africa in the NCOP strategic session; and commiserates with the Gillion family, her friends and loved ones, her ANC comrades and colleagues in the NCOP and the Provincial Parliament, as well as staff and parliament officials she worked with.

3. The Chief Whip of the Majority Party (Ms W F Kaizer-Philander): That the House, in accordance with Rule 119(1) of the Standing Rules, appoints an Ad-hoc Committee to conduct oversight over the work of the provincial executive as it responds to the impact of the national energy crises on the Western Cape, including oversight over any part of the provincial executive, any provincial department, any provincial organ of state and any provincial entity involved in activities dealing with energy security.

The Committee shall consist of 15 Members, appointed in accordance with Rule 120 of the Standing Rules, with the membership allocated as follows:

- (a) Democratic Alliance: 8 Members
- (b) African National Congress: 2 Members
- (c) Economic Freedom Fighters: 1 Member
- (d) GOOD: 1 Member

- (e) African Christian Democratic Party: 1 Member
- (f) Freedom Front Plus: 1 Member
- (g) Al Jama-ah: 1 Member

The names of the Members representing the political parties must be submitted to the Speaker of the Western Cape Provincial Parliament as soon as possible for publication in an ATC.

The Ad-hoc committee shall have all the general powers conferred upon committees in accordance with the Standing Rules (Rule 91), as well as any other power, where applicable, conferred upon committees generally in accordance with the Standing Rules (Rules 77–95).

The Committee must report regularly to the House on its activities.

4. The Chief Whip of the Majority Party (Ms W F Kaizer-Philander): That:
- (1) an Ad-hoc Committee be appointed to give effect to section 196(8)(b)(i) of the Constitution, 1996, read with section 4(3)(b) of the Public Service Commission Act, 1997 (Act 46 of 1997), to consider applications and to recommend to the House a candidate for nomination by the Premier for appointment to serve on the Public Service Commission; and
 - (2) the Ad-hoc Committee consists of 15 Members, appointed in accordance with Rule 120 of the Standing Rules, with the membership allocated as follows:
 - (a) Democratic Alliance: 8 Members
 - (b) African National Congress: 2 Members
 - (c) Economic Freedom Fighters: 1 Member
 - (d) GOOD: 1 Member
 - (e) African Christian Democratic Party: 1 Member
 - (f) Freedom Front Plus: 1 Member
 - (g) Al Jama-ah: 1 Member
