MOTIONS

1. The Chief Whip of the Majority Party (Ms W F Kaizer-Philander): That in terms of section 6(3)(b) of the Remuneration of Public Office Bearers Act, 1998, (Act 20 of 1998), the upper limits of the salary and allowances of the Premier of the Western Cape, as proclaimed by the President of the Republic of South Africa by Proclamation No. 129 of 2023, published in *Government Gazette* No. 48929 dated 10 July 2023, be determined as the salary and allowances of the Premier of the Western Cape with effect from 01 April 2022.
2. The Chief Whip of the Majority Party (Ms W F Kaizer-Philander): That:
 - (1) an Ad-hoc committee be appointed by the House to consider and report on the Western Cape Provincial Powers Bill, 2023 as introduced by the Standing Committee on the Premier and Constitutional Matters on Monday, 3 July 2023. (See Announcements, Tablings and Committee Reports, no 66, dated 3 July 2023, p 224.)
 - (2) the Ad-hoc Committee shall consist of 10 Members, appointed in accordance with Rule 120 of the Standing Rules, with the membership allocated as follows:
 - (a) Democratic Alliance: 6 members
 - (b) African National Congress: 2 members
 - (c) Economic Freedom Fighters: 1 Member
 - (d) 1 Member to be nominated by the GOOD/ACDP/Freedom Front Plus and Al Jama-ah, collectively.

The names of the Members representing the political parties must be submitted to the Speaker of the Western Cape Provincial Parliament within three (3) working days for publication in the ATC.

The committee to have all the powers conferred on committees generally as contemplated in Rule 91 and the powers necessary for the carrying out of its assignment as contemplated in Rule 119 of the Standing Rules.

NOTICES OF MOTION (20 July 2023)

1. Mr G Pretorius: That the House debates the implications of the pending National Health Insurance Bill on the Western Cape.
2. Ms A P Bans: That the House debates the increasing rate of child murders in Western Cape.
3. Ms R Windvogel: That the House debates the rabbit haemorrhagic disease (RHD) outbreak in the Western Cape.
4. Ms N D Nkondlo: That the House debates the 17.6% electricity price hike in Cape Town. This hike is way above the Nersa-approved tariff hike for municipalities of 15.1.
5. Mr P Marran: That the House debates the Provincial government carelessness about the hundreds of displaced shack fire victims at Ramaphosa informal settlement in Philippi.

NOTICES OF MOTION (22 June 2023)

1. Mr M I Sileku: That the House acknowledges the findings of the Auditor-General, highlighting that the current state of Beaufort West, Kannaland and Laingsburg can be attributed to a lack of leadership; notes that this cannot be disputed by the ANC's Member Cameron Dugmore who was in the committee meeting when this was confirmed by the Auditor-General; further acknowledges that these municipalities are governed by the ANC and their allies; recognises that the Department of Local Government gave extended assistance to Beaufort West, Kannaland and Laingsburg, however, it is regrettable that assistance can only be provided to those who actively seek it; expresses serious concern over the Auditor-General's report, which reveals that these municipalities made limited efforts to enhance their financial management; and appreciates the Auditor-General's encouragement for the DA-led Western Cape to serve as a leading example by promoting a culture of compliance and adherence.
2. Ms L M Maseko: That the House notes with excitement that the City of Cape Town has secured €100 million in infrastructure funding from the French Development Agency, which equates to about R2 billion; notes that this will go towards the City's record-breaking R43 billion medium-term infrastructure budget; notes that this funding will be used to improve water and sanitation, public transport and access to electricity; further notes that the City of Cape Town alone has an infrastructure budget twice the size of the entire Gauteng Province's infrastructure budget; notes that the DA-led Cape Town now has an infrastructure investment portfolio of R120 billion over the next 10 years; and acknowledges the significant role this money will play in addressing socio-spatial

inequalities and in contributing to the creation and restoration of vital infrastructure throughout the City.

3. Mr T M Klaas: That the House notes that on 21 June 2023 hundreds of community members marched to the Gugulethu Health Care Centre to demand better services at the clinic; notes that the residents complained about the issue of a leaking roof causing wet floors when it rains, long queues, missing patient files, robberies and maltreatment at the hands of the nursing staff; further called for a hospital to be built in the area, just like the one in Khayelitsha; further notes that there have been robberies in the area targeting patients visiting the clinic as well as the security personnel; notes that residents are experiencing a lack of proper healthcare services at the clinic and are feeling unsafe as they are robbed inside this clinic; and notes that all of this is testimony that the DA-led provincial government does not take black people living in townships seriously.
4. Mr M K Sayed: That the House acknowledges the positive impact of Rainbow Nation Kids Songs driven by a young woman, Lungi Naidoo, in KwaZulu-Natal; urges the Western Cape Education Department to develop similar projects for schools in our province; notes that Rainbow Nation Kids Songs have successfully promoted unity, cultural diversity and social cohesion among young learners; notes that, recognising the value of such initiatives, the WCED must invest in projects that celebrate our nation's diversity, foster inclusivity and promote cultural understanding in schools across the Western Cape; and notes that, by encouraging the development of similar programmes, we can cultivate an environment that embraces our collective heritage, nurtures tolerance and empowers our learners to become compassionate, global citizens.
5. Mr P Marran: That the House notes the devastating impact of the recent floods on the Western Cape's citrus and potato harvests, which has the potential to incur significant financial losses for our farmers and farm workers; recognising the urgency of the situation, calls upon the provincial government to intervene swiftly and provide the necessary support to those affected; notes that immediate assistance – such as financial aid, infrastructure repairs and access to resources – is crucial to mitigate the economic burden imposed on these agricultural communities; and notes that, by taking prompt action, the government can help safeguard the livelihoods of our farmers and ensure the continued stability and productivity of our agricultural sector.
6. Mr M Kama: That the House notes the pervasive issue of the exclusion of black people from the economy of the Western Cape; notes that there is an urgent need for equitable representation and economic opportunities; calls on the Western Cape Government and relevant stakeholders to work actively towards the dismantling of systemic barriers that hinder the full participation of black individuals in the region's economy, including implementing policies that promote diversity, equity and inclusion in hiring, procurement and business ownership; and notes that, by fostering an environment that embraces diversity and provides equal access to economic resources, we can create a more just and prosperous Western Cape for all its residents.
7. Mr M K Sayed: That the House notes with grave concern the high number of unplaced learners who, despite having applied on time and correctly, were rejected by all schools they applied to; further notes that the latest of these cases involves Ms Keet who applied for her daughter at five schools in Stellenbosch and all the applications were unsuccessful at Rhenish Primary School, Laerskool A F Louw, Laerskool Eikestad, Idasvallei Primary

School and Laerskool Stellenbosch; further notes that Ms Keet has lodged an appeal at Rhenish Primary School and calls on Minister Maynier to intervene and ensure placement of this child at the school; further notes and acknowledges that the unplaced learner crisis in the Western Cape is exacerbated by discriminatory and racist practices, especially by the SGBs of former model C schools who, with the backing of the DA, ACDP and FF+, use the admissions and language policies to gatekeep and block (mainly) black learners (black, coloured and Indian) from enrolling in their schools; and resolves to call on Minister Maynier and his Department to appear before the Standing Committee to brief Members about the root causes of this crisis with an action plan.

8. Mr M K Sayed: That the House notes with grave concern and condemns the endless illegal extension of the National School Nutrition Programme (NSNP) contract by the Western Cape Education Department (WCED) whereas the B/WCED 2915/21 (National School Nutrition Programme) and B/WCED 2916/21 (MOD centres) were advertised on 13 May 2021 with the closing date of 14 June 2021; notes that only the award of bid B/WCED 2915/21 was publicised on the Western Cape Tender Bulletin dated 12 December 2022 and to date bid B/WCED 2916/21 has not yet been awarded; notes that, instead, its validity period is being unendingly extended, including on the following dates: 11 December 2021–31 March 2022, 31 March 2022–31 July 2022, 31 July 2022–31 October 2022, 31 October 2022–31 January 2023, 31 January 2023–27 March 2023 and 27 March 2023–30 June 2023; further notes that even the June 2023 date is being extended to 30 September 2023 according to internal notice that have been received; and resolves to call on the WCED to end the illegal extension of the NSNP immediately.

1. Die HoofswEEP van die Meerderheidsparty (me W F Kaizer-Philander): Dat, ingevolge artikel 6(3)(b) van die Wet op die Besoldiging van Openbare Ampsbekleërs, 1998, (Wet 20 van 1998), die boperke van die salaris en toelaes van die Premier van die Wes-Kaap, soos aangekondig deur die President van die Republiek van Suid-Afrika by Proklamasie No 129 van 2023, gepubliseer in die *Staatskoerant* No 48929, gedateer 10 Julie 2023, bepaal word as die salaris en toelaes van die Premier van die Wes-Kaap met ingang 1 April 2022.
2. Die HoofswEEP van die Meerderheidsparty (Me W F Kaizer-Philander): Dat:
 - (1) 'n Ad-hoc-komitee aangestel word deur die Huis om die Wes-Kaapse Wetsontwerp op Provinsiale Bevoegdhede, 2023, soos ingestel deur die Staande Komitee oor die Premier en Grondwetlike Aangeleenthede op Maandag, 3 Julie 2023, te oorweeg en daarvoor verslag te doen. (Sien Aankondigings, Besprekings en Komiteeverslae, no 66, gedateer 3 Julie 2023, bl 224.)
 - (2) die Ad hoc-komitee uit 10 Lede bestaan, aangestel ooreenkomstig Reël 120 van die Staande Reëls, met lidmaatskap soos volg toegewys:
 - (a) Demokratiese Alliansie: 6 lede
 - (b) African National Congress: 2 lede
 - (c) Ekonomiese Vryheidsvegters: 1 Lid
 - (d) 1 lid wat deur die GOOD/ACDP/Freedom Front Plus en Al Jama-ah gesamentlik genomineer word.

Die name van die Lede wat die politieke partye verteenwoordig, moet binne drie (3) werksdae aan die Speaker van die Wes-Kaapse Provinsiale Parlement voorgelê word vir publikasie in die ATC.

Die komitee moet al die bevoegdhede hê wat oor die algemeen aan komitees toegeken word soos beoog in Reël 91 en die bevoegdhede wat nodig is vir die uitvoering van sy opdrag soos beoog in Reël 119 van die Staande Reëls.

KENNISGEWING VAN VOORSTELLE (20 Julie 2023)

1. Mnr G Pretorius: Dat die Huis die implikasies van die hangende Nasionale Gesondheidsversekeringswetsontwerp op die Wes-Kaap debatteer.
2. Me A P Bans: Dat die Huis die toenemende koers van kindermoorde in die Wes-Kaap debatteer.
3. Me R Windvogel: Dat die Huis debatteer oor die uitbraak van konynbloedingssiekte (RHD) in die Wes-Kaap.
4. Me N D Nkondlo: Dat die Huis die 17,6% elektrisiteitsprysverhoging in Kaapstad debatteer. Hierdie staptog is ver bo die Nersa-goedgekeurde tariefverhoging vir munisipaliteite van 15.1.
5. Mnr P Marran: Dat die Huis debatteer oor die provinsiale regering se sorgeloosheid oor die honderde ontheemde slagoffers van brandhut by Ramaphosa informele nedersetting in Philippi.

KENNISGEWING VAN VOORSTELLE (22 Junie 2023)

1. Mnr M I Sileku: Dat die Huis erkenning gee aan die bevindings van die Ouditeur-generaal wat beklemtoon dat die huidige toestand van Beaufort-Wes, Kannaland en Laingsburg toegeskryf kan word aan 'n gebrek aan leierskap; kennis neem dat dit nie deur die ANC se Lid Cameron Dugmore betwis kan word nie wat in die komiteevergadering was toe dit deur die Ouditeur-generaal bevestig is; verder erken dat hierdie munisipaliteite deur die ANC en hul bondgenote regeer word; erken dat die Departement van Plaaslike Regering uitgebreide hulp aan Beaufort-Wes, Kannaland en Laingsburg verleen het, maar dat dit betreurenswaardig is dat hulp slegs verleen kan word aan diegene wat dit aktief soek; ernstige kommer uitspreek oor die Ouditeur-generaal se verslag, wat onthul dat hierdie munisipaliteite beperkte pogings aangewend het om hul finansiële bestuur te verbeter; en waardering uitspreek vir die Ouditeur-generaal se aanmoediging vir die DA-geleide Wes-Kaap om as 'n leidende voorbeeld te dien deur 'n kultuur van voldoening en nakoming te bevorder.

2. Me L M Maseko: Dat die Huis met opgewondenheid kennis neem dat die Stad Kaapstad €100 miljoen se infrastruktuurfinansiering van die Franse Ontwikkelingsagentskap bekom het, wat gelykstaande is aan sowat R2 miljard; kennis neem dat dit aangewend sal word in die Stad se rekordbrekende mediumtermyn-infrastruktuurbegroting van R43 miljard; kennis neem dat hierdie befondsing gebruik sal word om water en sanitasie, openbare vervoer en toegang tot elektrisiteit te verbeter; verder kennis neem dat die Stad Kaapstad alleen 'n infrastruktuurbegroting het wat twee keer so groot is as die infrastruktuurbegroting van die hele Provinsie Gauteng; kennis neem dat die DA-geleide Kaapstad nou 'n infrastruktuurbeleggingsportefeulje van R120 miljard oor die volgende 10 jaar het; en erkenning gee aan die belangrike rol wat hierdie geld sal speel om aandag te skenk aan sosio-ruimtelike ongelykhede en om by te dra tot die skepping en herstel van lewensbelangrike infrastruktuur regdeur die Stad.
3. Mnr T M Klaas: Dat die Huis kennis neem dat honderde gemeenskapslede op 21 Junie 2023 na die Gugulethu-gesondheidsorgsentrum opgeruk het om beter dienste by die kliniek te eis; kennis neem dat die inwoners gekla het oor die kwessie van 'n lekkende dak wat nat vloere veroorsaak wanneer dit reën, lang rye, vermiste pasiëntlêers, rooftogte en mishandeling deur die verpleegpersoneel; verder 'n beroep gedoen het dat 'n hospitaal in die gebied gebou word, net soos die een in Khayelitsha; verder kennis neem dat daar rooftogte in die gebied was wat pasiënte wat die kliniek besoek, sowel as die sekuriteitspersoneel teiken; kennis neem dat inwoners 'n gebrek aan behoorlike gesondheidsorgdienste by die kliniek ervaar en onveilig voel omdat hulle binne hierdie kliniek beroof word; en kennis neem dat dit alles daarop wys dat die DA-geleide provinsiale regering nie swart mense wat in informele nedersettings woon, ernstig opneem nie.
4. Mnr M K Sayed: Dat die Huis erkenning gee aan die positiewe impak van Rainbow Nation Kids Songs onder aanvoering van 'n jong vrou, Lungi Naidoo, in KwaZulu-Natal; die Wes-Kaapse Onderwysdepartement versoek om soortgelyke projekte vir skole in ons provinsie te ontwikkel; kennis neem dat Rainbow Nation Kids Songs eenheid, kulturele diversiteit en sosiale kohesie onder jong leerders suksesvol bevorder het; kennis neem dat, met erkenning van die waarde van sulke inisiatiewe, die WKOD moet belê in projekte wat ons nasie se diversiteit vier, inklusiwiteit bevorder en kulturele begrip in skole in die Wes-Kaap bevorder; en neem kennis dat ons, deur die ontwikkeling van soortgelyke programme aan te moedig, 'n omgewing kan kweek wat ons kollektiewe erfenis koester, verdraagsaamheid kweek en ons leerders bemagtig om meelewende wêreldburgers te word.
5. Mnr P Marran: Dat die Huis kennis neem van die verwoestende impak van die onlangse vloede op die Wes-Kaap se sitrus- en aartappel-oeste, wat die potensiaal het om aansienlike finansiële verliese vir ons boere en plaaswerkers te veroorsaak; met erkenning van die dringendheid van die situasie, 'n beroep op die provinsiale regering doen om vinnig in te gryp en die nodige ondersteuning te verskaf aan diegene wat geraak word; kennis neem dat onmiddellike bystand – soos finansiële hulp, die herstel van infrastruktuur en toegang tot hulpbronne – noodsaaklik is om die ekonomiese las wat op hierdie landbougemeenskappe geplaas word, te verlig; en kennis neem dat die regering, deur vinnige stappe te doen, kan help om die lewensbestaan van ons boere te beskerm en die voortgesette stabiliteit en produktiwiteit van ons landbousektor te verseker.

6. Mnr M Kama: Dat die Huis kennis neem van die voortgesette kwessie van die uitsluiting van swart mense uit die ekonomie van die Wes-Kaap; kennis neem dat daar 'n dringende behoefte is aan billike verteenwoordiging en ekonomiese geleenthede; 'n beroep op die Wes-Kaapse Regering en tersaaklike belanghebbendes doen om aktief te werk aan die aftakeling van sistemiese hindernisse wat die volle deelname van swart individue in die streek se ekonomie belemmer, insluitende die implementering van beleide wat diversiteit, billikheid en insluiting by aanstelling, verkryging en sakeondernemingseienarskap bevorder; en kennis neem dat, deur 'n omgewing te bevorder wat diversiteit verwelkom en gelyke toegang tot ekonomiese hulpbronne aanbied, ons 'n meer regverdigde en welvarende Wes-Kaap vir al sy inwoners kan skep.
7. Mnr M K Sayed: Dat die Huis met ernstige kommer kennis neem van die groot aantal ongeplaaste leerders wat, ten spyte daarvan dat hulle betyds en korrek aansoek gedoen het, deur alle skole waar hulle aansoek gedoen het, afgekeur is; verder kennis neem dat die jongste van hierdie voorvalle me Keet behels wat vir haar dogter by vyf skole in Stellenbosch aansoek gedoen het en al die aansoeke onsuksesvol was by die Rhenish Primary School, die Laerskool A F Louw, die Laerskool Eikestad, die Idasvallei Primary School en die Laerskool Stellenbosch; verder kennis neem dat me Keet appèl aangeteken het by die Rhenish Primary School en 'n beroep op Minister Maynier doen om in te gryp om die plasing van hierdie kind by die skool te verseker; verder kennis neem en erken dat die krisis van ongeplaaste leerders in die Wes-Kaap vererger word deur diskriminerende en rassistiese praktyke, veral deur die SBL's van voormalige model C-skole wat, met die steun van die DA, ACDP en VF+, die toelatings- en taalbeleide gebruik om hekwag te speel en (hoofsaaklik) swart leerders (swart, bruin en Indiër) verhoed om by hul skole in te skryf; en besluit om 'n beroep op Minister Maynier en sy departement te doen om voor die Staande Komitee te verskyn om Lede in te lig oor die grondliggende oorsake van hierdie krisis met 'n aksieplan.
8. Mnr M K Sayed: Dat die Huis met ernstige kommer kennis neem van en die eindelose onwettige verlenging van die kontrak vir die Nasionale Skoolvoedingsprogram (NSVP) deur die Wes-Kaapse Onderwysdepartement (WKOD) veroordeel, terwyl die B/WKOD 2915/21 (Nasionale Skoolvoedingsprogram) en B/WKOD 2916/21 (MOD-sentrums) op 13 Mei 2021 geadverteer is met die sluitingsdatum van 14 Junie 2021; kennis neem dat slegs die toekenning van bod B/WKOD 2915/21 op die Wes-Kaapse Tenderbulletin gedateer 12 Desember 2022 gepubliseer is en tot op hede is bod B/WKOD 2916/21 nog nie toegeken nie; kennis neem dat die geldigheidstydperk daarvan oneindig verleng word, insluitende op die volgende datums: 11 Desember 2021–31 Maart 2022, 31 Maart 2022–31 Julie 2022, 31 Julie 2022–31 Oktober 2022, 31 Oktober 2022–31 Januarie 2023, 31 Januarie 2023–27 Maart 2023 en 27 Maart 2023–30 Junie 2023; verder kennis neem dat selfs die Junie 2023-datum verleng word tot 30 September 2023 volgens interne kennisgewing wat ontvang is; en besluit om 'n beroep op die WKOD te doen om die onwettige verlenging van die NSVP onmiddellik te beëindig.
