NOTICE OF MOTIONS

- 1. Mr K E Magaxa: That the House debates the effectiveness of the Western Cape Government's strategies to halt the road carnage in the province as, during the Traffic Month alone, the road carnage claimed the lives of more than a hundred people, averaging double digits every weekend.
- 2. Mr M Mnqasela: That the House debates the spy saga currently playing itself out in the public domain.
- 3. Ms P Z Lekker: That the House debates the DA-run government's response to the war between taxi bosses and the Western Cape Government.
- 4. Mr M Mnqasela: That the House debates the sustainability of water resources so that they are able to meet our current demands and the needs of future generations; and come up with solutions.
- 5. Mr R T Olivier: That the House debates the high incidence and severity of bullying in schools around the province which have led to suicides and the hospitalisation of some learners.
- 6. Ms T M Dijana: That the House debates the high number of gang-related deaths in the province under the DA.
- 7. Mr N E Hinana: That the House calls on the national government to implement the necessary austerity measures and to reprioritise the budget in order to find the necessary funds to fund tertiary education adequately.
- 8. Ms D Gopie: That the House debates interventions by the Western Cape Government aimed at mitigating strokes which are reported to be the third leading cause of deaths in the Western Cape and one of the leading causes of disability in South Africa.

- 9. Mr B D Joseph: That the House, noting:
 - (a) the horrific continuation of the use of rape and sexual violence as a means to subject women around the world:
 - (b) further that in Cape Town an estimated 21 women are raped daily and 7 309 women were raped in 2015 alone; and
 - (c) that most rapes go unreported due to the rape victim's lack of faith in the ability of the South African justice system to offer women protection and treat them with dignity and respect,

therefore, the House makes a call to end these atrocious crimes.

- 10. Ms P Makeleni: That the House congratulates the courageous women of Hangberg, Imizamo Yethu and Ocean View for launching their Women's League Forum in partnership with the ANC.
- 11. Mr S G Tyatyam: That the House note that October was filled with lots of student protests demanding that fees must fall; and further note the swift response by President Jacob Zuma who called an urgent meeting between student leaders and universities' vice-chancellors where a moratorium on fees was agreed to; and congratulate the President for providing leadership.
- 12. Ms M N Gillion: That the House congratulates John Michels, the new councillor of the ANC in ward 11 in Grabouw, after the ANC took the ward from the DA during the byelections last month.
- 13. Ms D Gopie: That the House notes with serious concern that Hanover Park residents who depend on a public clinic now have to obtain health services in other areas following the DA-run City's decision to close their clinic temporarily due to gang wars; condemn the City with the strongest contempt possible for compromising health services to the people; and call on the security services to intervene to restore peace and order in the area.
- 14. Mr Q R Dyantyi: That the House notes with serious concern that a senior DA councillor in George, Henry Jones, is being investigated by police for the illegal sale of subsidised plots and RDP houses in Rosedale; and further notes the nauseating DA hypocrisy, acting as protagonists of clean governance on one hand, while failing to act decisively against its corrupt members, as Jones is only suspended from the party but is allowed to continue as a councillor.
- 15. Ms P Z Lekker: That the House welcomes the visit and leadership of the Deputy Minister of Police, Maggie Sotyu, last month where she undertook to get more staff for the Nyanga police station and to look into mobile stations in Brown's Farm and Samora Machel.
- 16. Mr K E Magaxa: That the House commends the South Road Families Association for taking up the fight against the DA-run City of Cape Town which intended to evict 26 families to make way for MyCiti bus route, as earlier last month the Western Cape High Court's acting judge Weinkove ruled in their favour, halting the evictions and ordering the City to conduct a meaningful public participation process before serving residents with eviction notices and demolishing their homes; and further note that the DA-run City of Cape Town is hell-bent on keeping alive the legacy of apartheid as it applied for leave to appeal against the ruling and issued further eviction notices against Plumstead families; and that the House condemn the City for resuscitating apartheid tactics and applaud the judge for this progressive judgment.
- 17. Mr R T Olivier: That the House condemns the abuse of an official vehicle by the Minister of Transport and Public Works, Mr D A C Grant, used to transport voters during a by-election yesterday in Cape Agulhas.
