NOTICES OF MOTION (21 November 2024)

1. Mr F C Christians: That the House notes the budget cuts of the Department of Health and Wellness as stated in the National Medium-Term Policy Statement; and notes the effect this will have on this critical frontline service in the Western Cape.
2. Ms A P Bans: That the House notes with grave concern the serious allegations of corruption, cronyism, capture and maladministration in the Western Cape Department of Mobility, particularly the alleged involvement of senior officials, such as Deidre Riboonaar, Kyle

Reinecke, Ricardo Collins, Gamza Martin and Farrel Payne, who are accused of personal enrichment through luxury properties, fleets of expensive vehicles, and the appointment of family members to cushy government positions; further notes that companies allegedly linked to these officials, such as PEGASYS and ROUTE MASTER, have been awarded lucrative multiyear contracts, raising concerns about conflicts of interest and corruption; further notes that, despite Premier Alan Winde acknowledging knowledge of these allegations, the implicated officials have not been suspended pending investigation, leading to concerns about the Premier's complacency and lack of decisive action; and therefore calls on Premier Winde to furnish the House with the timelines and scope of the investigation he claims to have instituted into these matters, and for the Public Accounts Committee (PAC) to summon the Department of Mobility and its Minister to appear before it to account for these serious allegations; and further calls on the House to take decisive action to ensure that corruption in the Western Cape Government is eradicated, that transparency is upheld and that those responsible are held to account.

NOTICES OF MOTION (14 November 2024)

1. Mr B Ngqentsu: That the House notes and joins the international socialist forces in celebrating the 107th anniversary since the 1917 Great October Socialist Revolution and, as noted by Nikos Mottas in the socialist journal *In Defense of Communism: The Marxist-Leninist Blog*, the significance of the Great October Socialist Revolution lies in the fact that it was historically the first conscious step for the transition from the barbaric, violent and inhuman system of capitalism to socialism, and the abolishing of man by man; acknowledges that, contrary to bourgeois scholars and the media that have always wanted to portray the Great October Revolution as a "coup", the Great October Socialist Revolution was the product of organised working-class struggles led by the great Lenin and Bolsheviks to usher in a just and human socialist order; further notes that the Great October Socialist Revolution elevated in practice that the class struggle is the driving force of history and thus the South African Communist Party used the 107th anniversary celebration to mobilise and organise South Africa's working class against the capitalist crisis of rising cost of living and called for the expansion of VAT-exempt basic products, a decisive advance towards a comprehensive social security system, a comprehensive poverty eradication programme, fair pricing in retail, the comprehensive implementation of NHI; the implementation of the BELA Bill (including clauses 4 and 5), a public employment programme, getting rid of budget cuts, the transformation of monetary policy and the Reserve Bank, re-industrialisation and sectoral policy, the revitalisation of state-owned enterprises and public development finance institutions and the transformation of the financial sector to serve the working class; and notes that this provincial government has immense lessons to learn from this revolution.
2. Mr B Ngqentsu: That the House notes with deep concern the recent statement made by the Democratic Alliance (DA) MP Ian Cameron regarding the escalating gun violence in the Western Cape, particularly in areas such as Manenberg, where three lives were tragically lost and four others were injured this past weekend; further notes that, while acknowledging the alarming rise in gun violence, it is imperative that we do not allow this serious issue to be mischaracterised or used as a political gimmick; acknowledges that Ian Cameron's statement, while highlighting the need for effective policing, fails to address the root causes of this violence, which are deeply embedded in the persistent crisis of chronic underdevelopment of working-class communities in the Western Cape and the ongoing socio-economic challenges that our people face, which include poverty,

unemployment and inequality; further acknowledges that the escalation of gun violence in the province cannot be seen in isolation from the broader socio-economic conditions that prevail in many of these crime-ridden communities, including Manenberg and the other 13 crime hotspots; appreciates that the lack of economic opportunities, the systemic neglect by the provincial government and municipalities, particularly the City of Cape Town, and the inadequate focus on social services have all contributed to an environment where violence thrives; educates Cameron that the fight against crime is not simply a matter of policing, but of creating communities that are empowered, economically active and equipped with the resources necessary to overcome the conditions that breed criminality, and so it is factually incorrect for an apartheid apologist like Ian Cameron to place disproportionate blame on national structures like the South African Police Service (SAPS) and also use the crisis of crime to advance the DA's misplaced devolution of police powers without acknowledging the role of provincial and local governments in addressing the underlying social issues that contribute to crime; and calls on the provincial government, particularly the DA-led City of Cape Town, to take responsibility for the chronic underdevelopment of working-class communities in the Western Cape and to commit to greater investment in social infrastructure, housing, education and job creation.

3. Ms R Windvogel: That the House notes with deep concern the disturbing fact that companies implicated in the corruption of the procurement of personal protective equipment (PPE) during the COVID-19 pandemic continue to do business with the government, despite the findings of the Special Investigating Unit (SIU); further notes that it is particularly alarming that in the Western Cape the company Masiqhame Trading, which was identified as a key player in PPE corruption during the pandemic, continues to secure lucrative multi-year contracts with the provincial government and that this is not only a violation of the public trust but an affront to the efforts of those who are working tirelessly to ensure transparency and accountability in government procurement; further notes that, despite the damning findings of the SIU, Masiqhame Trading has not been blacklisted nor has any substantial action been taken to prevent it from benefiting from taxpayer money through ongoing contracts with the Western Cape provincial government and that this situation is utterly unacceptable, and it raises serious questions about the political will and moral leadership of those in positions of power, particularly Premier Alan Winde; acknowledges that, while Premier Winde has often spoken out vehemently against corruption, yet his actions – or lack thereof – suggest a far more complacent attitude towards those implicated in corruption in his own province as he has failed to take meaningful action against Masiqhame Trading, a company that has been at the centre of one of the most shameful instances of corruption in the history of the Western Cape; and calls on Premier Alan Winde and Minister David Maynier to demonstrate true leadership and integrity by immediately taking action against Masiqhame Trading and any other companies implicated in PPE corruption as the time is now for Premier Winde to back his strong rhetoric with real, decisive action as the public deserves more than words: they deserve accountability and the assurance that no company – no matter how well-connected – will be allowed to profit from corruption at the expense of the people of the Western Cape.
4. Ms A P Bans: That the House notes with great pride and appreciation the decrease in the official unemployment rate, which has dropped by 1,4 percentage points to 32,1% in the third quarter of 2024 (Q3: 2024), compared to the second quarter of 2024 (Q2: 2024); celebrates the positive employment outcomes as highlighted in the Quarterly Labour Force Survey for Q3: 2024, which show a promising trend in job creation across key sectors of

the economy; acknowledges and commends the ongoing efforts by the ANC-led government in driving sustainable job creation and economic growth, recognising that this reduction in unemployment is not a mere statistical shift but a tangible outcome of targeted interventions to stimulate economic activity, to expand opportunities for work and to empower previously marginalised communities; recognises that this achievement is a direct reflection of the ANC's transformative policies and the strategic implementation of initiatives outlined in the 2024 election manifesto, which prioritises economic stability, inclusive growth and the creation of meaningful, sustainable jobs for all South Africans, particularly the youth and women who have been hardest hit by unemployment; affirms the ANC's commitment to reducing unemployment further through continued investment in skills development, infrastructure and support for small and medium enterprises (SMEs), as well as addressing the structural challenges that continue to have an impact on the labour market, especially in rural areas; and calls on all sectors of society to continue to support and build on these efforts, ensuring that the trajectory of job creation and economic empowerment continues to gain momentum in the coming quarters, as we strive towards a more equitable and prosperous South Africa for all.

5. Ms A P Bans: That the House notes and calls on Premier Alan Winde to expedite the implementation of lifestyle audits for all members of his Cabinet in order to ensure transparency, accountability and the integrity of the provincial government; further notes and recommends that the scope of these lifestyle audits be expanded to include senior and top managers in the provincial government, particularly directors and chief directors, who hold significant influence over departmental decision-making and resource allocation; further notes with great concern the growing number of reports and reliable information regarding deeply entrenched corruption in various provincial government departments where certain officials at senior levels have reportedly captured entire departments for personal gain and are actively perpetuating a culture of cronyism and nepotism; highlights that this corruption undermines the effective delivery of services to the people of the Western Cape, breeds inefficiency and contributes to the erosion of public trust in the provincial government; emphasises the need for urgent action to address these systemic issues of corruption, capture and patronage, which have not only allowed corrupt practices to flourish, but have also obstructed the Province's ability to operate in an open and accountable manner; calls for the establishment of a transparent and independent mechanism to oversee the lifestyle audits, ensuring that the process is free from political interference and that any findings are acted upon decisively, with the appropriate disciplinary actions taken against individuals found to be engaging in corrupt activities; and further urges Premier Alan Winde to show strong leadership in this regard, making it clear that there will be no tolerance for corruption in his administration and that steps will be taken to restore the integrity of the provincial government and to ensure that public resources are used for the benefit of all citizens, not for personal enrichment.

KENNISGEWING VAN VOORSTELLE (21 November 2024)

1. Mnr F C Christians: Dat die Huis kennis neem van die begrotingsbesnoeiings van die Departement van Gesondheid en Welstand soos in die Nasionale Mediumtermyn-beleidsverklaring vermeld; en kennis neem van die uitwerking wat dit op hierdie kritieke frontliniediens in die Wes-Kaap sal hê.

2. Me A P Bans: Dat die Huis met diepe kommer kennis neem van die ernstige bewerings van korrupsie, baantjies vir boeties, kaping en wanadministrasie in die Wes-Kaapse Departement van Mobiliteit, veral die beweerde betrokkenheid van senior amptenare, soos Deidre Riboonaar, Kyle Reinecke, Ricardo Collins, Gamza Martin en Farrel Payne, wat aangekla word van persoonlike verryking deur luukse eiendomme, vlote duur voertuie, en die aanstelling van familieledes om gerieflike regeringsposte; verder kennis neem dat maatskappye, wat na bewering met hierdie amptenare verbind word, soos PEGASYS en ROUTE MASTER, aan wie winsgewende meerjarige kontrakte toegeken is, kommer wek oor belangebotsings en korrupsie; verder kennis neem dat, ten spyte van Premier Alan Winde se erkenning dat hy kennis van hierdie bewerings gedra het, die geïmpliseerde amptenare nie geskors is hangende die ondersoek nie, wat lei tot kommer oor die Premier se onbekommerdheid en gebrek aan beslissende optrede; en dus 'n beroep op Premier Winde doen om aan die Huis die tydlyne en omvang van die ondersoek wat hy beweer dat hy na hierdie aangeleenthede ingestel het, te verstrek, en dat die Komitee oor Openbare Rekening (KOR) die Departement van Mobiliteit en sy Minister versoek om voor hom te verskyn om rekenskap oor hierdie ernstige bewerings te gee; en verder 'n beroep op die Huis doen om beslissende stappe te doen om toe te sien dat korrupsie in die Wes-Kaapse Regering uitgeroei word, dat deursigtigheid gehandhaaf word en dat diegene wat verantwoordelik is, tot verantwoording geroep word.

KENNISGEWING VAN VOORSTELLE (14 November 2024)

1. Mnr B Ngqentsu: Dat die Huis kennis neem van en aansluit by die internasionale sosialistiese beweging ter viering van die 107e herdenking van die 1917 Groot Oktober-sosialistiese revolusie en, soos opgemerk deur Nikos Mottas in die sosialistiese joernaal *In Defense of Communism: The Marxist-Leninist Blog*, lê die betekenis van die Groot Oktober-sosialistiese revolusie daarin dat dit histories die eerste bewustelike stap was in die oorgang van die barbaarse, gewelddadige en onmenslike stelsel van kapitalisme na sosialisme, en die afskaffing van mens deur mens; erkenning gee dat, in teenstelling met bourgeois-geleerdes en die media wat nog altyd die Groot Oktober-revolusie as 'n "staatsgreep" wou uitbeeld, die Groot Oktober-sosialistiese revolusie die produk was van 'n georganiseerde werkersklasstryd gelei deur die groot Lenin en Bolsjewiste om 'n regverdige en menslike sosialistiese bestel in te lei; verder kennis neem dat die Groot Oktober-sosialistiese revolusie in die praktyk uitgewys het dat die klassestryd die dryfveer van die geskiedenis is en dus het die Suid-Afrikaanse Kommunistiese Party die 107e bestaansjaarviering gebruik om Suid-Afrika se werkersklas te mobiliseer en te organiseer teen die kapitalistiese krisis van stygende lewenskoste en gevra vir die uitbreiding van BTW-vrygestelde basiese produkte, beslissende vordering in die rigting van 'n omvattende maatskaplikesekerheidstelsel, 'n omvattende armoede-uitwissingsprogram, billike kleinhandelspryse, die omvattende implementering van NGV; die implementering van die BELA-wetsontwerp (insluitend klousule 4 en 5), 'n openbare indiensnemingsprogram, die verwydering van begrotingsbesnoeiings, die transformasie van monetêre beleid en die Reserwebank, herindustrialisering en 'n sektorale beleid, die herlewing van ondernemings in staatsbesit en openbare ontwikkelingsfinansieringsinstellings en die transformasie van die finansiële sektor om die werkersklas te dien; en kennis neem dat hierdie provinsiale regering groot lesse uit hierdie revolusie kan leer.
2. Mnr B Ngqentsu: Dat die Huis met diepe kommer kennis neem van die onlangse verklaring wat Ian Cameron, LP van die Demokratiese Alliansie (DA), gemaak het oor die stygende wapengeweld in die Wes-Kaap, veral in gebiede soos Manenberg, waar drie mense hul

lewens tragies verloor het en vier ander beseer is in die afgelope naweek; verder kennis neem dat, alhoewel ons die kommerwekkende toename in wapengeweld erken, dit noodsaaklik is dat ons nie toelaat dat hierdie ernstige kwessie verkeerd gekarakteriseer word of as 'n politieke foefie gebruik word nie; erkenning gee dat Ian Cameron se verklaring, hoewel dit die behoefte aan doeltreffende polisiëring beklemtoon, versuim om aandag te skenk aan die grondoorsake van hierdie geweld, wat diep gewortel is in die voortgesette krisis van chroniese onderontwikkeling van werkersklasgemeenskappe in die Wes-Kaap en die voortdurende sosio-ekonomiese uitdagings wat ons mense in die gesig staar, wat armoede, werkloosheid en ongelykheid insluit; verder erkenning gee dat die styging in wapengeweld in die provinsie nie in isolasie gesien kan word van die breër sosio-ekonomiese toestande wat in baie van hierdie misdaadgeteisterde gemeenskappe heers nie, insluitend Manenberg en die ander 13 misdaadbrandpunte; begryp dat die gebrek aan ekonomiese geleentheid, die stelselmatige verwaarloosing deur die provinsiale regering en munisipaliteite, veral die Stad Kaapstad, en die onvoldoende fokus op maatskaplike dienste saam bygedra het tot 'n omgewing waar geweld floreer; Cameron opvoed dat die bekamping van misdaad nie bloot 'n kwessie van polisiëring is nie, maar insluit om gemeenskappe te skep wat bemagtig is, ekonomies aktief is en toegerus is met die nodige hulpbronne om die toestande wat misdadigheid kweek, te oorkom, en dus is dit feitelik verkeerd vir 'n apartheidsapologeet soos Ian Cameron om buitensporige blaam op nasionale strukture soos die Suid-Afrikaanse Polisiediens (SAPD) te plaas en ook die misdaadkrisis te gebruik om die DA se misplaaste afwenteling van polisiebevoegdheid te bevorder sonder om die rol van provinsiale en plaaslike regerings te erken in die aanpak van die onderliggende maatskaplike kwessies wat tot misdaad bydra; en 'n beroep op die provinsiale regering, veral die DA-geleide Stad Kaapstad, doen om verantwoordelikheid te aanvaar vir die chroniese onderontwikkeling van werkersklasgemeenskappe in die Wes-Kaap en om hulle te verbind tot groter belegging in maatskaplike infrastruktuur, behuising, onderwys en werkskepping.

3. Me R Windvogel: Dat die Huis met diepe kommer kennis neem van die ontstellende feit dat maatskappy wat betrokke was by korrupsie met die verkryging van persoonlike beskermende toerusting (“personal protective equipment” of PPE) tydens die COVID-19-pandemie steeds met die regering sake doen, ondanks die bevindings van die Spesiale Ondersoekendeheid (SOE); verder kennis neem dat dit veral kommerwekkend is dat die maatskappy Masiqhame Trading, wat tydens die pandemie as 'n sleutelspeler in PPE-korrupsie geïdentifiseer is, in die Wes-Kaap steeds winsgewende meerjarige kontrakte met die provinsiale regering sluit en dat dit nie net 'n skending van die publiek se vertroue is nie, maar 'n belediging van die pogings van diegene wat onvermoeid werk om deursigtigheid en aanspreeklikheid in staatsverkryging te verseker; verder kennis neem dat, ten spyte van die verdoemende bevindinge van die SIU, Masiqhame Trading nie op die swartlys geplaas is nie en daar ook nie enige wesenlike stappe gedoen is om te verhoed dat dit voordeel trek uit belastingbetalersgeld deur voortgesette kontrakte met die Wes-Kaapse provinsiale regering nie en dat hierdie situasie heeltemal onaanvaarbaar is, wat ernstige vrae laat ontstaan oor die politieke wil en morele leierskap van diegene in magsposisies, veral Premier Alan Winde; erkenning gee dat, hoewel Premier Winde hom dikwels heftig teen korrupsie uitgespreek het, sy optrede – of gebrek daaraan – egter dui op 'n veel meer onbekommerde houding teenoor diegene wat by korrupsie in sy eie provinsie betrokke is, aangesien hy versuim het om betekenisvolle stappe teen Masiqhame Trading te doen, 'n maatskappy wat die middelpunt was van een van die mees skandaligste gevalle van korrupsie in die geskiedenis van die Wes-Kaap; en 'n beroep op Premier Alan Winde en

Minister David Maynier doen om ware leierskap en integriteit te toon deur onmiddellik stappe te neem teen Masiqhame Trading en enige ander maatskappye wat by PPE-korrupsie betrokke was, te doen aangesien die tyd aangebreek het vir Premier Winde om sy sterk retoriek met werklike, beslissende optrede te ondersteun aangesien die publiek meer as woorde verdien: hulle verdien aanspreeklikheid en die versekering dat geen maatskappy – maak nie saak hoe invloedryk nie – toegelaat sal word om voordeel te trek uit korrupsie ten koste van die mense van die Wes-Kaap nie.

4. Me A P Bans: Dat die Huis met baie trots en waardering kennis neem van die afname in die amptelike werkloosheidskoers, wat in die derde kwartaal van 2024 (K3: 2024) met 1,4 persentasiepunte tot 32,1% gedaal het, vergeleke met die tweede kwartaal van 2024 (K2: 2024); verheug is oor die positiewe indiensnemingsuitkomst soos uitgelig in die Kwartaallikse Arbeidsmagopname vir K3: 2024, wat 'n belowende tendens ten opsigte van werkskepping in sleutelsektore van die ekonomie aantoon; erkenning gee aan en die voortdurende pogings aanprys van die ANC-geleide regering om volhoubare werkskepping en ekonomiese groei te dryf, met die erkenning dat hierdie vermindering in werkloosheid nie 'n blote statistiese verskuiwing is nie, maar 'n tasbare uitkoms van geteikende ingrypings om ekonomiese aktiwiteit te stimuleer, om geleenthede vir werk uit te brei, en om voorheen gemarginaliseerde gemeenskappe te bemagtig; erkenning gee dat hierdie prestasie 'n regstreekse weerspieëling is van die ANC se transformerende beleid en die strategiese implementering van inisiatiewe soos uiteengesit in die 2024-verkiesingsmanifes, wat ekonomiese stabiliteit, inklusiewe groei en die skepping van betekenisvolle, volhoubare werkgeleenthede vir alle Suid-Afrikans, veral die jeug en vroue wat die swaarste deur werkloosheid getref is, te prioritiseer; die ANC se verbintenis bevestig om werkloosheid verder te verminder deur voortgesette belegging in vaardigheidsontwikkeling, infrastruktuur en ondersteuning vir klein en medium ondernemings (KMO's), asook deur die skenk van aandag aan die strukturele uitdagings wat steeds 'n impak op die arbeidsmark het, veral in landelike gebiede; en 'n beroep op alle sektore van die samelewing doen om voort te gaan om hierdie pogings te ondersteun en daarop voort te bou ten einde te verseker dat die trajek van werkskepping en ekonomiese bemagtiging voortgaan om momentum te kry in die komende kwartale, terwyl gestreef word na 'n meer regverdig en welvarende Suid-Afrika vir almal.
5.
