Mr B D Joseph: In view of the current wage dispute involving the Robertson Winery, the need for a living wage in the wine industry, and the plight of agricultural workers in the Western Cape.

- 1. Ms T M Dijana moved: That the House debates the insufficient CCTV cameras in crime hotspots in Khayelitsha and other townships and on the Cape Flats and the negative impact it has on the fight against crime.
- 2. Mr M G E Wiley moved: That the House debates the implications of the High Court's finding of 15 September 2016 wherein Mr Fransman's desperate attempts to avoid scrutiny by the WCPP's Standing Committee on Public Accounts were dismissed with costs.

Mr S G Tyatyam moved: That the House notes with concern the increase in business and cash-in-transit robberies in the Western Cape; further notes that the DA-run provincial government is promoting theses robberies as it has done nothing to address the situation; and commends the South African Police Service for intensifying its fight against these criminals.
- 9. Mr M Mnqasela moved: That the House congratulates Ms H Zille, the Premier of the Western Cape, on the release of her book entitled *Not without a Fight*.
- 10. Ms L M Maseko moved: That the House congratulates Premier H Zille for being able to outline the National Nine-Point Plan while President J G Zuma was only able to outlined one of the points.
