NOTICES OF MOTION

- 1. Mr L L Mvimbi moved: That the House acknowledges and appreciates the efforts and contributions made by MPPs during the presentation of the annual reports and the reports by the Auditor-General, especially the Members of Scopa who had to leave these premises late in the evenings due to their commitment to hold the executive to account; a special word of thanks to Hon Members Baartman, Maseko, America and Xego, as well as the Hon Member Nkondlo, for standing in for me in an acting capacity.
- 2. Ms L J Botha moved: That the House debates the 5% budget cut and the impact it will have on services provided by the Western Cape Department of Education.
- 3. Ms A Bans moved: That the House notes with concern the recent reports of the suspension of a senior employee in the Department of Cultural Affairs and Sport on the grounds of sexual harassment; notes further that this is concerning given the issue of gender-based violence and sexual offences in the province and thus highlighting the importance of a previously mentioned motion presented by the ANC to implement a vetting system for all government employees in the province; and calls on the Minister to ensure that the official remains suspended until the case is concluded.

- 4. Mr C M Dugmore moved: That the House debates the implications of the recent judgment by Judge Melebo Habedi in the Gauteng High Court that dismissed the application by former Premier Zille, who is now Chairperson of the DA's Federal Executive Council, to set aside the Public Protector's finding that the former Premier's tweets about colonialism did not comply with the provisions of Constitution and with the Executive Ethics Code contained in the Executive Members Ethics Act, 1998 (Act 82 of 1998).
- 5. Ms D M Baartman moved: That the House debates the Integrated Resource Plan 2019.
- 6. Mr F C Christians moved: That the House debates the Comprehensive Sexuality Education (CSE) curriculum for 2020.
- 7. Mr M K Sayed moved: That the House notes with concern reports of ill-treatment of teachers by other teachers at the Die Bron Primary School in Stanford, which has since led to the resignation of one educator; notes further that the alleged ill-treatment has resulted in divisions among parents at the school, leading to the formation of groups, like the IsiXhosa Parents Group, that are feeling very frustrated with the attitude of the Die Bron Primary School SGB and the lack of urgency to address their concerns; notes further that their concerns include racism at the school, including a teacher at the school who allegedly slammed a child's head down on his desk and called him the K word and learners who are enduring racist slurs and bullying at school daily; and calls for an urgent investigation into these concerns and intervention.
- 8. Mr D Smith moved: That the House notes the ongoing decline of the DA in the province and that it continues to lose support daily; notes further that, besides the by-election blow in Matzikama yesterday where the ANC has taken the DA ward in Vredendal to govern that municipality, the DA has also lost the Speaker of the Stellenbosch Municipality, Wilhelmina Petersen, who resigned unexpectedly and without giving a reason.
- 9. Mr M K Sayed moved: That the House notes with concern that many learners again face being unplaced at schools in the next academic year as we have been inundated with many cries for assistance from parents whose children were rejected with inconsistent reasoning being applied; and calls for an investigation into allegations that 90% of children from poor working-class backgrounds have not been accepted at these schools when they applied on time and after having submitted all the required documents.
- 10. Ms R Windvogel moved: That the House debates the sickening account of a Swellendam farmer who shot a bystander farmworker at Buffelsjag after the farmer shot another's cow; and further notes that nobody from this provincial DA-run government has even attempted to have this incident investigated despite numerous requests to have such abuse of workers by farmers reported to the DA government.
- 11. Ms N G Bakubaku-Vos moved: That the House notes the sudden withdrawal of Bonginkosi Madikizela, Western Cape DA leader, as the third contender for the national leadership of the DA; and notes that commentators find it strange that a favourite of the DA's English liberal Helen Zille jumped even before the race had started.

- 12. Ms A Bans moved: That the House notes with dismay the employment at great expense of an outsider artist for the upcoming switching-on of festivity lights in Cape Town thereby snubbing the many local artists who could have served their local community better at this level.
- 13. Mr M Kama moved: That the House notes that the DA stands behind the door in its attempt to shift the blame for political meddling to the ANC in the matter of the appointment of a provincial police commissioner as the DA has for many years led a campaign against certain senior SAPS officers; and notes that its DA Minister, Albert Fritz, serves on a panel that looks at the available candidates.
- 14. Mr M K Sayed moved: That the House notes with concern that the Northpine School, which is next to a church, will host a karaoke event on 22 November 2019 in which people are encourage to bring their own liquor; notes further that there is no mention of the sale of liquor in the circulated leaflet, but people are encouraged rather to bring their own liquor to the event; accepts that the WCED has now converted our schools to alcohol-consuming spaces; and calls for an urgent investigation into the event.
- 15. Mr L L Mvimbi moved: That the House notes that Cape Town is in serious trouble with dissatisfied motorists and is about to change its parking and charge system to please the electorate ahead of the upcoming municipal elections.
- 16. Mr D Smith moved: That the House notes that the wealthy area of the Atlantic Seaboard including Sea Point has now joined Cape Town in requesting an interdict to enforce its by-laws to fine homeless people and to rob them of their meagre earnings.
