MOTION

Mr G Bosman: That the House, pursuant to the resolution it adopted on 29 August 2024 to revive the consideration of the Constitution of the Western Cape Amendment Bill (Determination of number of Members) [B 6B–2023] from the stage it reached during the Sixth Parliament, hereby refers the Amendment Bill to the Standing Committee on the Premier and Constitutional Matters for consideration and reporting.

Provincial Economic Review and Outlook – Ms D M Baartman, Minister of Finance.

FURTHER BUSINESS

NOTICES OF MOTION (19 September 2024)

1. Ms T Lithakong: That the House notes that on Friday 13 September 2024 the President of this country officially signed the Basic Education Laws Amendment Bill (BELA Bill) into law, a move that must be welcomed by all South Africans; further note that the purpose of the BELA Act is to respond to administrative challenges that continue to face schools in this country, as well as transforming our basic education system; notes that the good thing about this new piece of legislation is that it makes Grade R compulsory, as well as giving power to provincial heads of departments to have a final say when it comes to administering language policy in schools, a function previously reserved to school governing bodies and which was abused; notes that, in the past, SGBs from former Model C schools would use a language, such as Afrikaans, as the only medium of instruction in schools as a gatekeeping mechanism so that they can exclude the majority of African learners from being admitted to those schools; and hopes that the President will not be held at ransom by certain political parties and organisations in incorporating the outstanding provisions of this act into law after the three-month period.

2. Mr B Ngqentsu: That the House notes with deep concern and condemns in the strongest terms possible the attempts by the City of Cape Town to dismiss approximately 47 Law Enforcement Advancement Plan (LEAP) officers without following due process; further notes that this action is particularly alarming given that the cases of about 108 LEAP officers who were unfairly dismissed earlier this year are still pending before the bargaining council; appreciates the leadership role of the South African Municipal Workers Union (SAMWU) as it continues to challenge these unjust dismissals, particularly by the anti-worker DA-led City of Cape Town; acknowledges that the fighting capacity of SAMWU will reveal the underlying political rationale behind the treatment of LEAP officers and how they are exploited; calls for the immediate reinstatement of the 108 LEAP officers and demands that the City abandons the planned unfair dismissal of the 47 officers; accepts that the continued unfair dismissal of these vulnerable LEAP officers suggests a double standard on the part of the City, contradicting its assertions that LEAP officers are essential and effective in combating crime in Cape Town; reiterates calls for JP Smith to be summoned to appear before the committees to account for the implementation of the Western Cape Safety Plan, which continues to be a big, expensive failure; and further calls on the DA-led City to come clean about this LEAP officers project.
3. Mr B Ngqentsu: That the House notes and extends its heartfelt congratulations to comrade Yershen Pillay, CEO of the Chemical Industries Education and Training Authority (CHIETA), for his outstanding leadership and the achievement of a clean audit; further notes with great admiration that under his stewardship the CHIETA has not only met but surpassed its targets, as evidenced by the clean audit award; appreciates Comrade Pillay's recent statement that clean audits must translate into sustainable livelihoods, which acknowledges CHIETA's commitment to sustainable livelihoods through exemplary governance and impactful skills development; commends Comrade Yershen, a communist, for his dedication to enhancing the quality of life through job creation and skills development, as evidenced by the creation of 7 893 jobs, the support provided to 630 entities in the small, medium and micro enterprises (SMME) sector, and the training of 2 286 artisans, which is testament to his effective leadership; extends congratulations to Comrade Yershen Pillay and the entire CHIETA team for their unwavering dedication and exceptional performance, hoping that their achievements will inspire the DA-led administrations in the Western Cape provincial government and various municipalities to understand that clean audits are not merely a celebration of compliance, but a stepping stone towards continued performance and positive impact on our communities and country; and appreciates that Pillay's exemplary leadership is a demonstration that the ANC and SACP continue to produce excellent cadres.
4. Ms R Windvogel: That the House notes with deep concern the alarming rise in extortion targeting social workers and other government employees operating in vulnerable communities in the City of Cape Town; further notes that the recent incidents in Delft, where social workers were threatened, and the recent series of hijackings involving waste services vehicles operated by the City of Cape Town, highlight the urgent need for action; recognises the continued targeting of government officials not only endangers their lives, but also negatively impacts the communities that rely on their vital services; condemns these senseless attacks on government officials; and calls for decisive interventions to protect government officials who dedicate their lives to serving the most vulnerable among us.

5. Ms R Windvogel: That the House notes with deep concern and condemns in the strongest possible terms the recent display of the Ukrainian flag at the Cape Town City Hall on Ukraine Flag Day; further notes that this was a desperate and reprehensible act that disrespects the legacy of Nelson Mandela and undermines South African sovereignty; concurs with the sentiments expressed by Lindiwe Sisulu, who condemned this incident as an example of “performative white supremacy” and an attempt by Ukrainian nationalists to exploit a historically significant location for their own agenda; recognises that the Cape Town City Hall is a site of immense historical importance, symbolising the end of apartheid and the birth of a new democratic era in South Africa, and that its use in this context diminishes the sacred memory associated with Nelson Mandela’s first public address following his release from prison in 1990; accepts that the actions of the Ukrainian Association of South Africa in facilitating this display were distasteful and disrespectful to our national sovereignty and that such acts threaten to undermine the historical significance of our monuments and institutions, which should serve as reminders of our struggle for freedom and justice; and calls for the implementation of appropriate measures to prevent similar incidents in the future and to safeguard the integrity of our historical sites.
6. Mr M K Sayed: That the House notes and welcomes the recent petition titled “Petition to Premier Alan Winde: Release Tafelberg for Social Housing Now” initiated by Reclaim the City and Ndifuna Ukwazi (NU); further notes that the petition, which advocates for the use of the Tafelberg site for social and affordable housing, particularly for domestic workers who serve in the area, has gathered over 60 signatures; supports the call for the Tafelberg site to be handed over to the City of Cape Town for development into much-needed social housing units; acknowledges that this petition aligns with the broader goal of addressing spatial segregation and socio-economic exclusion that have persisted since the end of apartheid; and calls for a comprehensive and inclusive approach to spatial redress in Cape Town, which includes the development of affordable housing in central areas that have historically been excluded from such initiatives.
7. Ms N D Nkondlo: That the House notes and expresses its profound concern regarding the recent trench collapse at the intersection of Broadway Boulevard and Broadlands Road in Strand, where workers were engaged in the installation of the new Gordon’s Bay rising pipeline; further notes that this tragic incident led to several construction workers being trapped in the sinkhole and suffering injuries; commends the swift and courageous response of emergency service personnel, whose prompt actions were crucial in rescuing the trapped workers and transporting them to hospital for medical attention; welcomes the visit by ANC MPPs to the site, as they sought to understand the causes of this accident and engaged directly with the affected workers; and calls on the DA-led subcouncil and ASLA, the company responsible for the construction project, to prioritise and strictly adhere to the highest safety standards to protect the welfare of all workers on site.

Mnr G Bosman: Dat die Huis, ooreenkomsdig die besluit wat op 29 Augustus 2024 aangeneem is om die oorweging van die Wysigingswetsontwerp op die Grondwet van die Wes-Kaapse (Bepaling van Getal Lede) [W 6B–2023] te hernuwe vanaf die stadium wat dit tydens die Sesde Parlement bereik het, hiermee die Wysigingswetsontwerp na die Staande Komitee oor die Premier en Grondwetlike Aangeleenthede vir oorweging en verslagdoening verwys.

VERDERE WERKSAAMHEDE

KENNISGEWING VAN VOORSTELLE (19 September 2024)

1. Me T Lithakong: Dat die Huis kennis neem dat die President van hierdie land op Vrydag 13 September 2024 die Wysigingswetsontwerp op Basiese Onderwyswette (“Basic Education Laws Amendment Bill” of BELA-wetsontwerp) amptelik onderteken het, ’n stap wat deur alle Suid-Afrikaners verwelkom moet word; verder kennis neem dat die doel van die BELA-wet is om te reageer op administratiewe uitdagings wat skole in hierdie land die hoof moet bied, asook om ons basiese onderwysstelsel te transformeer; kennis neem dat die goeie aspek van hierdie nuwe stuk wetgewing is dat dit graad R verpligtend maak, asook om die bevoegdheid aan provinsiale departementshoofde te gee om ’n finale sê te hê wanneer dit by die administrasie van taalbeleid in skole kom, ’n funksie wat voorheen vir die skoolbeheerliggame (SBL’s) gereserveer is en wat misbruik is; kennis neem dat SBL’s van voormalige Model C-skole in die verlede ’n taal, soos Afrikaans, as die enigste medium van onderrig in skole as ’n hekwagmeganisme sou gebruik sodat hulle die meerderheid swart leerders van toelating tot daardie skole kon uitsluit; en hoop dat die President nie deur sekere politieke partye en organisasies as gyselaar gehou sal word om nie die uitstaande bepalings van hierdie wet ná die driemaandtydperk in wet te inkorporeer nie.

2. MnB Ngqentsu: Dat die Huis met diepe kommer kennis neem van en die pogings van die Stad Kaapstad om ongeveer 47 beamptes van Law Enforcement Advancement Plan (LEAP) af te dank sonder om die behoorlike proses te volg ten sterkste veroordeel; verder kennis neem dat hierdie optrede besonder kommerwekkend is gegewe die feit dat die sake van ongeveer 108 LEAP-beamptes wat vroeër vanjaar onregverdig afdank is, steeds voor die bedingsraad dien; waardering uitspreek vir die leierskaprol van die Suid-Afrikaanse Municipale Werkersunie (“South African Municipal Workers Union” of SAMWU) wat voortgaan om hierdie onregverdigte afdankings teen te staan, veral deur die DA-geleide Stad Kaapstad wat teen werkers gesind is; erkenning gee dat die vegvermoë van SAMWU die onderliggende politieke rede vir die behandeling van LEAP-beamptes en hoe hulle uitgebuit word, aan die lig sal bring; 'n beroep doen vir die onmiddellike heraanstelling van die 108 LEAP-beamptes en eis dat die Stad die beplande onbillike afdanking van die 47 beamptes laat vaar; aanvaar dat die voortgesette onbillike afdanking van hierdie weerlose LEAP-beamptes 'n dubbele standaard aan die kant van die Stad is, wat sy bewerings weerspreek dat LEAP-beamptes noodsaklik en doeltreffend is in die bekamping van misdaad in Kaapstad; beroepe herhaal dat JP Smith gedagvaar word om voor die komitees te verskyn om verantwoording te doen oor die implementering van die Wes-Kaapse Veiligheidsplan, wat steeds 'n groot, duur mislukking is; en verder 'n beroep op die DA-geleide Stad doen om die waarheid oor hierdie LEAP-beampteprojek te openbaar.
3. MnB Ngqentsu: Dat die Huis kennis neem van en sy hartlike gelukwense uitspreek teenoor kameraad Yershen Pillay, HUB van die Onderwys-en-opleidingsowerheid vir die Chemiese Nywerheid (“Chemical Industries Education and Training Authority” of CHIETA), vir sy uitstaande leierskap en die behaling van 'n skoon outhui; verder met groot bewondering kennis neem dat die CHIETA onder sy rentmeesterskap nie net sy teikens behaal het nie, maar dit ook oortref het, soos blyk uit die toekenning van 'n skoon outhui; waardering uitspreek vir kameraad Pillay se onlangse stelling dat skoon outhuis in volhoubare lewensbestaan omgeskakel moet word, wat erkenning gee aan die CHIETA se verbintenis tot volhoubare lewensbestaan deur voorbeeldige bestuur en vaardigheidsontwikkeling wat 'n impak maak; kameraad Yershen, 'n kommunis, aanprys vir sy toewyding om lewensgehalte deur werkskepping en vaardigheidsontwikkeling te verbeter, soos blyk uit die skepping van 7 893 werkgeleenthede, die ondersteuning wat aan 630 entiteite in die sektor van klein, medium en mikro-ondernemings (KMMO) verskaf is, en die opleiding van 2 286 ambagslui, wat getuig van sy doeltreffende leierskap; kameraad Yershen Pillay en die hele CHIETA-span gelukwens met hul onwrikbare toewyding en uitsonderlike prestasie, en die hoop uitspreek dat hul prestasies die DA-geleide administrasies in die Wes-Kaapse provinsiale regering en verskeie munisipaliteite sal inspireer om te verstaan dat skoon outhuis nie bloot 'n viering van voldoening is nie, maar 'n tree is in die rigting van voortgesette prestasie en 'n positiewe impak op ons gemeenskappe en land; en waardering uitspreek vir Pillay se voorbeeldige leierskap wat 'n aanduiding is dat die ANC en SAKP sal voortgaan om uitstekende kaders op te lewer.
4. Me R Windvogel: Dat die Huis met diepe kommer kennis neem van die kommerwekkende toename in afpersing wat maatskaplike werkers en ander staatswerkemers teiken wat in weerlose gemeenskappe in die Stad Kaapstad werksaam is; verder kennis neem dat die onlangse voorvalle in Delft, waar maatskaplike werkers gedreig is, en die onlangse reeks kapings van afvaldienstevoertuie wat deur die Stad Kaapstad bedryf word, die dringende behoefté aan optrede beklemtoon; erkenning gee aan die volgehoue teikening van staatsamptenare nie net hul lewens in gevaar stel nie, maar ook 'n negatiewe impak het op

die gemeenskappe wat op hul noodsaaklike dienste staatmaak; hierdie sinnelose aanvalle op staatsamptenare veroordeel; en 'n beroep doen vir beslissende ingrypings om regeringsamptenare te beskerm wat hul lewens daaraan wy om die weerloosste mense onder ons te dien.

5. Me R Windvogel: Dat die Huis met diepe kommer kennis neem van en die onlangse vertoning van die vlag van Oekraïne by die Kaapstadse stadsaal op Oekraïnevlagdag ten sterkste veroordeel; verder kennis neem dat dit 'n desperate en laakkbare daad was wat die nalatenskap van Nelson Mandela minag en Suid-Afrikaanse soewereiniteit ondermyn; saamstem met die mening wat deur Lindiwe Sisulu uitgespreek is, wat hierdie voorval veroordeel het as 'n voorbeeld van "performatiewe wit oppergesag" en 'n poging deur Oekraïnse nasionaliste om 'n histories betekenisvolle plek vir hul eie agenda uit te buit; erkenning gee dat die Kaapstadse stadsaal 'n plek van ontsaglike historiese belang is, wat die einde van apartheid en die geboorte van 'n nuwe demokratiese era in Suid-Afrika simboliseer, en dat die gebruik daarvan in hierdie konteks die eerbiedwaardige herinnering skend wat met Nelson Mandela se eerste openbare rede geassosieer word ná sy vrylating uit die tronk in 1990; aanvaar dat die optrede van die Oekraïnse Vereniging van Suid-Afrika om hierdie vertoning te faciliteer onsmaklik en oneerbiedig teenoor ons nasionale soewereiniteit is en dat sulke dade dreig om die historiese betekenis van ons monumente en instellings te ondermyn, wat as herinneringe moet dien aan ons stryd om vryheid en geregtigheid; en 'n beroep doen op die implementering van toepaslike maatreëls om soortgelyke voorvalle in die toekoms te voorkom en om die integriteit van ons historiese terreine te beskerm.
6. Mn M K Sayed: Dat die Huis kennis neem van en die onlangse petisie getiteld "Petisie aan Premier Alan Winde: Stel Tafelberg nou vir maatskaplike behusing vry" ("Petition to Premier Alan Winde: Release Tafelberg for Social Housing Now") verwelkom wat deur Reclaim the City en Ndifuna Ukwazi (NU) geïnisieer is; verder kennis neem dat die petisie, wat die gebruik van die Tafelberg-terrein vir maatskaplike en bekostigbare behusing bepleit, veral vir huiswerkers wat in die gebied werk, meer as 60 handtekeninge ingesamel het; die oproep ondersteun dat die Tafelberg-terrein aan die Stad Kaapstad oorhandig moet word vir ontwikkeling as broodnodige maatskaplikebehusingseenhede; erkenning gee dat hierdie petisie strook met die breër doelwit om aandag te skenk aan ruimtelike skeiding en sosio-ekonomiese uitsluiting wat voortgeduur het sedert die einde van apartheid; en 'n beroep doen op 'n omvattende en inklusieve benadering tot ruimtelike regstelling in Kaapstad, wat die ontwikkeling van bekostigbare behusing in sentrale gebiede insluit wat histories van sulke inisiatiewe uitgesluit is.
7. Me N D Nkondlo: Dat die Huis kennis neem van en sy diepe kommer uitspreek oor die onlangse slootineenstorting by die kruising van Broadway-boulevard en Broadlandsweg in die Strand, waar werkers besig was met die installering van die nuwe Gordonsbaaise stygende pyplyn; verder kennis neem dat hierdie tragiese voorval daartoe geleid het dat verskeie konstruksiewerkers in die sinkgat vasgekeer was en beserings opgedoen het; die vinnige en dapper reaksie van die nooddienpersoneel aanprys wie se vinnige optrede deurslaggewend was om die vasgekeerde werkers te red en na die hospitaal vir mediese aandag te vervoer; die besoek deur ANC-LPP's aan die terrein verwelkom, aangesien hulle probeer het om die oorsake van hierdie ongeluk vas te stel en direk met die geraakte werkers in gesprek was; en 'n beroep op die DA-geleide subraad en ASLA, die maatskappy verantwoordelik vir die konstruksieprojek, doen om die hoogste veiligheidstandaarde te prioritiseer en streng na te kom om die welsyn van alle werkers op die terrein te beskerm.

UMnu B Ngqentsu: Sokuba iNdlu iqaphela ngenkxalabo enzulu kwaye igxibha ngeyona ndlela imizamo yeSixeko seKapa yokugxotha phantse ama-47 amagosa eSicwangciso sokuSa Phambili uNyanzelo IwezoMthetho (LEAP) ngaphandle kokulandela iinkqubo ezifanelekileyo; iphindia iqaphele ukuba eli nyathelo ingakumbi liyaxhalabisa phantsi kokuba kukho umba wamatyala amagosa e-LEAP amalunga ne-108 athe agxothwa ngokungenablunga ebutsheni balo nyaka ukuba akakaqukunjelwa ngexa asephambi kwebhunga lolamlo; yamkela indima yesikhokelo soMbutho weManyano yooMasipala woMzantsi Afrika (SAMWU) njengoko uqhuba ufaka umngeni kolu gxotho lungenabulungisa, ingakumbi siSixeko seKapa esikhokelwa yi-DA esingabafuniyo abasebenzi; iyanakana ukuba isakhono sokulwa se-SAMWU siza kubhentsisa isizathu sezopolitiko esisemva kwempatho yamagosa e-LEAP nendlela axhatshazwa ngayo; imemelela ubuyiselo kwakhona olungxamisekileyo lwamagosa e-LEAP ali-108 kwaye inyanzelsia ukuba esi Sixeko siyeke olu gxotho lucwangcisiweyo lungenabulunga lwamagosa angama-47; yamkela ukuba ugxothe olungenabulunga lwala magosa abuthathaka e-LEAP lubonisa ubungqangangqwili kwicalo leSixeko, lukhabana amabango aso okuba amagosa e-LEAP abalulekile kwaye esebezena ekuthinteleni ulwaphulo-mthetho eKapa; iphindia kwakhona amakhwelo ayo okuba uJP Smith afakelwe umsila wengwe ukuba avele phambi kweekomiti ukuze anike inkcaza ngoqaliso IweSicwangciso sezoKhuseleko seNtshona Koloni, esiqhuba siyintsielelo enkulu, ebiza kakuhlu ngezimali; kwaye kwakhona imemelela kwiSixeko seKapa esikhokelwa yi-DA ukuba siveze elubala le prowujekthi yamagosa e-LEAP.
3. UMnu B Ngqentsu: Sokuba iNdlu iyaqaphela kwaye ithumela uvuyiswano Iwayo olungazenzisio kuqabane Yershen Pillay, i-CEO yeChemical Industries Education and Training Authority (CHIETA), ngobunkokheli bakhe obugqwesileyo kwakunye nemfezeko yophicotho-zincwadi olucocekileyo; iphindia iqaphele ngothakazelelo olukhulu ukuba phantsi kwesikhokelo sah i-CHIETA ayikhawulelenga kuphela kodwa igqithisile kokujoliswe kuko kwayo, njengoko kubonakele ngembasa yophicotho-zincwadi olucocekileyo; ibulela intatho yakutshanje kaQabane Pillay yokuba uphicotho-zincwadi olucocekileyo malukekelele kwiintsapho ezizinzileyo, olunakana ukuzibophelela kwe-CHIETA kwiintsapho ezizinzileyo ngorhulumento olungumzekelo kwakunye nophuhliso Iwezakhono olunefuthe; income uQabane Yershen, ikomanisi, ngokuzinikela kwakhe ekubhekiseni phambili umgangatho wobomi ngokusebenzisa udalo lwemisebenzi nophuhliso Iwezakhono, njengoko kubaonakele ngodalo lwemisebenzi ezngama-7 893, inkxaso ebonelelwa kumaqumrhu angama-630 kwicandelo lwamashishini, aphakathi kunye namancinanana (SMME), kunye noqequesho lwabachweli bangama-2 286, nto leyo ibubungqina kwisikhokelo sakhe esisebenezayo; ithumela uvuyiswano kuQabane Yershen Pillay kunye neqeal liphela le-CHIETA ngokuzibophelela kwabo okungagungqiyo kunye nomsebenzi wabo ogqwesileyo, ithemba ukuba iimfezeko zabo ziza kuvuselela ulawulo olukhokelwa yi-DA kurhulumente wephondo leNtshona Koloni kwakunye noomasipala abohlukeneyo ukuba baqaphela ukuba uphicotho-zincwadi olucocekileyo ayikuphela

kombhiyozo wothotyelo, kodwa llilitye lokuqabelo ukuya kumsebenzi oghubayo nefuthe elitsha kuluntu nelizwe lethu; kwaye yamkela ukuba isikhokelo esingumzekelo sikaPillay ngumboniso wokuba i-ANC kunye ne-SACP ziqhube zivelisa amaqabane aphume izandla.

4. UNksz R Windvogel: Sokuba iNdlu iqaphela ngenxalabo enzulu ulonyuko oloyikisayo lofunyano lwemali ngesinyanzelo ebantwini ngoonqevu ngeqhingga lokuba babayabakhusela olujoliswe koontlalontle kwakunye nabanye abaqeshwa bakarhulumente abasebenza kuluntu olubuthathaka kwiSixeko seKapa; iphinde iqaphele ukuba iziganeko zakutshanje eDelft, apho oontlalontle bethe bagrogriswa kwakunye nothotho loqweqwedisolubandakanya izithuthi zeenkonzo zeenkunkuma ezisetyenziswa siSiseko seKapa, iqaqambisa imfuno yenyathelo elingxamisekileyo; inakana ujoliso oluqhubayo Iwamagosa karhulumente alwenzakalisi kuphela ubomi bawo, kodwa lunefuthe elibi kuluntu oluxhomekeke kuwo kwiinkonzo zaho ezibalulekileyo; igxeka olu hlaselo lungaqiqanga kumagosa karhulumente; kwaye imemelela amangenelelo angqongqo ukukhusela amagosa karhulumente anikela ngobomi bawo ekukhonzeni abona babuthathaka phakathi kwethu.

UNksz R Windvogel: Sokuba iNdlu iqaphela ngenxalabo enzulu kwaye igxibha ngeyona ndlela ubonakaliso lwakutshanje lweflegi yase-Ukraine kwiHolo yeSixeko seKapa ngoSuku lweFlegi yase-Ukraine; iphinde iqaphele ukuba eli ibe ilinyathelo lobungqangangqwili nelikhalimekayo elidelela ilifa likaNelson Mandela kwanelisingela phantsi ukuzimela geze koMzantsi Afrika; ingqinelana neembono ezivakaliswe nguLindiwe Sisulu, ogxeke esi siganeko njengomzekelo “wobunganga bobumhlophe obuqqutwyayo” kwakunye nelinge lamanashinali ase-Ukraine ukuxhaphaza le ndawo iphawuleka ngokwezimbali ukufezekisa iinjongo zabo; iyanakana ukuba iHolo yeSixeko seKapa yindawo yembali yobaluleko olungenambaliso, ephawula ukuphela kwenqubo yengcinezelo kwakunye nokuzalwa kwenqubo entsha yedemokhasi eMzantsi Afrika, kwanokuba usetyenziso lwayo kulo mxholo lutshababalisa inkumbulo engcwele eyeyanyaniswa nentetho yokuqala yasesidlangularalen kaNelson Mandela kalandela ukukhululwa kwakhe entlongweni ngo-1990; iyamkela ukuba la manyathelo oMbutho wase-Ukraine waseMzantsi Afrika ekuququzeleleni le mbonakalo ebengaginyeki kwaye edelela ekuzimeleni kwethu kukazwelonek kwanokuba izenzi ezinje zigrogrisa ukusingela phantsi ubaluleko lwembali lwemiyeko namaziko ethu, angasebenza njengokusikhumbuza ngomzabalazo wenkululeko nobulungisa bethu; kwaye imemelela ekuqualisweni kwamanyathelo afanelekileyo ukuthintela iziganeko ezikumila kunje kwixa elizayo kwanokukhusela isidima seendawo zembali yethu.

UMnu M K Sayed: Sokuba iNdlu iyaqaphela kwaye yamkela isikhalaizo sakutshanje esinesihloko esithi “ISikhalaizo esiya kuNkulumbuso Alan Winde: Khululela iTafelberg kwezeziNdlu zeNtlalo Ngoku” esiqulunqwe yiReclaim the City kunye neNdifuna Ukwazi (NU); iphindia qaphela ukuba esi sikhalaizo, esizabalazela usetyenziso lwasiza saseTafelberg kwezezindlu zezentlalo nezifikelelekayo, ingakumbi kubasebenzi basemakhayeni abakhonza kule ndawo, siqokelele ngaphaya kwama-60 abatyikityi; ixhasa ikhwelo lokuba indawo yaseTafelberg inikezelwe kwiSixeko seKapa kupuhhliso ukuze ibe ziiyunithi zezezindlu zentlalo ezifunwa ngamandla; iyanakana ukuba esi sikhalaizo singqamana nenjongo exananazileyo yokuhoyana nolwahlulo lwezesithuba kwakunye nobukulo lwezentlalo-qoqosho olithe gqolo oko kwaphela inkqubo yengcinezelo; kwaye imemelela indlela eyondeleleneyo nequkayo ukubuyekeza isithuba eKapa, equka uphuhliso lwezezindlu ezifikelelekayo kwiindawo ezssembindini ebezibukulwe ngokwembali kumalinge anjalo.

UNksz N D Nkondlo: Sokuba iNdlu iyaqaphela kwaye ivakalisa inkxalayo yayo enkuI mayela nokuwa kumjelo kwakutshanje kwindlela enqumlezayo phakathi kweBroadway Boulevard neNdlela iBroadlands eStrand, apho abasebenzi babemaxhaphetshunofakelo lombhobho onyukayo omtsha waseGordon's Bay; iphindia iqaphela ukuba esi siganeko siyingozi sikhokelele kubasebenzi bokwakha abaliqela bebambeke kumngxuma amanzi kwaye befumana umonzakalo; income impendulo ekhawulezileyo neyobugorha yabasebenzi benkonzo kaxakeka, abamanyathelo akhawulezileyo athe abaluleka ekuhlanguleni abasebenzi ababambekileyo kwaye bebasas esibhedele ukuya kufumana ingqwalasela yezonyango; ymakela utelelo lwee-MPPs ze-ANC kule ndawo, njengoko bezizingela ukuqonda oonobangela bale ngozi zaze zancokola ngqo kunye nabasebenzi abachaphazelekilyo; kwaye imemelela kwibhunga elikhokelwa yi-DA no-ASLA, inkampani enoxanduva lwale proujkethi yolkwakhiwo, ukuba balule kwaye bothobele ngokungqongqo eyona migangatho yezokhuseleko eyakhe yaphezulu ukukhusela intlalontle yazo bonke abasebenzi kule ndawo.
