### **NOTICES OF MOTION (29 August 2024)**

1. Mr D G Jacobs: That the House acknowledges that gang violence on the Cape Flats has escalated to become the most pressing crime issue in the Western Cape; notes that, during the weekend of 28 June 2024 to 1 July 2024, the Cape Flats experienced a tragic toll of 120 fatalities and 90 injuries; further notes that a full-scale gang conflict appears to be emerging, with casualties surpassing those reported in the Russia–Ukraine conflict over a comparable period; acknowledges that the existing policing strategy is ineffective and requires an urgent reassessment, given the apparent lack of progress in investigations and the absence

of information regarding arrests and successful prosecutions; further acknowledges that our communities are not targets for violence and that the streets of the Cape Flats are stained with the blood of our children; and resolves that the current situation is intolerable and requires immediate action to address and resolve this crisis.

2. Ms B Stoffel: That the House debates the pervasive issues of corruption and dysfunction in our municipalities.
3. Mr F Kamfer: That the House debates the profound impact of drug and substance abuse in our province.
4. Ms R Windvogel: That the House debates the current state of education in the Western Cape.
5. The Chief Whip of the Majority Party (Mr G Bosman): That the Constitution of the Western Cape Amendment Bill (Determination of Number of Members) [B 7–2023] be considered from the stage that it reached during the Sixth Parliament.

#### **NOTICES OF MOTION (22 August 2024)**

1. Mr N Constable: That the House extends its heartfelt congratulations to the athletes who represented our nation with such distinction at this year's Olympics; notes that the athletes' dedication and excellence have not only highlighted their personal achievements but also elevated our country's pride on the global stage; notes that we also acknowledge the pivotal role played by Minister Gayton McKenzie in revitalizing the Department of Sport, Arts and Culture; notes that his leadership and focus have greatly enhanced the performance and outlook of our entire government; notes that it is with immense pride and gratitude that we celebrate the remarkable contributions of our athletes and the renewed spirit of hope and progress in our nation; and we congratulate all athletes for their exemplary representation and success.
2. Mr D W Bryant: That the House welcomes the new leaders of Beaufort West and hopes that this House will work with the new leaders to bring stable governance to the municipality, which for years has been wrought with allegations of corruption, mismanagement and poor service delivery; notes that the DA not only won the three wards in Beaufort West and Murraysburg, but support for the party also increased substantially; and notes that this marks the first time that the Beaufort West Municipality will be governed outright by the DA.
3. Mr B Ngqentsu: That the House notes with great pride and elation the election of Comrade Pat Marran as the Deputy President of the Boland Rugby Union; notes that Comrade Marran, a dedicated ANC PEC Member and former Member of the Western Cape Provincial Parliament, has consistently demonstrated his unwavering passion for sport throughout his tenure in this House; extends heartfelt congratulations to Comrade Pat on this well-deserved achievement; wishes him every success as he undertakes his new responsibilities; and expresses confidence that he will vigorously champion the development of rugby at grassroots level in the Boland and its surrounding areas.
4. Ms N D Nkondlo: That the House notes and welcomes Eskom's significant achievement of maintaining over 100 consecutive days without load-shedding; notes that this milestone represents a critical moment for us to appreciate the progress made in addressing our nation's energy challenges; further notes and acknowledges that the 100 days without load-shedding highlight the effectiveness of the Energy Action Plan introduced by President

Cyril Ramaphosa in July 2022 and the dedicated efforts of Eskom engineers and staff; further notes and appreciates that this milestone is also a testament to the collaborative efforts of the National Energy Crisis Committee and other stakeholders; commends the hard work and resilience of all those who have contributed to this success; and extends our appreciation to Minister Ramakgopa and his team, Eskom's engineers and staff, and all involved in the energy sector for their commitment to improving our energy infrastructure.

5. Ms A P Bans: That the House notes and welcomes the steady progress made by the Passenger Rail Agency of South Africa (Prasa) in getting passenger trains back on track along the central line, with the completion of the refurbishment of several stations; further notes that, after four years without passenger trains, services have resumed, providing affordable transport from Cape Town to multiple stations, including Stock Road, Mandalay and Nolungile; acknowledges that operations at a total of 11 stations on the central line corridor – once the busiest in the Western Cape – were suspended due to rampant vandalism, infrastructure damage and the establishment of informal settlements on rail tracks, issues that escalated during the COVID-19 pandemic lockdown; and commends the Board of Prasa and the national government for their exemplary efforts in restoring these vital services.
6. Ms B Stoffel: That the House notes and welcomes the successful vote of no confidence against the former DA Mayor of Oudtshoorn, Mr Macpherson, which took place on 1 August 2024; notes that this motion of no confidence was brought about due to ongoing concerns and grievances raised by former coalition partners regarding Mr Macpherson's governance and his undermining of collaborative efforts in the coalition; extends its warmest congratulations to Mr Allers, who has been elected as the new Mayor of Oudtshoorn, and to Mr Mziwoxolo Tyatya from the ANC, who has been elected as Deputy Mayor, and Ms Suzanne Jansen from the PA, who has taken on the role of Speaker; acknowledge the significant roles assigned to smaller parties, including Advieskantoor and the Oudtshoorn Gemeenskap Inisiatief, in the new mayoral committee; and calls upon all members of the new leadership team and their respective parties to unite in their efforts and to demonstrate dedication to rendering quality services to the people of Oudtshoorn.
7. Mr D J Wessels: That the House notes that the City of Cape Town's Human Settlement Directorate has delivered some 2 000 title deeds in just two months; notes that these title deeds form part of the City's Human Settlements Title Deeds Campaign, which includes tracking and tracing qualifying title deed residents by visiting areas and going door to door; and further notes that the City aims to deliver another 12 000 title deeds in the coming months.

### KENNISGEWING VAN VOORSTELLE (29 Augustus 2024)

1. Mnr D G Jacobs: Dat die Huis erkenning gee dat bendegeweld op die Kaapse Vlakte sodanig toegeneem het dat dit die dringendste misdaadkwessie in die Wes-Kaap geword het; kennis neem kennis dat die Kaapse Vlakte gedurende die naweek van 28 Junie 2024 tot 1 Julie 2024 'n tragiese tol van 120 sterftes en 90 beserings ondervind het; verder kennis neem dat dit 'n volskaalse bendekonflik blyk te wees, met ongevalle wat dié oorskry wat oor 'n vergelykbare tydperk in die Rusland-Oekraïne-konflik aangemeld is; erkenning gee dat die bestaande polisiëringstrategie ondoeltreffend is en 'n dringende herbeoordeling vereis, gegewe die oënskynlike gebrek aan vordering met ondersoek en die afwesigheid

van inligting oor inhegtenisnemings en suksesvolle vervolgings; verder erkenning gee dat ons gemeenskappe nie teikens vir geweld is nie en dat die strate van die Kaapse Vlakte met die bloed van ons kinders bevlek is; en besluit dat die huidige situasie ondraaglik is en onmiddellike optrede vereis om aandag aan hierdie krisis te skenk en dit op te los.

2. Me B Stoffel: Dat die Huis die dringende kwessies van korruksie en wanfunktionsionering by ons munisipaliteit debatteer.
3. Mn F Kamfer: Dat die Huis die diepgaande impak van dwelm- en middelmisbruik in ons provinsie debatteer.
4. Me R Windvogel: Dat die Huis die huidige stand van onderwys in die Wes-Kaap debatteer.
5. Die Hoofsweep van die Meerderheidsparty (Mnr G Bosman): Dat die Wysigingswetsontwerp op die Grondwet van die Wes-Kaap (Bepaling van Getal Lede) [W 7–2023] oorweeg word vanaf die stadium wat dit tydens die Sesde Parlement bereik het.

1. Mnr N Constable: Dat die Huis die atlete wat ons nasie met soveel onderskeiding by vanjaar se Olimpiese Spele verteenwoordig het, hartlik gelukwens; kennis neem dat die atlete se toewyding en uitnemendheid nie net hul persoonlike prestasies beklemtoon het nie, maar ook ons land se trots op die wêreldwye verhoog geplaas het; kennis neem dat ons ook erkenning gee aan die deurslaggewende rol wat Minister Gayton McKenzie gespeel het in die herlewing van die Departement van Sport, Kuns en Kultuur; kennis neem dat sy leierskap en fokus die prestasie en vooruitskouing van ons hele regering aansienlik verbeter het; kennis neem dat dit met groot trots en dankbaarheid is dat ons die merkwaardige bydraes van ons atlete en die hernieude gees van hoop en vooruitgang in ons nasie vier; en ons alle atlete gelukwens met hul verteenwoordiging en sukses wat 'n voorbeeld vir almal stel.
2. Mnr D W Bryant: Dat die Huis die nuwe leiers van Beaufort-Wes gelukwens en hoop dat hierdie Huis met die nuwe leiers sal saamwerk om stabiele bestuur in die munisipaliteit te vestig, wat vir jare gely het onder korruksie, wanbestuur en swak dienslewering; kennis neem dat die DA nie net die drie wyke in Beaufort-Wes en Murrarysburg gewen het nie, maar dat steun vir die party ook aansienlik toegeneem het; en kennis neem dat dit die eerste keer is dat die Beaufort-Wes-munisipaliteit regstreeks deur die DA regeer sal word.

Mnr B Ngqentsu: Dat die Huis met groot trots en opgewondenheid kennis neem van die verkiezing van kameraad Pat Marran as die Adjunkpresident van die Boland-rugbyunie; kennis neem dat kameraad Marran, 'n toegewyde PUK-lid van die ANC en voormalige Lid van die Wes-Kaap Provinsiale Parlement, deurgaans sy onwrikbare passie vir sport tydens sy ampstermyn in hierdie Huis getoon het; kameraad Pat hartlik gelukwens met hierdie welverdiende prestasie; hom alle sukses toewens met die opneem van sy nuwe verantwoordelikhede; en die vertroue uitspreek dat hy hom kragtig sal beywer vir die ontwikkeling van rugby op voetsoolvlak in die Boland en omliggende gebiede.

aksieplan beklemtoon wat deur President Cyril Ramaphosa in Julie 2022 ingestel is, en van die toegewyde pogings van Eskom-ingenieurs en -personeel; verder kennis neem en waardering uitspreek dat hierdie mylpaal ook 'n bewys is van die samewerkingspogings van die Nasionale Energiekrisiskomitee en ander belanghebbendes; die harde werk en veerkrachtigheid van almal aanprys wat tot hierdie sukses bygedra het; en waardering betuig teenoor Minister Ramakgopa en sy span, Eskom se ingenieurs en personeel, en almal wat by die energiesektor betrokke is, vir hul verbintenis tot die verbetering van ons energie-infrastruktur.

5. Me A P Bans: Dat die Huis kennis neem van en die bestendige vordering verwelkom wat die Passasierspooragentskap van Suid-Afrika (Prasa) gemaak het om passasierstreine weer op die sentrale lyn in te stel met die voltooiing van die opknapping van verskeie stasies; verder kennis neem dat, ná vier jaar sonder passasierstreine, met dienste hervat is wat bekostigbare vervoer vanaf Kaapstad na verskeie stasies moontlik maak, insluitende Stockweg, Mandalay en Nolungile; erkenning gee dat bedrywigheide by altesaam 11 stasies op die sentralelynkorridor – eens die besigste in die Wes-Kaap – opgeskort is weens wye vandalisme, skade aan infrastruktur en die vestiging van informele nedersettings op treinspore, kwessies wat tydens die inperking as gevolg van die COVID-19-pandemie toegeneem het; en die Raad van Prasa en die nasionale regering aanprys vir hul pogings, wat as voorbeeld dien, om hierdie noodsaklike dienste te herstel.
6. Me B Stoffel: Dat die Huis kennis neem van en die suksesvolle mosie van wantroue teen die voormalige DA-burgemeester van Oudtshoorn, mnr Macpherson, wat op 1 Augustus 2024 geslaag het, verwelkom; kennis neem dat hierdie mosie van wantroue ingedien is weens voortdurende kommer oor en grieve wat deur voormalige koalisievennote geopper is oor mnr Macpherson se bestuur en sy ondermyning van samewerkingspogings in die koalisie; mnr Allers, wat tot die nuwe Burgemeester van Oudtshoorn verkies is, en mnr Mziwoxolo Tyatya van die ANC, wat as Onderburgemeester verkies is, en me Suzanne Jansen van die PA, wat die amp van Speaker opgeneem het, hartlik gelukwens; erkenning gee aan die beduidende rolle wat aan kleiner partye, insluitende die Advieskantoor en die Oudtshoorn Gemeenskap Inisiatief, in die nuwe Burgemeesterskomitee toegeken is; en 'n beroep op al die lede van die nuwe leierskapspan en hul onderskeie partye doen om saam te staan in hul pogings om dienste van gehalte aan die mense van Oudtshoorn te lewer en hul verbintenis daartoe te toon.
