Ms C A T Murray: The impact the Growth for Jobs Strategy will have on employment in the Western Cape.

NOTICES OF MOTION (3 August 2023)

1. Mr F C Christians: That the House debates why the DA government has rental units instead of selling these units to the public.
2. Mr P Marran: That the House debates the nonchalant attitude of the DA about the increasing number of shack fires in Cape Town townships.
3. Mr L L Mvimbi: That the House debates the selective road maintenance in Cape Town.
4. Mr P Marran: That the House debates the lack of refuse removal in some townships in Cape Town.
5. Ms A P Bans: That the House debates gun violence in Cape Town.

NOTICES OF MOTION (27 July 2023)

1. Mr M I Sileku: That the House notes the ruling of the IEC that found that GOOD lied about incorrect voter registration in Pacaltsdorp; notes that the GOOD party is so desperate for power, that they are willing to lie blatantly to media houses and spread misinformation; notes that they are the real fraudsters and should be held accountable for their reckless accusations; notes that, due to their actions, the GOOD party's secretary-general, Brett

Herron is now being investigated for intimidation and breach of the Electoral Code of Conduct; notes that, even though the GOOD party went to these extreme lengths, they still lost three wards in one day – karma really is a dish best served cold; and notes that the GOOD party only has themselves to blame: they should accept their defeat, respect democracy and move on.

2. Mr M Kama: That the House urgently calls for the DA-led City of Cape Town to address its neglect of black lives in the wake of another tragic shack fire in SST, Town Two, ward 93, resulting in two more fatalities; notes that this incident occurred in an area previously devastated by a fire that destroyed over 300 shacks, leading to the proposal of the Silver Town Emergency Housing Project; notes that this crucial project remains however unrealised due to the City's refusal to sign a land-availability agreement with the Western Cape Department of Human Settlements; condemns this neglect and demands immediate action to save lives and to prioritise the safety and well-being of all citizens, regardless of race.
3. Ms P Z Lekker: That the House condemns the measures undertaken by the apartheid state of Israel in the reforms of their justice system; notes the concerns of justice-loving Israelis and democrats across the world in how these measures will continue to solidify Israel as an apartheid state; warns the Israeli government that they are continuing the same path that the National Party in South Africa, and specifically Jimmy Kruger; and calls on the international community, including the national government of South Africa, to move for the international isolation of the apartheid state of Israel.
4. Ms A P Bans: That the House notes with deep concern the recent court proceedings involving a security company boss accused of R26,8 million tender fraud in the DA-led Saldanha Bay Municipality; notes that these allegations jeopardise public funds and erode trust in government institutions and service providers; notes that, as a political organisation committed to transparency and community well-being, we stress the importance of upholding the rule of law and respecting legal processes; notes that we trust the judiciary to conduct a fair investigation and to uphold justice; notes that we however cannot overlook the poor oversight by the DA-led Saldanha Bay Municipality and the DA's Minister of Police Oversight and Community Safety, Reagen Allen; notes that the lack of effective monitoring in tender management raises serious concerns; firmly condemns negligence in overseeing public resources that undermines citizens' trust in elected representatives; and commits to monitoring this matter closely and calls on relevant representatives to address similar issues.
5. Mr P Marran: That the House notes with concern Casidra's recent turnaround strategies for the Amalienstein and Waaikraal farms in the Southern Cape, considering their previous failures in managing these farms effectively; acknowledges the importance of successful farm management in promoting agricultural growth and rural development; notes that, in the light of these past shortcomings, we call for increased accountability and scrutiny in Casidra's approach to revitalising these farms; urges Casidra to provide transparent reports on their strategies, progress and utilisation of resources; to ensure sustainable and successful farm management, advocates for comprehensive oversight mechanisms and the inclusion of local stakeholders' input; and notes that this approach will bolster the farms' potential for economic growth and social upliftment to the benefit of the surrounding communities.

6. Mr P Marran: That the House notes with concern the Breede Valley Municipality's failure to construct houses in outer towns, such as De Doorns, Touwsriver, and Rawsonville; notes that it is disheartening that no houses have been built in these towns over the past five years, with no future projects in the pipeline; notes that housing is a fundamental human right, and the lack of progress in addressing this issue hampers the well-being and dignity of our citizens; urgently calls for a comprehensive plan to be put in place to expedite housing development in these neglected areas; demands transparency in the allocation of resources and a commitment to prioritise housing projects in the outer towns; and commits to monitoring the implementation of these plans to ensure accountability and to ensure that the needs of our communities are met.

KENNISGEWING VAN VOORSTELLE (27 Julie 2023)

1. Mnr F C Christians: Dat die Huis debatteer waarom die DA-regering huureenhede het in plaas daarvan om daardie eenhede aan die publiek te verkoop.
2. Mnr P Marran: Dat die Huis die DA se nonchalante houding oor die toenemende getal opslaanhuisbrande in Kaapstadse informele nedersettings debatteer.
3. Mnr L L Mvimbi: Dat die Huis selektiewe padinstandhouding in Kaapstad debatteer.
4. Mnr P Marran: Dat die Huis die gebrek aan vullisverwydering in sommige informele nedersettings in Kaapstad debatteer.
5. Me A P Bans: Dat die Huis vuurwapengeweld in Kaapstad debatteer.

KENNISGEWING VAN VOORSTELLE (22 Junie 2023)

1. Mnr M I Sileku: Dat die Huis kennis neem van die uitspraak van die OVK wat bevind het dat GOOD gelieg het oor verkeerde kiesersregistrasie in Pacaltsdorp; kennis neem dat die party GOOD so desperaat vir mag is, dat hulle bereid is om blatant vir mediahuise te lieg en verkeerde inligting te versprei; kennis neem dat hulle die ware bedrieërs is en

verantwoordelik gehou moet word vir hul roekelose beskuldigings; kennis neem dat die party GOOD se sekretaris-generaal, Brett Herron, weens hul optrede nou vir intimidasie en oortreding van die Verkiesingsgedragskode ondersoek word; kennis neem dat, alhoewel die party GOOD tot hierdie uiterstes gegaan het, hulle steeds drie wyke op een dag verloor het – karma is inderdaad 'n gereg wat die beste koud bedien word; en kennis neem dat die party GOOD net hulself te blameer het: hulle moet hul nederlaag aanvaar, die demokrasie respekteer en aanbeweeg.

2. Mnr M Kama: Dat die Huis 'n dringende beroep op die DA-geleide Stad Kaapstad doen om aandag te skenk aan sy verwaarlosing van swart lewens in die nadraai van nog 'n tragiese opslaanhuisbrand in SST, Town Two, wyk 93, wat tot nog twee sterftes gelei het; kennis neem dat hierdie voorval plaasgevind het in 'n gebied wat voorheen verwoes is deur 'n brand wat meer as 300 opslaanhuise vernietig het, wat tot die voorstel van die Silver Town-noodbehuisingsprojek gelei het; kennis neem dat hierdie deurslaggewende projek egter ongerealiseerd bly weens die Stad se weiering om 'n grondbesikbaarheidsooreenkoms met die Wes-Kaapse Departement van Menslike Nedersettings te onderteken; hierdie verwaarlosing veroordeel en onmiddellike optrede eis om lewens te red en om die veiligheid en welstand van alle burgers, ongeag ras, te prioriseer.
3. Me P Z Lekker: Dat die Huis die maatreëls veroordeel wat die apartheidstaat van Israel getref het in die hervorming van sy regstelsel; kennis neem van die kommer van Israeli's wat geregtigheid liefhet, en demokrate regoor die wêreld oor hoe hierdie maatreëls sal voortgaan om Israel as 'n apartheidstaat te versterk; die Israeliese regering waarsku dat hulle dieselfde pad as die Nasionale Party in Suid-Afrika, en spesifiek Jimmy Kruger, volg; en 'n beroep doen op die internasionale gemeenskap, insluitend die nasionale regering van Suid-Afrika, om hul te beywer vir die internasionale isolasie van die apartheidstaat van Israel.
4. Me AP Bans: Dat die Huis met diepe kommer kennis neem van die onlangse hofverrigtinge waarby die baas van 'n sekuriteitsmaatskappy betrek is, wat van tenderbedrog van R26,8 miljoen in die DA-geleide Saldanhabaai-munisipaliteit beskuldig word; kennis neem dat hierdie bewerings openbare fondse in gevaar stel en vertrouwe in staatsinstellings en diensverskaffers erodeer; kennis neem dat ons, as 'n politieke organisasie wat tot deursigtigheid en gemeenskapswelstand verbind is, die belangrikheid daarvan beklemtoon om die oppergesag van die reg te handhaaf en regsprosesse te respekteer; kennis neem dat ons die regbank vertrou om 'n regverdige ondersoek te doen en geregtigheid te handhaaf; kennis neem ons egter nie die swak toesig van die DA-geleide Saldanhabaai-munisipaliteit en die DA se Minister van Polisie-toesig en Gemeenskapsveiligheid, Reagan Allen, kan miskyk nie; kennis neem dat die gebrek aan doeltreffende monitering in tenderbestuur ernstige kommer wek; nalatigheid in die toesig oor openbare hulpbronne wat burgers se vertrouwe in verkose verteenwoordigers ondermyn, ten sterkste veroordeel; en verbind bly tot die noukeurige monitering van hierdie aangeleentheid en 'n beroep op tersaaklike verteenwoordigers doen om aandag te skenk aan soortgelyke kwessies.
5. Mnr P Marran: Dat die Huis met kommer kennis neem van Casidra se onlangse omkeerstrategieë vir die Amalienstein- en Waaikraal-plaas in die Suid-Kaap, met inagneming van hul vorige mislukkings om hierdie plase doeltreffend te bestuur; erkenning gee aan die belangrikheid van suksesvolle plaasbestuur in die bevordering van landbougroei en landelike ontwikkeling; kennis neem dat ons, in die lig van hierdie vorige tekortkominge, 'n beroep doen op groter aanspreeklikheid en ondersoek van Casidra se

benadering om hierdie plase te laat herleef; Casidra versoek om deursigtige verslae oor hul strategieë, vordering en benutting van hulpbronne te verskaf; omvattende toesigmeganismes en die insluiting van plaaslike belanghebbendes se insette bepleit om volhoubare en suksesvolle plaasbestuur te verseker; en kennis neem dat hierdie benadering die plase se potensiaal vir ekonomiese groei en sosiale opheffing tot voordeel van die omliggende gemeenskappe sal versterk.

6. Mnr P Marran: Dat die Huis met kommer kennis neem van die Breedevallei-munisipaliteit se versuim om huise in buitedorpe, soos De Doorns, Touwsrivier en Rawsonville, te bou; kennis neem dat dit ontmoedigend is dat geen huise in die afgelope vyf jaar in hierdie dorpe gebou is nie, met geen toekomstige projekte in die pyplyn nie; kennis neem dat behuising 'n grondliggende mensereg is, en die gebrek aan vordering om aan hierdie kwessie aandag te skenk, die welstand en waardigheid van ons burgers skaad; 'n dringend beroep doen dat 'n omvattende plan opgestel moet word om behuisingsontwikkeling in hierdie verwaarloosde gebiede te bespoedig; deursigtigheid in die toewysing van hulpbronne eis en 'n verbintenis om behuisingsprojekte in die buitedorpe te prioritiseer; en verbind bly tot die monitering van die implementering van hierdie planne om verantwoordingspligtigheid te verseker en om toe te sien dat daar aan die behoeftes van ons gemeenskappe voldoen word.
