SUBJECT FOR DISCUSSION

Ms N D Nkondlo: The opportunity cost related to the neglect of the informal sector for the realisation of inclusive growth and prosperity for all.

FURTHER BUSINESS

NOTICES OF MOTION (5 September 2024)

1. Mr F C Christians: That the House debates the discontinuance of the Walking Bus Project and the detrimental effect it has had on the communities it served.
2. Mr G P Marais: That the House debates the current state of municipalities in the Western Cape and their capacity, or lack thereof, to provide sustainable and effective services in the Western Cape with a view to implement remedial action and to improve operational standards and efficiencies in the spirit of cooperative governance.
3. Ms A P Bans: That the House, considering the serious allegations and ongoing legal proceedings involving Mr Farrell Payne, a senior manager in the Department of Mobility, who is currently facing charges of sexual misconduct involving a junior female employee; notes with deep concern that the complainant has not received a copy of the internal investigation report despite repeated requests, and is currently at home due to the distressing nature of the situation, while the accused remains in office; acknowledges the need for transparency, accountability and the fair treatment of all parties involved, and the importance of upholding the principles of justice and workplace safety; calls on the Premier to ensure that the complainant receives a copy of the internal investigation report related

to the allegations against Mr Payne to maintain transparency and provides the complainant with access to the findings of the investigation; and further calls for the immediate suspension of Mr Payne pending the resolution of the court case as an essential measure to uphold the integrity of the Department and the provincial government.

NOTICES OF MOTION (29 August 2024)

1. Mr B Ngqentsu: That the House notes that the month of August is a historic month in our national calendar as it is the national Women's Month in recognition of the historic role played by women in our struggle for liberation and social emancipation, including the emancipation of women from patriarchal domination; further notes that women's role in the struggle includes the massive 1956 Women's March led by formidable and courageous women including Albertina Sisulu, Lillian Ngoyi, Helen Joseph, Sophia de Bruyn and Rahima Moosa, to mention a few, with an overwhelming participation by working-class women; acknowledges that, while we celebrate the 68th anniversary of the iconic August 1956 Women's March towards national liberation of the historically oppressed and equal rights regardless of race and gender, we remain deeply concerned that working-class women remain on the periphery of the economy and are alarmed by the levels of violence against women; calls on Members and society at large to ensure that gender-based violence has no space in our society; and denounces the absence of a comprehensive strategy from the DA-led provincial government to tackle gender-based violence and barriers to women empowerment in the Western Cape.
2. Mr B Ngqentsu: That the House notes and expresses its deep concern regarding the escalating violence between rival taxi associations, Codeta and Cata, in Atlantis; further notes that this conflict has emerged following the recent launch of a new route by Codeta, which has led to significant unrest and allegations of unfair practices from Cata; recognises that this tension between rival associations poses a serious threat to public safety and transportation stability in the entire province; urges all parties involved to exercise restraint and to cease all forms of violence and intimidation immediately, and calls on all credible community leaders to work with all the spheres of government and the Minibus Taxi Task Team to prioritise this matter and to take immediate steps to convene the necessary discussions with both parties to resolve the current impasse through dialogue and negotiation, ensuring that all parties have the opportunity to present their concerns and work towards a mutually acceptable solution.
3. Ms R Windvogel: That the House notes and expresses grave concern over the Western Cape Education Department's reckless and ill-considered decision to reduce the number of teaching posts for 2025 by over 2 400 positions, which will have a profoundly detrimental effect on all schools, particularly those in previously disadvantaged communities, worsening the already poor quality of education in these areas; further notes that this drastic measure follows the implementation of WCED Circular 34 of 2023, which has already caused significant harm to under-resourced schools, as these schools have been left with large, unmanageable class sizes and have struggled to cover the shortfall with substitute teachers due to financial constraints; calls on the House to reject this decision vehemently and to urge the Western Cape Education Department strongly to reconsider; and calls for the reallocation of resources from non-essential programmes, such as the School Evaluation Authority and the Back-to-School Programme, instead of cutting teaching posts.

4. Mr N Masipa: That the House notes with admiration the achievements of the winners at the prestigious South African Young Wine Show Awards 2024; notes that this event is one of the oldest wine shows in the world and celebrates its 192nd year of existence this year; notes that South African wine is world-renowned and, being crowned as one of the best young wines in the country, is an enormous honour for a winemaker and wine farm; notes that the South African wine industry is a key part of the Western Cape's economy and contributes massively to both employment and tourism in the province; and sends a letter of thanks to the organisers, the South African National Wine Show Association and Agri Expo, for keeping this historic competition going, thus contributing to the Western Cape's reputation as a premier wine-producing region.
5. Mr D W Bryant: That the House notes the achievement of Western Cape municipalities in the Auditor-General's Consolidated General Report on Local Government Audit Outcomes for the 2022/23 period; notes that this again demonstrates that public funds are best utilised when the needs of residents come first; notes that, of the 34 municipalities across South Africa that received clean audits, the majority (58,8%) were from the Western Cape; notes that, in stark contrast, municipalities outside the Western Cape continue to face challenges in delivering credible financial statements, as highlighted by the Auditor-General when she said, "Municipalities in all provinces except the Western Cape continued to struggle with preparing credible financial statements.>"; notes that the municipalities that are consistently failing their residents in the Western Cape remain those under opposition control; and notes that this pattern highlights the importance of electing leaders who prioritise sound financial management and service delivery.
6. Ms W F Kaizer-Philander: That the House notes that, on 21 August 2024, the Standing Committee on Social Development furnished a letter to the national Minister of Justice and Constitutional Development requesting that attacks on social workers be classified as attacks on the state; notes with great disappointment that this letter has been ignored by the Minister of Justice and Constitutional Development, Ms Thembisa Simelane; and further notes that a follow-up letter was sent to the Minister on 28 August 2024, urging immediate attention to this matter, with a response requested by 6 September 2024.

Me N D Nkondlo: Die geleentheidskoste wat met die afskeep van die informele sektor verband hou, vir die verwerkliking van inklusiewe groei en welvaart vir almal.

KENNISGEWING VAN VOORSTELLE (5 September 2024)

1. Mn F C Christians: Dat die Huis die beëindiging van die Loopbusprojek debatteer en die nadelige gevolge wat dit op die gemeenskappe wat daardeur bedien is, gehad het.
2. Mn G P Marais: Dat die Huis die huidige stand van munisipaliteit in die Wes-Kaap debatteer en hul vermoë, of gebrek daaraan, om volhoubare en doeltreffende dienste in die Wes-Kaap te lewer met die oog op die implementering van remediërende stappe en om bedryfstandaarde en doeltreffendheid in die gees van samewerkende regering te verbeter.
3. Me A P Bans: Dat die Huis, met inagneming van die ernstige bewerings en voortgesette regstappe waarby mnr Farrell Payne, 'n senior bestuurder in die Departement van Mobiliteit, wat tans teregstaan op aanklagte van seksuele wangedrag waarby 'n junior vroulike werknemer betrokke is, betrek word; met diepe kommer kennis neem dat die klaer nog nie 'n afskrif van die interneondersoekverslag ontvang het nie ten spyte van herhaalde versoek, en tans tuis is weens die ontstellende aard van die situasie, terwyl die beskuldigde in sy amp bly; erkenning gee aan die behoefté aan deursigtigheid, verantwoordingspligtigheid en die billike behandeling van alle betrokke partye, en aan die belangrikheid van die

handhawing van die beginsels van regverdigheid en werkplekveiligheid; 'n beroep op die Premier doen om toe te sien dat die klaer 'n afskrif ontvang van die interneondersoekverslag wat met die bewerings teen mnr Payne verband hou, om deursigtigheid te handhaaf en om die klaer toegang te gee tot die bevindings van die ondersoek; en verder 'n beroep doen vir die onmiddellike skorsing van mnr Payne hangende die afhandeling van die hofsaak as 'n noodsaklike maatreël om die integriteit van die Departement en die provinsiale regering te handhaaf.

KENNISGEWING VAN VOORSTELLE (29 Augustus 2024)

1. MnR B Ngqentsu: Dat die Huis kennis neem dat Augustusmaand 'n geskiedkundige maand in ons nasionale kalender is aangesien dit nasionale Vrouemaand is ter erkenning van die geskiedkundige rol wat vroue gespeel het in ons stryd om bevryding en maatskaplike emansipasie, insluitende die bevryding van vroue van patriargale oorheersing; verder kennis neem dat vroue se rol in die stryd die reuse-Vroue-optog van 1956 insluit, geleï deur formidabele en dapper vroue, insluitende Albertina Sisulu, Lillian Ngoyi, Helen Joseph, Sophia de Bruyn en Rahima Moosa, om net 'n paar te noem, met 'n oorweldigende deelname deur werkersklasvroue; erkenning gee dat, terwyl ons die 68ste herdenking van die ikoniese Vroue-optog van Augustus 1956 vir nasionale bevryding van die histories onderdruktes en vir gelyke regte ongeag ras en geslag vier, ons diep bekommert bly dat werkersklasvroue op die periferie van die ekonomie bly en bekommert bly oor die vlakke van geweld teen vroue; 'n beroep op Lede en die breë gemeenskap doen om toe te sien dat geslagsgebaseerde geweld geen plek in ons samelewing het nie; en die awesigheid veroordeel van 'n omvattende strategie van die DA-geleide provinsiale regering om aandag te skenk aan geslagsgebaseerde geweld en aan die hindernisse tot vrouebemagtiging in die Wes-Kaap.
2. MnR B Ngqentsu: Dat die Huis kennis neem van en sy diepe kommer uitspreek oor die toenemende geweld tussen die mededingende taxiverenigings, Codeta en Cata, in Atlantis; verder kennis neem dat hierdie konflik ontstaan het ná die onlangse bekendstelling van 'n nuwe roete deur Codeta, wat tot aansienlike onrus en bewerings van onbillike praktyke van Cata geleï het; erkenning gee dat hierdie spanning tussen mededingende verenigings 'n ernstige bedreiging vir openbare veiligheid en vervoerstabiliteit in die hele provinsie inhou; 'n beroep op alle betrokke partye doen om selfbeheersing te beoefen en om alle vorme van geweld en intimidasie onmiddellik te staak, en 'n beroep op alle geloofwaardige gemeenskapsleiers doen om met al die regeringsfere en die Minibustaxitaakspan saam te werk om hierdie saak te prioritiseer en om onmiddellike stappe te doen om die nodige samesprekings met beide partye te reël om die huidige dooiepunt deur dialoog en onderhandeling op te los ten einde te verseker dat alle partye die geleentheid het om hul bekommernisse te verwoord en saam te werk aan 'n oplossing wat wedersyds aanvaarbaar is.
3. Me R Windvogel: Dat die Huis kennis neem van en ernstige kommer uitspreek oor die Wes-Kaapse Onderwysdepartement se roekeloze en ondeurdagte besluit om die getal onderwysposte in 2025 met meer as 2 400 poste te verminder, wat 'n uiters nadelige uitwerking op alle skole sal hê, veral die skole in voorheen benadeelde gemeenskappe, wat die van onderwys in hierdie gebiede wat reeds van swak gehalte is, sal vererger; verder kennis neem dat hierdie drastiese maatreël volg op die implementering van die WKOD se Omsendbrief 34 van 2023, wat reeds aansienlike skade aan skole met gebrekkige hulpbronne aangerig het, aangesien hierdie skole met groot, onhanteerbare klasgroottes

gelaat is en reeds gesukkel het om die tekort met plaasvervangeronderwysers as gevolg van finansiële beperkings te dek; 'n beroep op die Huis doen om hierdie besluit heftig te verwerp en om die Wes-Kaapse Onderwysdepartement sterk te versoek om dit te heroorweeg; en vra vir die hertoewysing van hulpbronne van nienoodsaaklike programme, soos die Skoolevaluatingsowerheid en die Terug-skool-toe-program, in plaas daarvan om onderwysposte te sny.

4. Mnr N Masipa: Dat die Huis met bewondering kennis neem van die prestasies van die wenners by die gesogte Suid-Afrikaans Jongwynskoutoekennings vir 2024; kennis neem dat hierdie geleentheid een van die oudste wynskoue ter wêreld is en vanjaar sy 192e bestaansjaar vier; kennis neem dat Suid-Afrikaanse wyn wêreldbekend is en, wanneer 'n wyn as een van die beste jong wyne in die land gekroon word, dit 'n yslike eer vir 'n wynmaker en wynplaas is; kennis neem dat die Suid-Afrikaanse wynbedryf 'n sleuteldeel van die Wes-Kaap se ekonomie vorm en grootliks bydra tot beide indiensneming en toerisme in die provinsie; en 'n dankbrief rig aan die organiseerders, die Suid-Afrikaanse Nasionale Wynskouvereniging en Agri Expo, omdat hulle hierdie geskiedkundige kompetisie aan die gang hou en sodoende bydra tot die Wes-Kaap se reputasie as 'n voorste wynproduserende streek.
5. Mnr D W Bryant: Dat die Huis kennis neem van die prestatie van Wes-Kaapse munisipaliteite in die Ouditeur-generaal se Gekonsolideerde Algemene Verslag oor Plaaslike Regerings se Oudituitkomste vir die 2022/23-tydperk; kennis neem dat dit weereens aantoon dat openbare fondse die beste aangewend word wanneer die behoeftes van inwoners eerste gestel word; kennis neem dat, van die 34 munisipaliteite in Suid-Afrika wat skoonoudits ontvang het, die meerderheid (58,8%) in die Wes-Kaap is; kennis neem dat, in skrille kontras, munisipaliteite buite die Wes-Kaap steeds uitdagings in die gesig staar om geloofwaardige finansiële state te verskaf, soos uitgelig deur die Ouditeur-generaal toe sy gesê het: "Munisipaliteite in alle provinsies behalwe die Wes-Kaap het voortgegaan om te sukkel met die voorbereiding van geloofwaardige finansiële state.>"; kennis neem dat die munisipaliteite wat deurgaans hul inwoners in die Wes-Kaap in die steek laat, steeds die munisipaliteite is wat onder die beheer van die opposisie is; en kennis neem dat hierdie patroon die belangrikheid beklemtoon van die verkiesing van leiers wat gesonde finansiële bestuur en dienslewering prioritiseer.
6. Me W F Kaizer-Philander: Dat die Huis kennis neem dat die Staande Komitee oor Maatskaplike Ontwikkeling op 21 Augustus 2024 'n brief aan die nasionale Minister van Justisie en Staatkundige Ontwikkeling gestuur het waarin versoek word dat aanvalle op maatskaplike werkers as aanvalle op die staat geklassifiseer word; met groot teleurstelling kennis neem dat hierdie brief deur die Minister van Justisie en Staatkundige Ontwikkeling, me Thembi Simelane, geïgnoreer is; en verder kennis neem dat 'n opvolgbrief op 28 Augustus 2024 aan die Minister gestuur is waarin onmiddellike aandag aan hierdie aangeleentheid gevra word, met 'n antwoord wat teen 6 September 2024 versoek is.
