NOTICE OF MOTIONS

- 1. Mr R T Olivier moved: That the House debates the impact of drugs, crime and violence on schools in the Western Cape.
- 2. Ms D Gopie moved: That the House debates the impact of crime and violence on the provincial healthcare system and the failures of this DA government to ensure the safety of staff and patients at public healthcare facilities.
- 3. Mr N E Hinana moved: That the House debates the Western Cape municipalities' achievements for again being the top performing province in South Africa with clean local-government audits. The Western Cape received 73% clean audits, Gauteng was in second place with 33% and KwaZulu-Natal was in third place with 30%.

- 4. Mr C M Dugmore moved: That the House debates the shoddy workmanship of construction companies contracted to do work for the Western Cape Government which has resulted in five schools this year being declared unsafe by structural engineers.
- 5. Mr R T Olivier moved: That the House investigates allegations that a principal at a Cape Town high school is facing corruption charges after allowing rubble to be dumped on the school premises and accepted R160 000 in return.
- 6. Mr R B Lentit moved: That the House debates the violence and related causes in Grabouw.
- 7. Mr S G Tyatyam: That the House wishes Hon Mackenzie a speedy recovery after he exited the House quickly assisted by members of his party and wishes him well and a speedy recovery from whatever sickness made him dizzy before he entered the House.
- 8. Mr N E Hinana: That the House congratulates the Western Cape ANC Youth League for successfully and consistently campaigning for the peaceful return of the Hon Marius Fransman to their fold.
- 9. Mr D Joseph moved: That the House debates the equitable share allocation to the Western Cape and the impact thereof on residents.
- 10. Ms M N Gillion moved: That the House notes that it is Child Protection Week from 29 May to 5 June 2016 where the government and civil society pay attention to serious issues faced by children; while many innocent young children die during gang shootings in the province, the provincial government focused on opening youth cafes and promoting vaccinations; in contrast the national government should be commended for highlighting the plight of child labour on farms, the exploitation of children and the movement of unaccompanied minors from neighbouring countries through this year's theme: "Lets us all protect children to move South Africa forward".
- 11. Mr M Mnqasela: That the House congratulates all the DA's designated mayoral candidates for the Western Cape municipal election on 3 August 2016 and wishes them well.
- 12. Ms T M Dijana: That the House with utter dismay reports that civic organisations from across the city are becoming increasingly concerned at the cosy relationship between the DA-led City of Cape Town and private developers resulting in inappropriate developments being bulldozed through while objections are routinely ignored; calls on the House to institute an investigation into these serious allegations; and appeals to the civic society to stand its ground and keep on fighting this ruthless and brutal DA government.

Mr R T Olivier: That the House condemns the provincial Department of Education for allowing infrastructure to decay and the provincial Department of Public Works for not maintaining and upgrading current schools to ensure optimum learning environments that are conducive to learning and that will give learners the best chance in life in the Western Cape.
- 14. Mr P Uys: That the House calls on the DA to save money as part of the Western Cape legislature's austerity measures and follow the ANC example by not sending any interparliamentary delegate during this financial year on any overseas excursions (like the upcoming events of the Commonwealth Parliamentary Association in Bangladesh or Mauritius).
- 15. Ms D Gopie: That the House condemns the heartless destruction of a religious place of worship in Delft by this Western Cape Government.
