- 4.4. To request the Commission on the Restitution of Land Rights in the Western Cape to provide the following:
  - (i) A presentation on what the process is to submit a land claim.
  - (ii) The file on the petition of Mr B Jacobs.
  - (iii) An excel spread sheet on the each land claimant, erf numbers, amount paid out to each recipients, who current owns of the land, a copy of the evaluation of the land and the current value of the land.
  - (vi) A copy of each research report conducted on the land claims, and the terms of the reference utilised, what was resolved following it and the complete file on it.
